Management System for College, Career and Work-Based Learning

The Request for Proposals (RFP) for the above-named project is amended as noted in this Addendum. This Addendum consists of questions and Rockwood School District's responses.

1. Is the District at liberty to discuss if it currently has a web-based college and career exploration platform in place? *We currently use a combination of things to meet the needs included in our RFP (Scoir, Missouri Connections, youScience)*
2. If the current solicitation is looking to replace the current solution, what are the desired outcomes through the implementation of a new solution? *Our desired outcome is to have a system wide program to support students with their education journey and post-secondary planning. More specific outcomes are listed with the needs listed in the RFP.*
3. Can the District please confirm the breakdown of sites and students requiring licenses by grade? *We would like to be able to extend this to elementary. However, understand that the majority of the functions may only relate to 9-12, followed by 6-8 and then Elementary. As for estimate enrollment, K-5=9,000 | 6-8=3,750 | 9-12=7,750.*
4. Will the District require vendors to do final presentations? Will these be conducted in-person or virtually? Could you please provide the dates for the demonstrations? *Yes, we would like in-person presentations but don't have dates at this time.*
5. Can the District please advise how it is implementing the Permission Slips and Approval functionality currently? *We do not currently implement a system wide solution for automating this process.*
6. Can the District please clarify if the Partnership Management requirements are in conjunction with WBL requirements? *Yes and no. While many WBL opportunities will use partners within our partner management, we also want to use the Partner Management functionality to support other aspects of bringing career awareness to students, not necessarily all student embedded with lengthy "work based" experience. Some examples are career shadowing, guest speakers, career fair, etc.*
7. With respect to evidence of financial condition and stability, would it suffice to provide the financial statements of the last 2 years? *Yes, that is acceptable.*
8. What is the enrollment breakdown of the district (Elementary, Middle High School) and how many buildings are in the district? *Estimate enrollment, K-5=9,000 students, 19 schools + 1 gifted center | 6-8=3,750 students and 6 schools | 9-12=7,750 students and 4 HS + 1 Alt School.*
9. Is the district currently using a CCLR system? *We currently use a combination of things to meet the needs included in our RFP (Scoir, Missouri Connections, youScience)*

10. Is this proposal designed for all K-12 students in the district? Our desired outcome is to have a system wide program to support students with their education journey and post-secondary planning. More specific outcomes are listed with the needs listed in the RFP. We would like to be able to extend this to elementary.
