# SECTION 00100 ADVERTISEMENT FOR BIDS

#### PART 1. GENERAL

### 1.1 SEALED BIDS

Sealed bids for construction of **Bulloch County Board of Commissioners—Cypress Lake Road Intersection Improvements** will be received until **August 25**, **2020**, **2:00 PM** at the **Bulloch County Purchasing Office — Bulloch County** at **115 N. Main Street, Statesboro, Georgia 30458** at which time and place they will be publicly opened and read. **Any bid received after said time and date will not be considered by the Owner.** No bid may be withdrawn after the closing time for the receipt of bids for a period of **thirty (30)** days.

Vendors are responsible for the actual delivery of sealed bids during normal business hours to the Bulloch County Purchasing Office. The original bid along with one (1) copy and supporting documents must be submitted in a sealed clearly marked envelope. After the bids are open and publicly read, the bid review team will then proceed to determine conformity with the specifications and other criteria. Upon the closure of the review, the bid review team will recommend selection of a vendor to the Board of Commissioners for final approval at their next subsequent regular meeting.

### 1.2 SCOPE OF WORK

The work shall consist of furnishing all products and equipment and performing all labor necessary to perform the following:

Construction of 12' wide turn lanes on Cypress Lake Road for both approaches to Veterans Memorial Parkway. The project will include installation of a traffic signal according to GDOT specifications to the intersection with ADA accessible crosswalks with associated striping and pavement markings. The project will further consist of erosion and sediment control and grassing.

Time allotted for completion of work is **one hundred eighty (180)** calendar days. All Work shall be completed in accordance with the plans and specifications. The Work will be awarded in one (1) Contract.

## 1.3 PLANS, SPECIFICATIONS AND CONTRACT DOCUMENTS

#### 1.4 BONDS

Bids shall be accompanied by a bid bond in an amount not less than 5% of the base bid. All bonds shall be by a surety company licensed in Georgia with an "A" minimum rating of performance and a financial strength of at least five (5) times the contract price as listed in the most current publication of "Best's Key Rating Guide Property Liability". Performance and Payment Bonds, each in an amount equal to 100% of the contract price shall be required of the successful bidder if contract is awarded. Each Bond shall be accompanied by a "Power of Attorney" authorizing the attorney-in-fact to bind the surety and certified to include the date of the bond and registered as a corporate surety in the most recent edition of Circular 570 of the United States Department of the Treasury.

### 1.5 FUNDING SOURCES

Funding is to be provided by the Georgia Department of Transportation and the Bulloch County Commissioners.

### 1.6 RESERVATION OF RIGHTS

Owner reserves the right to reject any or all Bids and to waive informalities, including without limitation, the rights to reject any or all nonconforming, non-responsive, unbalanced or conditional Bids and to reject the Bid of any Bidder if Owner believes that it would not be in the best interest of the Project to make an award to that Bidder, whether because the Bid is not responsive or the Bidder is unqualified or of doubtful financial ability or fails to meet any other pertinent standard or criteria established by the Owner.

### 1.7 E-VERIFY

Contractor shall comply with E-Verify regulations.

## 1.8 SPECIAL NOTE

Contractor who installs the traffic signal must be a GDOT approved traffic signal contractor.
