Land Management at the Independent Farm Land (the area of Creek Road and Bennie Landing Road) in Lake City, SC.

#### SCOPE OF WORK/SERVICE:

- Brush cut all open areas of about 10 acers. Open areas can be maintained by tractor and bush cutter fairly easy and quickly. NOTE: Estimate is one occurrence cutting.
- Brush cut in-between 80 acres of pine tree rows.
- Pine row cutting shall be maintained by tracked skid steers with cutters.
- Tracked sked steers are to be used. The narrow passage and terrain creates issues to use any other equipment. NOTES: Estimate is a one occurrence cutting.


