The Board of County Commissioners of Curry County, State of New Mexico, has issued the following Addendum #1 to the Professional Architectural Services for Curry County Multipurpose Livestock Pavilion RFP No. 2022/23-04. Questions were invited and received and a compilation of questions were made and the following answers are provided.

#### Questions and Answers:

1. **Question**—"Will this project include demolition of the existing livestock barns?" **Yes, the project will include demolition.**
2. **Question**—"What site work will be associated with this project? Asphalt parking lot, site lighting, any other items?" **Site work may consist of but not limited to site lighting, sidewalks, landscape and any site improvements necessary for proper drainage.**
3. **Question**—"Has a survey of the site and geotechnical investigation been completed?" **No**
4. **Question**—"Will the building require heating and cooling?" **Yes**
5. **Question**—"Is landscape design part of this project? Does the City of Clovis have any landscape requirements that will need to be met?" **Minimal landscaping is possible. The City of Clovis does not have landscape requirements that will affect this project.**
6. **Question**—"We do not currently meet the requested insurance requirement for professional liability. Is it acceptable to modify our policy at a later date if selected for this project?" **Proof of the required insurance shall be provided upon execution of the contract for services.**
