Certified check or Bid Bond for 5% of bid (maximum-\$10,000) made payable to the City of Prattville must accompany each bid as evidence of good faith. The right to reject any or all bids is reserved.

The Project will include:

Concrete slab demolition and removal 4,600 SY; Roadway construction (2,300 LF) of Maple Street, Bridge Street and Maple Street Extension, 2,050 LF of storm drain pipe; 260 LF of 8" sanitary sewer main; 2,120 SY of concrete sidewalk improvements, 2,500 LF of HDPE 16" force main, etc

NOTE: All item bids are complete in place.

No bidder may withdraw his bid within 45 days after the actual date of the opening thereof.

The successful bidder will be allowed 180 days to complete this project.
