## **SCOPE OF WORK**

To provide janitorial supplies as ordered during the contract period.

## **SPECIFIC REQUIREMENTS**

1. Contractor must be able to provide Janitorial Supplies, which meets or exceeds the specifications contained in this document.
2. Contractor must be able to provide cleaning fluids, equipment, filters, soap, paper products, and/or any item needed by Franklin County as specified in pricing form.
3. Contractor agrees to provide samples at bidder's expense to Franklin County upon request, if necessary, to test products before purchase.

### **MATERIAL AVAILABILITY:**

Bidders must accept responsibility for verification of material availability, product schedules and other pertinent data prior to submission of bid and delivery time. It is the responsibility of the bidder to notify the County immediately if the materials specified are discontinued, replaced, or not available for an extended period of time. All materials ordered by the County, shall be as needed A sample of materials may be requested.

4. Method of delivery shall be determined at the time of order and will not exceed Franklin County boundaries.
5. Contractor must be able to provide supplies to any requesting department in Franklin County. Normal business hours are Monday through Friday 8:00 a.m. – 4:30 a.m. (CST). However, these times must be verified with each requesting department. County observed holidays will be provided upon request.
6. Prices are ALL INCLUSIVE: (Shipping, Handling, Delivery, and Assembly to locations specified by the County).
7. Vendors are to insure that bid price is for the amounts or quantities specified.
8. All information requested, must be provided. Failure to provide requested information could result in a bid determined as non-responsive.
