CITY OF KINGMAN <u>NOTICE OF REQUEST FOR PROPOSAL</u> <u>TRANSIT CENTER SITE SELECTION</u> <u>AND ENVIRONMENTAL ANALYSIS</u> <u>PW23-002</u>

Project Description: Kingman Area Regional Transit (KART), operated by the City of Kingman is requesting proposals from qualified CONSULTANTs for a Transit Center Site Selection and Environmental Analysis. The Short and Long Range Transit Study performed in 2021 identified the need for a dedicated transit center that can better provide safe and efficient service for transit customers. This site will need a comfort station with restroom facilities, a customer service area, administrative offices, be in close proximity to a current KART route and provide enough space to allow for system growth.

Qualified CONSULTANTs who pick up a copy of the Request for Proposal packet or are sent a copy through the City of Kingman's Public Works Department will be included on the Request for Proposal Holders List. Proposals will be opened at that time. Any proposal received after 3:00 P.M. on the above stated date will be returned unopened. Faxed and e-mailed bids will not be accepted.
