US-61 West Outer Road Extension – Phase 1

The US-61 West Outer Road Extension – Phase 1 Project shall consist of constructing a new west outer roadway for US Route 61 from Peine Loop Road to Champions Lane, a distance of 0.34 miles.

A non-mandatory Pre-Bid Meeting will be held at Wentzville City Hall, 310 W. Pearce Blvd., Wentzville, MO 63385 at 10 a.m. on January 11, 2016.

Sealed bids will be accepted by the City of Wentzville Procurement Department, City Hall, 310 W. Pearce Blvd, Wentzville, MO 63385 until 2 p.m. (local time) on January 24, 2017. Bids will be opened and read aloud.

Bid documents will be distributed electronically via an FTP link at no cost. Bidders may make printed copies of the bid packet which include specifications, drawings, and bid documents at their own expense. The successful bidder shall be required to comply in all respects with the State Statutory provisions concerning the payment of prevailing wages on Public Works, Section 290.262 RSMo and shall pay to all workmen performing the work under the Contract not less than the prevailing hourly rate of wages as determined by the Department of Labor and Industrial Relations of the State of Missouri.

The City of Wentzville hereby notifies all bidders that it will affirmatively ensure that in any contract entered into pursuant to this solicitation, disadvantaged business enterprises will be afforded full opportunity to submit bids in response to this invitation and will not be discriminated against on the grounds of race, color, or national origin in consideration for an award.
