Therefore, please consider the inconsistent delivery of mail when submitting your bid. **Submit your bid package marked clearly on the outside of the envelope or box – INSTRUCTIONAL SUPPLIES – BID #21-01. Samples should be mailed or delivered in a separate envelope or box clearly marked INSTRUCTIONAL BID SAMPLES with Bid #21-01 with the vendor submitting the samples clearly marked.**
