The Project includes the installation of approximately 9,075 linear feet of 6" force main; the rehabilitation/upgrade of 1 sewer lift station and the decommissioning/abandonment of an existing 6" force main. The proposed force main route will run north along US 220 BUS for approximately 7,590 feet, then turn west and run for approximately 1,470 feet through Klaussner Industries Plant #3 site to an existing pump station owned and operated by the City of Asheboro. The project area runs along BUS-220 from Uwharrie Charter Schools to Klaussner Industries.
