2. Specific control of the following pests and others not mentioned herein:
 - a. Ants
 - b. Fleas
 - c. Mice
 - d. Rats
 - e. Roaches
 - f. Silverfish
3. Contractor shall render service once a month, on or about the same calendar day.
4. Contractor may be recalled for pest treatment at any time deemed necessary by proper authority at no additional cost to City of Waycross.
5. Contractor shall obtain signed service report from responsible person in each City Building, stating service was rendered.
6. Contractor shall submit a copy of Department of Agriculture Licenses with bid.
7. The City shall have the right to add or delete any buildings as necessary with a comparable rate as other buildings.
8. Contractor Must show proof of liability insurance on vehicles and worker's compensation on employees and complete E-Verify forms.
9. Contract period shall be from July 1, 2022 and end on June 30, 2023. There will be an option of four (4) annual renewals of all parties are in agreement and there are no price increases.
10. The City of Waycross may, at any time they deem necessary, terminate this agreement with thirty (30) days written notice.
11. Include a list of 5 other government/business references with contact name and numbers.
12. There will be a non-mandatory pre-bid meeting so that all contractors can review each building. Monday and Tuesday, 8:00 a.m.-12:00 p.m., May 3-4, 2022. All contractors will meet at the 2nd floor conference room of City Hall, 417 Pendleton Street, Waycross, GA 31501. Contractor may choose either day to attend. Any questions that are asked will be answered in an addendum and issued to all contractors.
