## 2018 Police Utility Vehicle Bid Specifications

The Robertson County Sheriff's Office is requesting bids for four (4) 2018 Police Utility Vehicles (Three marked units and one unmarked unit). These vehicles should meet or exceed the following requirements:

Wheelbase not less than 112.6 inches, All-Wheel Drive, with Engine not less than a 3.7L Ti-VCT V-6 FFV with 304 hp and 279 ft/lbs of torque.

All vehicles must have two programmed key fobs to allow remote locking and unlocking of all doors and rear hatch.

Three vehicles will be marked police units and must have white paint.

One vehicle will be an unmarked patrol SUV and must include Police Interior Upgrade Package (standard seating, carpeting, and center console for unmarked police interior) and will be "Medium Titanium" in color.

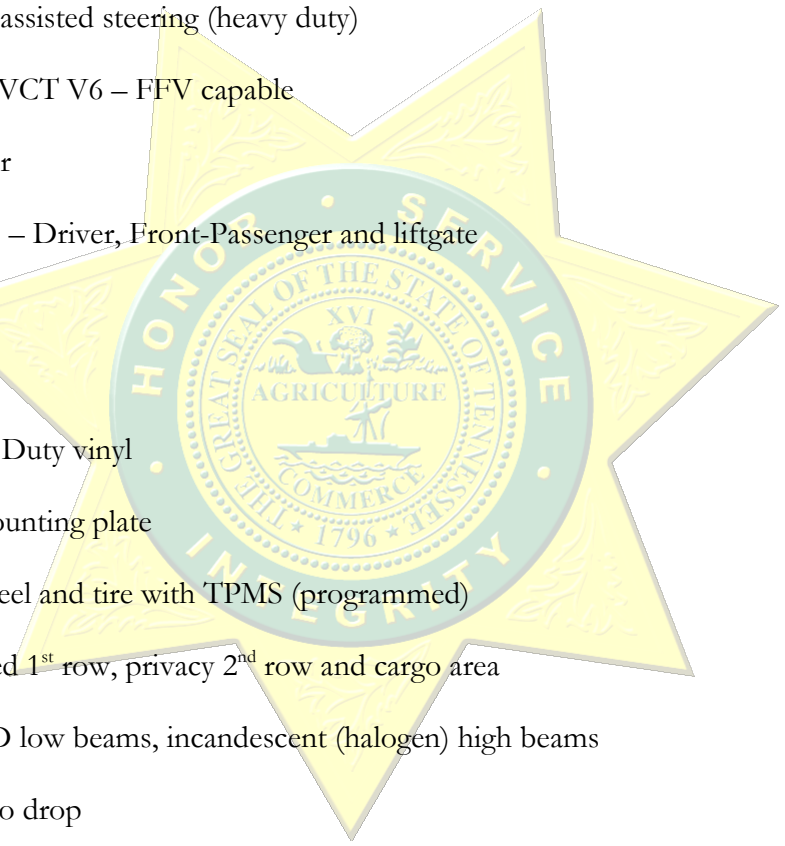

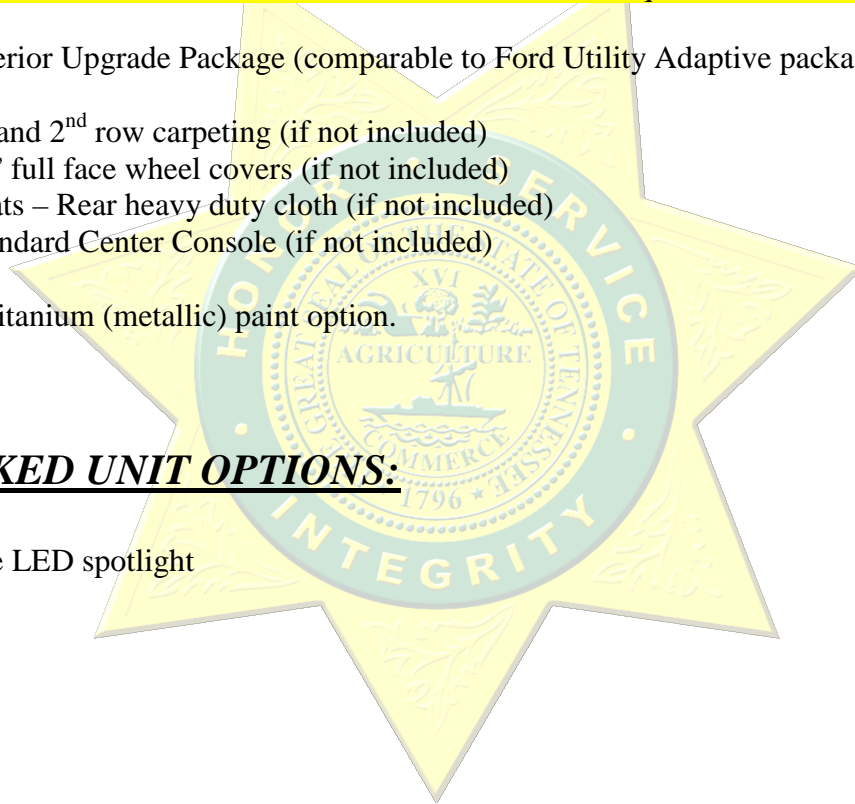
