The Franklin County Fiscal Court is requesting sealed bids for Scott X3 Pro Self Contained Breathing Apparatus (SCBA) and Scott RIT-Pak III Emergency Air Supply Systems. Bids are restricted to Scott X3 Pro SCBA and Scott RIT-Pak III Emergency Air Supply Systems equipment to ensure compatibility with current SCBAs (Scott X3 Pro), face pieces (Scott AV3000HT) and cylinders (Scott 45 minute/4500psi) currently in service for the Franklin County Fire Department. Bids shall include any and all costs for items including but not limited to permits, materials, special equipment and shall be itemized on the List of Unit Prices provided in the bid form. Sealed bids will be received by the Franklin County Fiscal Court, ATTN: Michael Mueller, Judge/Executive, 321 W. Main Street, Frankfort, Kentucky, until **10:00 a.m. EST, on July 16, 2024**. Bids will thereafter be publicly opened and read aloud. All submittals shall be clearly marked "**FIRE DEPT SCBA SEALED BID**".

Such qualified vendors submitting bids which are 5% or less higher than other competing bids may be considered low bids.

Award of a single contract will be made to the best, lowest, responsive, responsible bidder. Franklin County reserves the right to reject any bid for any reason. Bids not conforming to the specifications contained herein will not be considered.
