11. For the large diameter CIPP (Larger than 24”) do you have a list of pipe segments, or estimated quantities for how much could potentially be issued via work orders? The concern is that larger diameter is extremely difficult to price for a quantity of (1), and would result in an extremely high unit price to cover all contingencies. There is special concern for the extremely large diameter (60” or Greater), as transportation of the liner becomes an issue for longer lengths. A list of the large diameter segments in your system, with their approximate lengths would be immensely helpful in ensuring that an accurate estimate is quoted for these line items.
