Offerors understand and agree that technical support may not be readily available the day of and or the hours/minutes prior to due date and time. Offerors also understand and agree that internet access, browsers, and operating systems are not supported by the District and/or its agents. Offerors are strongly encouraged to review, create, and submit all electronic RFP responses several days in advance of the due date and time.

#### RFP Term

Albuquerque Public Schools reserves the right to enter into an 18-24 month contract with the awarded Offeror. Contract length is dependent on contract negotiations between consultant and insurance providers but will not exceed 24 months.

The Interagency Benefits Advisory Committee (IBAC) is a joint purchasing collective established by state statute which consists of the State of New Mexico Risk Management Division, New Mexico Public Schools Insurance Authority, New Mexico Retiree Health Care Authority, Albuquerque Public Schools and the membership of each of these agencies.

The Health Care Purchasing Act of 1997, which became effective on July 1, 1997, is an act related to publicly funded health care programs to provide for consolidated negotiation and purchasing of insurance. This act requires the four agencies listed above to complete a single process for the procurement of employee benefits by these publicly funded agencies. However, the four agencies are not required to select the same provider/carrier. This act also requires that all requests for proposals issued as part of the consolidated purchasing shall include at least one distinct service area consisting of the Albuquerque metropolitan area. Proposals on a distinct service area shall be evaluated separately.

Legislation proposed during the 2023 State of New Mexico Legislative Session may amend or change provisions of the Health Care Purchasing Act, or how the IBAC operates.

# OFFEROR'S GENERAL INSTRUCTIONS

- 1. **READ ALL DOCUMENTS:** Offerors must familiarize themselves with all documents contained herein; it is mandatory that all submitted offers be in compliance with all the provisions contained in the Request for Proposal. Offerors should promptly notify the Buyer of any ambiguity, inconsistency, error, or missing attachments which they may discover upon examination of the RFP.
- 2. <u>CONE OF SILENCE:</u> APS has adopted a "Cone of Silence" to enforce its commitment to ethical procurement standards and improve accountability and public confidence. The Cone of Silence prohibits any communication regarding a competitive procurement solicitation between any person who seeks an award from the District, including potential vendors or vendor's representative and APS Board Members, the Superintendent, senior staff members, principals, department heads, directors, managers or other District representative and all IBAC members, IBAC agency employees and IBAC agency Board members who have influence in the evaluation or selection process.
- 3. <u>OFFICIAL CONTACT:</u> Offerors may contact **ONLY** the Buyer regarding the terminology stated in the procurement documents. Other APS or IBAC agency employees do not have the authority to respond on behalf of APS.

Offerors MAY NOT contact other APS departments, employees or the evaluation committee, including IBAC agency employees. Any contact with an APS or IBAC agency department, employee or evaluation committee member may result in rejection of any proposal.

Any other verbal communication will be deemed unofficial and non-binding. Communication directed to parties other than the Buyer will have no legal bearing on this RFP or the resulting contract(s). Any response made by APS will be provided in writing to all Offerors by addendum; no verbal responses shall be authoritative.

- 4. WRITTEN QUESTIONS: Potential Offerors may submit written questions to the Buyer as to the intent or clarity of this RFP. All written questions must be addressed and submitted to the Buyer NO LATER than the date and time specified in this RFP. All times are subject to the local time zone. The Buyer will respond in a timely manner subject to the complexity of the questions. Buyer will ONLY respond to the written questions submitted and receive on or prior to the deadline in this RFP.
- 5. <u>SUBMISSION:</u> The submission of a proposal constitutes a representation by the Offeror that the Offeror has made all appropriate examinations, investigations, and analysis and has made provision as to the cost thereof in submitted proposal. By responding to this RFP, Offerors acknowledge and agree to the terms and conditions set form in this RFP.
- 6. <u>ELECTRONIC RFP DOCUMENTS:</u> This RFP is being made available by electronic means. In the event of conflict between a version of the RFP in the Offeror's possession and the version maintained by APS, the Offeror acknowledges that the version maintained by APS on the APS procurement website shall govern.
- 7. **INCURRING COSTS:** Any cost incurred by the potential Offeror in preparation, transmittal, and/or presentation of any proposal or material submitted in response to this RFP shall be borne solely by the Offeror. If applicable, any cost incurred by the Offeror for set up and demonstration of the proposed equipment and/or system shall be borne solely by the Offeror.

- 8. **PUBLIC RECORDS ACT:** Albuquerque Public Schools is a governmental entity subject to the State of New Mexico Inspection of Public Records Act (IPRA). Proposals submitted to APS as a result of a formal procurement solicitation are subject to release as a public information request. If an Offeror believes that its response or parts of its response may be exempted from disclosure under New Mexico law, the Offeror may mark the pages "confidential" for consideration to exemption. APS reserves the sole right to determine exemptions.
- 9. **PROPOSAL OFFER FIRM:** Responses to this RFP, including proposal prices for services, will be considered firm for one hundred twenty (120) days after due date. If a best and final offer is requested, the offer is good for ninety (90) days after receipt of best and final offer.
- 10. <u>FORMS AND ATTACHMENTS:</u> It is the responsibility of every Offeror to ensure they have downloaded the latest version of each RFP, including any addendum(s) which may have been issued and posted on the APS Procurement Department Website.
- 11. <u>ADDENDUM(S):</u> No Addendum will be issued later than FIVE (5) days prior to the date for receipt of proposals, except an Addendum withdrawing the RFP or one which extends the date for receipt of proposals.
  - Offerors should revisit the website (<a href="http://www.aps.edu/procurement">http://www.aps.edu/procurement</a>), then select, "See Current Bids and RFPs") prior to the due date before submitting their proposal to Albuquerque Public Schools. All addendums must be acknowledged in the submitted proposal.
- 12. **CORRECTIONS:** Corrections shall be initialed in ink by the Offeror signing the proposal. Offerors will be allowed to withdraw their proposals at any time prior to the deadline for receipt of proposals. The Offeror must submit a written withdrawal request to withdraw their proposal. The approval or denial of withdrawal requests received after the deadline for receipt of the proposals is governed by the applicable procurement regulations.
- 13. **EXCEPTIONS:** Any exceptions to the Scope of Services and/or specifications shall be listed separately in the submitted proposal and unless otherwise stated, specifications and/or Scope of Services attached are the minimum requirements. Minor deviations to the specifications as listed, may be considered.
  - The Buyer, after review of the proposals may request clarifications on information submitted by any and all Offerors in a written format, with a specified deadline for response.
- 14. <u>DISTRICT DISCRETION</u>: The District hereafter referred to as APS reserves the right, pursuant NMSA 1978, §13-1-132, in its sole discretion to waive minor informalities in proposals submitted provided that such informalities have no effect on price, quality, quantity or any matter to be evaluated in making a selection and confer no material advantage on the Offeror whose nonconformity is waived. APS reserves the right to add to or delete from the Scope of Services set forth in this RFP.
- 15. **BRAND NAMES:** Pursuant to NMSA 1978, §13-1-168, where a brand-name or equal specification is used in a solicitation, the use of a brand name is for the purpose of describing the standard of quality, performance and characteristics desired and is not intended to limit or restrict competition pursuant to NMSA 1978 §13-1-168. If a vendor proposes an "equal" to Scope of Services/specifications, APS is the sole interpreter of the Scope of Services/specifications and sole judge as to whether the "equal" proposed complies with the Scope of Services/specifications
- 16. OFFEROR QUALIFICATIONS: The Evaluation Committee may make such investigations as necessary to determine the ability of the potential Offeror to adhere to the requirement specified within this RFP. The Evaluation Committee may reject the proposal of any potential Offeror who is deemed not

to be a responsible Offeror or fails to submit a responsive offer as defined in NMSA 1978, §13-1-83 and §13-1-85.

- 17. <u>AWARD:</u> APS reserves the right to award all, part or none of the Scope of Services set forth in this RFP. This procurement in no manner obligates Albuquerque Public Schools until a valid signed contract and/or valid Purchase Order is executed.
- 18. PREFERENCES: RFPs may be awarded preference in compliance with NMSA 1978, §13-1-21 for New Mexico In-State Resident Business or Native America Resident Business or Resident Veteran Business or Native American Resident Veteran Business. Offerors shall include in their proposal a copy of the certificate issued by State of New Mexico Taxation & Revenue. If Proposal is Joint Venture, Offeror shall state in submitted offer the percentage of work that will be performed by Resident Business and/or Resident Veteran Business.

PLEASE NOTE: An Offeror cannot be awarded multiple preferences such as resident preference and a resident veteran business preference. The New Mexico Preferences shall not apply when the expenditures for this RFP includes federal funds.

19. <u>TIMELY SUBMISSIONS:</u> All Offeror proposals must be received for review and evaluation no later than the time and date specified in this RFP.

Important Information: Albuquerque Public Schools Online Bidding System (Vendor Registry) utilizes the Internet and the World Wide Web which is comprised of systems that are completely out of APS's control including but not limited to: the District, its agents, and registered suppliers' respective internet service providers. The District and its agents are not responsible for Internet outages, hardware failures, software failures, downtime, internet slowness, acts of God, power failures, and or user errors. All proposals must be submitted before the due date regardless of your organization's ability to submit proposals online. It is the suppliers' responsibility to ensure that RFP offers arrive before the due date and time.

- 20. **EXTEND SUBMISSION TIME:** APS may in its sole discretion extend the time for the submission of bids upon a finding that it is in the interest of APS to do so. Such extensions shall be by addendum(s), which may be issued before or on the submission due date.
- 21. **RFP CANCELLATION OR REJECTION:** In accordance with NMSA 1978, §13-1-131, this RFP may be canceled or proposals may be rejected in whole or in part when it is in the best interest of Albuquerque Public Schools.
- 22. **RFP OPENING:** Submitted proposals shall not be publicly opened. The contents of the proposals shall not be disclosed during any negotiations that may occur. A public log will be kept of the names of all Offeror organizations that submitted proposals. Pursuant to NMSA 1978, §13-1-116, the contents of proposals shall not be disclosed to competing potential Offerors during the negotiation process. The negotiation process is deemed to be in effect until the contract is awarded pursuant to this Request for Proposals. Awarded in this context means the final required APS signature on the contract(s) resulting

- from the procurement has been obtained.
- 23. **RESPONSIBLE AND RESPONSIVE OFFER:** APS may reject the proposal of any potential Offeror who is not a responsible Offeror or fails to submit a responsive offer as defined in NMSA 1978, §13-1-83 and §13-1-85.
- 24. **SOLE RESPONSE:** Any sole response that is received may be rejected by APS depending on available competition and timely needs of APS. APS reserves the right to award the contract to the responsible Offeror submitted responsive proposals most advantageous and in the best interest of APS.
- 25. **NEGOTIATIONS:** APS reserves the right to discontinue negotiations with any Offeror.
- 26. <u>MULTI-AWARD:</u> APS reserves the right to multi-award contracts as necessary for adequate delivery or service in accordance with NMSA 1978, §13-1-153.
- 27. <u>AFTER AWARD:</u> After final contract is negotiated, approved and awarded, all proposal documents pertaining to this procurement will be open to the public, except for the material, which is proprietary or confidential.
  - The Procurement Department might not disclose or make public any pages of a proposal on which the Offeror has stamped or imprinted "**Proprietary**" or "**Confidential**" subject to the following requirements.
  - Proprietary or confidential data shall be readily separable from the proposal in order to facilitate eventual public inspection of the non-confidential portion of the proposal. Confidential data is normally restricted to confidential financial information concerning the Offeror's organization and data that qualifies as trade secret in accordance with the Uniform Trade Act, NMSA 1978, §57-3A-7. The price of products offered or the cost of services proposed shall not be designated as proprietary or confidential information.
- 28. **APS SCHOOL BOARD APPROVAL:** The award of this contract is not final until approved by the APS School Board (if applicable) and/or contract is signed by both parties.
- 29. **<u>DEFINITIONS:</u>** Definition of Terminology: This section contains definitions that are used throughout this procurement document, including appropriate abbreviations.
  - "Agency" shall mean Albuquerque Public Schools (APS) IBAC agencies shall mean the State of New Mexico Risk Management Division, the New Mexico Public Schools Insurance Authority, the New Mexico Retiree Health Care Authority, and Albuquerque Public Schools.
  - "Award of Contract" shall mean a formal written notice by APS that a firm(s) has/have been selected to enter into a contract for services.
  - "Contract" shall mean an agreement for the procurement of items of tangible personal property or services.
  - "Contractor" shall mean the successful Offeror.
  - "Determination" shall mean the written documentation of a decision of a procurement manager including findings of fact required to support a decision. A determination becomes part of the procurement file to which it pertains.
  - "Desirable" the terms "may", "can", "should", or "prefers" identify a desirable or discretionary item or factor.
  - "Evaluation Committee" shall mean a body constituted to evaluate proposals and make selection recommendation.

- "Finalist" is defined as an Offeror who meets all the mandatory specifications of the RFP and whose score on evaluation factors is sufficiently high to qualify that Offeror for further consideration by the Evaluation Committee.
- "Mandatory" the terms "must", "shall", "will", "is required", or "are required", identify a mandatory item or factor. Failure to meet a mandatory item or factor will result in the rejection of the Bidder's bid.
- "Offer" the term means "proposal", "solution", means all documents submitted to APS responding to RFP.
- "Offeror", "Bidder", or "Proposer" is any person, corporation, or partnership who chooses to submit a proposal in response to this RFP.
- "Owner" shall be Albuquerque Public Schools.
- "Purchase Order" shall mean the document, which directs a Contractor to deliver items of tangible personal property or services pursuant to an existing contract.
- "Request for Proposal" or "RFP" means all documents, including those attached or incorporated by reference, used for soliciting proposals.
- "Responsible Offeror" shall mean an Offeror who submits a responsive bid and who has furnished, when required, information and data to prove that its financial resources, production or service facilities, personnel, service reputation and experience are adequate to make satisfactory delivery of the services or items of tangible property described in the RFP.
- "Responsive Offer" or "Responsive Proposal" shall mean a bid, which conforms in all material respects to the requirements set forth in the RFP.

## TERMS AND CONDITIONS

- APPLICABILITY: These terms and conditions are applicable and form a part of the resulting contract documents, and each purchase order issued for goods and/or services included in the Scope of Services and proposal forms issued herewith.
- 2. <u>TERM:</u> APS reserves the right to procure the services/goods as described in this RFP and enter into a contract as described on RFP front cover.
- REQUEST(S) NOT DEFINED IN SCOPE OF SERVICES: Contractor shall be held responsible to NOT fill requests which are clearly beyond the defined scope of this contract. Should such requests occur, Contractor has the responsibility of calling such violations to the attention of the APS Procurement Officer.
- 4. <u>ASSIGNMENT:</u> It is mutually understood and agreed that the successful Offeror(s) shall not assign, transfer, convey, sublet or otherwise dispose of the purchase order, contract, or his/her right, title of interest therein, or power to execute such purchase order or contract to any other person, company or corporation without the previous written consent of APS.
- NO MINIMUM GUARANTEE: Albuquerque Public Schools does not guarantee a minimum amount of purchases in conjunction with award of this request for proposals.
- 6. <u>PURCHASE ORDER REQUIRED:</u> A purchase order commitment represents an obligation to pay a vendor for future delivery of goods and/or services. No payments will be made for work performed or goods delivered before a Purchase Order is issued by APS Purchasing Department. Vendors who commence work before they have received a valid purchase order do so at their own risk and payment is not guaranteed. Purchase Orders are issued by APS and submitted electronically to the vendor by email.
- 7. PRICING ESCALATION (if applicable): Price escalation may be considered only at yearly observance of award (anniversary date) and only upon receipt of written request from Contractor stating reason(s) for escalation and the amount being requested. Justifying documentation MUST accompany price escalation request.
- 8. <u>TAXES</u>: APS holds a Class 9 Nontaxable Transaction Certificate and is exempt from payment of taxes on tangible personal property. A NTTC will be issued upon request.
- 9. NON-APPROPRIATION: APS' obligation to make payment under the terms of this RFP is contingent upon its appropriation of sufficient funds to make those payments. If APS does not appropriate funds for the continuation of this procurement, this procurement will terminate upon written notice of that effect to the Contractor. APS determination that sufficient funds have not been appropriated is firm, binding and not subject to review.
- 10. **PROCUREMENT CODE:** The Procurement Code, NMSA 1978, §13-1-28 through §13-1-199, imposes civil and misdemeanor criminal penalties for its violation. In addition, the New Mexico Criminal Statutes impose felony penalties for bribes, gratuities, and kickbacks.
- 11. PROCUREMENT UNDER EXISTING CONTRACTS: In accordance with NMSA 1978, §13-1-129, Offerors are hereby notified that other governmental entities within the State of New Mexico, or as otherwise allowed by their respective governing directives, may contract for services with the awarded Offeror. Contractual engagements accomplished under this provision shall be solely between the awarded Offeror and the contracting entity with no obligation by Albuquerque Public Schools
- 12. **TERMINATION:** Either party may terminate this contract as follows:
  - A. Termination by the Contractor

- 1. The Contractor may terminate this contract **only** if Albuquerque Public School District fails to comply with any provisions of this contract and after receiving notice of the noncompliance APS fails to cure the noncompliance within ten (10) days, or
- 2. By written mutual agreement between the Contractor and APS.

#### B. Termination by APS

#### 1. For Cause

- a. The occurrence of either one of the following events will justify termination for cause:
  - Contractor's persistent failure to perform the work in accordance with the contract documents (including but not limited to, failure to supply sufficient skilled workers or suitable materials or equipment).
  - ii. Contractor's violation in any substantial way of any provisions of this contract.
- b. If either one of the events identified above occur, APS may, after giving Contractor (and the surety, if any) ten (10) days written notice, terminate the service of Contractor, exclude Contractor from site, and take possession of the work. Contractor shall be paid for project costs incurred up to the date of termination but shall not be paid for loss of profits resulting from such termination.
- c. Where Contractor's services have been so terminated by APS, the termination will not affect any rights or remedies of APS against Contractor then existing or which may thereafter accrue. Any retention or payment of moneys due the Contractor by APS will not release the Contractor from liability.

#### 2. For Convenience

- a. Upon ten (10) days written notice to Contractor, APS may without cause and without prejudice to any other right or remedy of APS, elect to terminate the contract.
- b. In such case, Contractor shall be paid (without duplication of any items):
  - i. For completed and acceptable work executed in accordance with the contract documents prior to the effective date of termination.
  - ii. For expenses sustained prior to the effective date of termination in performing services and furnishing labor, materials or equipment as required by the contract document in connection with uncompleted work.
- c. Contractor shall not be paid on account of loss of anticipated profits or revenue or other economic loss arising out of or resulting from such termination.
- 13. INDEMNIFICATION: The Offeror shall be responsible for damage to persons or property that occurs as a result of Offeror's fault or negligence, or that of any of his/her employees, agents or subcontractors. Offeror shall save and hold harmless Albuquerque Public Schools against any and all losses, cost, damage, claims, expenses or liability in connection with the performance of the contract. Any equipment or facilities damaged by the Offeror's operation shall be repaired and/or restored to their original condition at the Offeror's expense.
- 14. <u>INSURANCE:</u> The successful Offeror shall purchase and maintain statutory limits of Worker's Compensation, Public Liability and Automobile Liability Insurance approved by APS at the time of contract award. Albuquerque Public Schools shall be included as a loss payee and/or additional insured. Public Liability and Automobile Liability insurance shall include at least the following coverage:

- 15. <u>AUDIT:</u> APS reserves the right to audit the Contractor's records associated with this contract at any time during the contract period and for a period of up to three years following the expiration or termination of the agreement. Such audit may be conducted by APS personnel or a third party under contract with APS. APS shall give the Contractor reasonable notice prior to the conduct of any audit and upon receiving the notice from APS the Contractor agrees to fully cooperate with the auditors. If Contractor subcontracts any portion of its obligation to another party, Contractor shall guarantee APS' access to books and records of such party.
- 16. **GOVERNING LAW:** This RFP and any contract with an Offeror which may result from this procurement shall be governed by the laws of the State of New Mexico.
- 17. <u>INDEPENDENT CONTRACTOR:</u> The Contractor is an independent contractor performing services for APS. The Contractor shall not accrue leave, retirement, insurance, or any other benefits afforded to employees of APS as a result of this procurement.
- 18. **DEBARMENT OR SUSPENSION:** A business (Contractor, Subcontractor or Supplier) that has either been debarred or suspended pursuant to the requirements of NMSA 1978, §13-1-177 through §13-1-180, and §13-4-11 through §13-4-17 as amended, shall not be permitted to do business with APS and shall not be considered for award of the contract during the period for which it is debarred or suspended with APS.
- 19. **CONFLICT OF INTEREST:** By submitting a proposal, the Offeror certifies that no relationship exists between the Offeror and APS that interferes with fair competition or is a conflict of interest; and no relationship exists between such proposer and another person or firm that constitutes a conflict of interest that is adverse to APS.
- 20. **NON-DISCLOSURE:** The Offeror shall not disclose any information relating to students, and employees of APS or any IBAC agency other than such information that may be authorized by the individual student or employee. The contractor will ensure compliance with HIPAA and FERPA regulations as applicable.

- Vendor agrees to indemnify and hold harmless APS and IBAC agencies from any damages, claims, liabilities, and costs including reasonable attorney fees in the event any unauthorized release of such information occurs.
- 21. **DELIVERY:** The goods shall be delivered free of the rightful claim of any third person, any security interest or other lien. Unless otherwise agreed all goods called for in this RFP shall be tendered in a single delivery and payment is due only upon such delivery (NET 30).
- 22. <u>FOB</u>: Unless stated otherwise, the price for goods is FOB: Destination (APS' designated address). Proposal prices shall include all freight and delivery charges.
- 23. <u>DELAYS IN DELIVERY</u>: Time is of the essence and this purchase may be subject to termination for failure to deliver on time, unless delay was caused by APS. If delay in delivery is foreseen, Seller must notify the APS Requesting Department of late delivery, cause of late delivery and remedy for late delivery.
- 24. <u>INSPECTION</u>: Final inspection will be made at the destination upon completion of delivery of goods/services. Final inspection shall include any testing or inspection procedures required by the specifications.
- 25. <u>ACCEPTANCE</u>: Acceptance of delivery of goods/services shall not be considered acceptance of the goods/services furnished. Acceptance occurs when the Requesting Department, after a reasonable opportunity to inspect the goods/services, signifies to the seller that are goods/services are conforming and fails to make an effective rejection.
- 26. <u>BUYERS REVOCATION OF ACCEPTANCE</u>: Requesting Department can revoke acceptance of goods when it is discovered, in a reasonable time, that the Sellers nonconforming goods substantially impair the value of the goods.
- 27. <u>SELLERS RIGHT TO CURE A NONCONFORMING DELIVERY OF GOODS</u>: The Seller, upon notice of revocation of acceptance, shall correct without charge and deliver conforming goods in a reasonable time.
- 28. <u>INVOICES:</u> Vendor shall submit invoices directly to APS Accounts Payable, unless otherwise instructed. Invoices may be sent to accounts.payable@aps.edu. Each invoice shall include APS Purchase Order Number. Invoices that are missing APS purchase order numbers are not eligible for payment.
- 29. **PAYMENT:** Any invoice received and payment made shall be subject to APS' terms and conditions (NET 30) unless specifically waived by APS in a separate written document.
- 30. **USE OF DISTRICT NAME OR LOGO(s):** Vendor may not use APS official name or logo, or any phrase associated with the District, without written permission from the Superintendent of Schools or their designee.
- 31. <u>DISPUTE RESOLUTION:</u> In the event the Parties do not agree to mediate the dispute or unable to resolve the dispute through mediation, then the dispute shall be resolved by binding arbitration. Such arbitration shall be governed by the New Mexico Uniform Arbitration Act, NMSA 44-7A-1, et seq. as amended.

#### ADDITIONAL TERMS AND CONDITIONS FOR COMPLIANCE WITH 2 C.F.R. PART 200, APPENDIX II

#### 1. REMEDIES

The parties agree that the Owner reserves all rights and privileges under applicable laws andregulations with respect to this contract in the event of a breach of contract, including but not limited to the right to institute legal proceedings in a court of competent jurisdiction seekingmonetary damages, court costs and litigation expenses, as applicable.

#### 2. TERMINATION FOR CAUSE AND CONVENIENCE

The parties agree that the Owner reserves the right to terminate the contract immediately, with written notice to the Contractor, in the event of a breach or default of the Contractor, including but not limited to situations in which the Contractor fails, after a reasonable opportunity to cure, to: (1) meet schedules, deadlines, and/or delivery dates within the time specified in the procurement solicitation, contract, and/or a purchase order; (2) make any payments owed; or (3) otherwise perform in accordance with the contract and/or the procurement solicitation. The Owner also reserves the right to terminate the contract immediately, with written notice to the Contractor, for convenience, if the Owner believes that it is in the best interest of the Owner to do so. In the event of a termination for convenience of the Owner, the Contractor will be compensated only for work performed and goods provided by the Owner as of the termination date. The amount of compensation due the Contractor in the event of a termination for the convenience of the Owner shall be a reasonable amount, using as a guide factors such as the percentage of work or services performed by the Contractor and accepted by the Owner as of the date of termination, the contract price and any unit prices specified in the contract, as applicable.

#### 3. EQUAL EMPLOYMENT OPPORTUNITY

#### During the performance of this contract, the contractor agrees as follows:

a. The contractor will not discriminate against any employee or applicant for employment because of race, color, religion, sex, sexual orientation, gender identity, or national origin. The contractor will take affirmative action to ensure that applicants are employed, and that employees are treated during employment without regard to their race, color, religion, sex, sexual orientation, gender identity, or national origin. Such action shall include, but not be limited to the following:

Employment, upgrading, demotion, or transfer; recruitment or recruitment advertising; layoff or termination; rates of pay or other forms of compensation; and selection for training, including apprenticeship. The contractor agrees to post in conspicuous places, available to employees and applicants for employment, notices to be provided setting forth the provisions of this nondiscrimination clause.

- b. The contractor will, in all solicitations or advertisements for employees placed by or on behalf of the contractor, state that all qualified applicants will receive consideration for employment without regard to race, color, religion, sex, sexual orientation, gender identity, or national origin.
- c. The contractor will not discharge or in any other manner discriminate against any employee or applicant for employment because such employee or applicant has inquired about, discussed, or disclosed the compensation of the employee or applicant or another employee or applicant. This provision shall not apply to instances in which

an employee who has access to the compensation information of other employees or applicants as a part of such employee's essential job functions discloses the compensation of such other employees or applicants to individuals who do not otherwise have access to such information, unless such disclosure is in response to a formal complaint or charge, in furtherance of an investigation, proceeding, hearing, or action, including an investigation conducted by the employer, or is consistent with the contractor's legal duty to furnish information.

- d. The contractor will send to each labor union or representative of workers with which he has a collective bargaining agreement or other contract or understanding, a notice to be provided advising the said labor union or workers' representatives of the contractor's commitments under this section, and shall post copies of the notice in conspicuous places available to employees and applicants for employment.
- e. The contractor will comply with all provisions of Executive Order 11246 of September 24,1965, and of the rules, regulations, and relevant orders of the Secretary of Labor.
- f. The contractor will furnish all information and reports required by Executive Order 11246 of September 24, 1965, and by rules, regulations, and orders of the Secretary of Labor, or pursuant thereto, and will permit access to his books, records, and accounts by the administering agency and the Secretary of Labor for purposes of investigation to ascertain compliance with such rules, regulations, and orders.
- g. In the event of the contractor's noncompliance with the nondiscrimination clauses of this contract or with any of the said rules, regulations, or orders, this contract may be canceled, terminated, or suspended in whole or in part and the contractor may be declared ineligible for further Government contracts or federally assisted construction contracts in accordance with procedures authorized in Executive Order I1246 of September 24, 1965, and such other sanctions may be imposed and remedies invoked as provided in Executive Order 11246 of September 24, 1965, or by rule, regulation, or order of the Secretary of Labor, or as otherwise provided by law.
- h. The contractor will include the portion of the sentence immediately preceding paragraph (a) and the provisions of paragraphs (a) through (g) in every subcontract or purchase order unless exempted by rules, regulations, or orders of the Secretary of Labor issued pursuant to section 204 of Executive Order 11246 of September 24, 1965, so that such provisions will be binding upon each subcontractor or vendor. The contractor will take such action with respect to any Subcontract or purchase order as the administering agency may direct as a means of enforcing such provisions, including sanctions for noncompliance:

Provided, however, that in the event a contractor becomes involved in, or is threatened with, litigation with a subcontractor or vendor as a result of such direction by the administering agency, the contractor may request the United States to enter into such litigation to protect the interests of the United States.

The applicant further agrees that it will be bound by the above equal opportunity clause withrespect to its own employment practices when it participates in federally assisted construction work: *Provided*, That if the applicant so participating is a State or local government, the above equal opportunity clause is not applicable to any agency, instrumentality or subdivision of such government which does not participate in work on or under the contract.

The Owner shall upon its own action or upon written request of an authorized representative of the Department of Labor withhold or cause to be withheld, from any moneys payable on account of work performed by the contractor or subcontractor under any such contract or any other Federal contract with the same prime contractor, or any other federally-assisted contract subject to the Contract Work Hours and Safety Standards Act, which is held by the same prime contractor, such sums as may be determined to be necessary to satisfy any liabilities of such contractor or subcontractor for unpaid wages and liquidated damages as provided in the clause set forth in paragraph (b) of this section.

d. Subcontracts. - b.The Contractor agrees to permit any of the foregoing parties to reproduce by any means whatsoever or to copy excerpts and transcriptions as reasonably needed.
- c. The Contractor agrees to provide the FEMA Administrator or his authorized representative's access to construction or other work sites pertaining to the work being completed under the contract.
- d. In compliance with the Disaster Recovery Act of 2018, the Owner and the Contractor

Acknowledge and agree that no language in this contract is intended to prohibit audits or internal reviews by the FEMA Administrator or the Comptroller General of the United States.

#### 12. DHS SEAL, LOGO, AND FLAGS

The contractor shall not use the DHS seal(s), logos, crests, or reproductions of flags or likenesses of DHS agency officials without specific FEMA pre-approval.

#### 13. COMPLIANCE WITH FEDERAL LAW, REGULATIONS, AND EXECUTIVE ORDERS

This is an acknowledgement that FEMA financial assistance will be used to fund all or a portion of the contract. The contractor will comply with all applicable Federal law, regulations, executive orders, FEMA policies, procedures, and directives.

#### 14. NO OBLIGATION BY FEDERAL GOVERNMENT

The Federal Government is not a party to this contract and is not subject to any obligations or liabilities to the non-Federal entity, contractor, or any other party pertaining to any matter resulting from the contract.

#### 15. PROGRAM FRAUD AND FALSE OR FRAUDULENT STATEMENTS OR RELATED ACTS

Contractor acknowledges that 31 U.S.C. Chap. 38 (Administrative Remedies for False Claims and Statements) applies to the Contractor's actions pertaining to this contract.

#### **PROTESTS**

If any Offeror who is aggrieved in connection with a solicitation or award of an Agreement may protest to the Purchasing Office in accordance with the requirements of the Contracting Procurement Regulations and the State Procurement Code. The protest should be made in writing within twenty-four (24) hours after the facts or occurrences giving rise thereto, but **NO LATER THAN** fifteen (15) calendar days after the facts or occurrences giving rise thereto (NMSA1978, §13-1-172). The protest must be in writing and delivered to the Executive Director - Procurement Department, Albuquerque, New Mexico

- 1. In the event of a timely protest under this section, the Purchasing Agent and the Contracting Agency shall not proceed further with the procurement unless the Purchasing Agent makes a determination that the award of Agreement is necessary to protect substantial interests of the Contracting Agency (NMSA 1978, §13-1-173).
- The Purchasing Agent or his/her Designee shall have the authority to take any action reasonably necessary to
  resolve a protest of an aggrieved Offeror concerning a procurement. This authority shall be exercised in
  accordance with adopted regulations, but shall not include the authority to award money damages or attorneys'
  fees (NMSA 1978, §13-1-174).
- The Purchasing Agent or his/her Designee shall promptly issue a determination relating to the protest. The determination shall:

A focus of this RFP will be the pursuit of specific objectives related to cost saving measures including value-based purchasing and other innovative approaches. The IBAC is looking for a consultant who can provide us with ideas and solutions which will place emphasis on cost saving throughout the totality of this procurement cycle. This approach should consider but not be limited to:

- A. Value-Based Plan Design
- B. Enhanced and Standardized Reporting
- C. <u>Value-Based Provider Reimbursement</u> Consideration will be given to opportunities both with and without medical plan administrator participation
- D. <u>Innovative approach to Performance Guarantees</u> that will result in cost savings to the IBAC agencies and value to our employees.

#### RFP SCHEDULE

The RFP Buyer will make every effort to adhere to the RFP Schedule as noted on front cover of this RFP. The schedule is subject to change by addendum. The evaluation committee **MAY** interview the Offeror(s) of the top rated proposals; however, contracts may be awarded without such interviews and based solely on written offers. Finalists will be contacted to schedule interviews if required. If an interview is requested, evaluation scores will be re-scored to reflect written response and interview response.

#### PURPOSE OF THIS REQUEST FOR PROPOSAL

The purpose of the Request for Proposal (RFP) is to solicit sealed proposals, to establish a contract through competitive negotiations for the procurement of consulting/project management services to assist in the procurement of dental, vision and medical plans (including Medicare Advantage and Medicare Supplement) for The Interagency Benefits Advisory Committee (IBAC) and its approximately 138,000 eligible employees/retirees and approximately 176,000 medical plan enrolled members.

The scope of this procurement is limited to consulting and project management services associated with the development and evaluation of a comprehensive RFP for dental, vision and medical services/administrators

(including Medicare Advantage and Medicare Supplement plans), along with wellness services, point solutions, and Employee Assistance Program (EAP) for some of the IBAC agencies. The awarded contractor will work with the IBAC in all phases of the development and evaluation of the RFP, to include timeline, questionnaires for each type of service, data-gathering, evaluation criteria (including scoring template), assistance with response to bidder's questions, assistance in the evaluation of the RFP responses, to include both detailed and summary evaluation reports (including analyst of technical and financial responses, finalist presentations and best and final offers), and assistance in reviewing the resulting contracts to be certain all agreed-upon provisions from the RFP are captured in the final contracts.

Any inquiries or requests regarding this procurement should be submitted to the RFP Buyer in writing. See Cover Page of RFP. Offerors may contact ONLY the RFP Buyer regarding the procurement. Other APS or IBAC agency employees do not have the authority to respond to questions related to this RFP.

#### SCOPE OF SERVICES

APS is seeking a consultant to handle the procurement of IBAC medical, dental, vision, wellness services, point solutions, and EAP services effective July 1, 2024 for State of New Mexico Risk Management Division, New Mexico Public Schools Insurance Authority, and New Mexico Retiree Health Care Authority and effective January 1, 2025 for Albuquerque Public Schools. It is the IBAC's goal that this comprehensive RFP be released the first week in July, 2023. The consultant will act as project manager for the following services:

- 1. Based on input and direction from the APS RFP Buyer and the IBAC agencies, develop an IBAC-specific Request for Proposal (RFP) for dental, vision and medical services/administrators (including Medicare Advantage and Medicare Supplement plans), wellness services, point solutions, and EAP, while adhering to state-mandated purchasing guidelines and to the Health Care Purchasing Act; assume responsibility for state-mandated publication of the RFP. The RFP will ask for proposals for both self-funded and fully insured dental and vision plans, and shall include at least one distinct service area consisting of the Albuquerque metropolitan area. Proposals on a distinct service area shall be evaluated separately.
- Collect all experience and eligibility/enrollment information needed for this RFP from each IBAC agency and/or the existing plan administrators/vendors. (This is generally time-consuming, and the Project Manager needs to ensure the data is reviewed for reasonableness and consistency.)
- 3. Include in the RFP desired services requested by each IBAC agency including any changes to be considered for the new contracts (i.e., a change in funding type). After collaboration with the IBAC agencies include in the RFP the agreed upon cost savings approaches and performance guarantees by type of service that will drive plan savings for the agencies and value for our members.
- 4. Provide a detailed timeline, methodology, and strategy as to how the management of the RFP will be accomplished and evaluated by the IBAC. Develop a scoring template for IBAC agency use in the evaluation of each proposal.
- 5. Work closely with the assigned APS RFP Buyer and IBAC agencies to respond to offeror's questions and develop any needed addendums to the RFP.
- 6. Prepare and present to the IBAC any necessary or requested reports on all components of the RFP (mandatory specifications, desirable specifications, questionnaire(s), costs, etc.). Complete a comprehensive evaluation of the medical proposals (including Medicare Advantage and Medicare Supplement) and dental, vision, wellness services, point solutions and EAP proposals for each applicable IBAC agency and provide related

reporting including a side-by-side comparison of responses. Also to include but not be limited to analysis such as network disruption and geo-access reporting.

This agreement effective this ADD DATE is entered into between Albuquerque Public Schools, hereinafter referred to as APS or District and ADD AWARDED CONTRACTOR NAME referred to as Contractor or Contract Project Manager.

1. SERVICES TO BE PROVIDED: The Contractor shall provide RFP consultation services as requested by APS and described in Request for Proposal RFP 23-066 NLM and expanded in the Contractors response. This agreement is for consulting/project management services to assist in the procurement of medical, dental, vision plans and related services for The Interagency Benefits Advisory Committee (The IBAC) and its approximately 138,000 eligible employees/retirees and approximately 176,000 medical plan enrolled members.

The scope of this procurement is limited to consulting and project management services associated with the development and evaluation of a comprehensive RFP for dental, vision and medical services/ administrators (including Medicare Advantage and Medicare Supplement plans), along with wellness services, point solutions and Employee Assistance Program. The awarded contractor will work with the IBAC in all phases of the development and evaluation of the RFP, to include adherence with the Health Care Purchasing Act, timeline, questionnaires for each type of service, data-gathering, evaluation criteria, assistance with response to bidder's questions, assistance in the evaluation of the RFP responses, detailed and summary evaluation reports, assistance with finalist presentations and best and final offers, and assistance in reviewing the resulting contracts to be certain all agreed-upon provisions from the RFP are captured in the final contracts.

2. AGREEMENT DOCUMENTS: The Agreement shall be comprised of this agreement Exhibit A, its attachments and all documents referenced herein, including a Business Associates Agreement. The Agreement shall also include Request for Proposal RFP 23-066 NLM, including the Contractor response, Referenced Scope of Work, Technical

Specifications, Purchase Order Terms and Conditions, and all negotiation records, which are incorporated herein and made a part of the Agreement. In instances where there exists a conflict between any of the documents described above, this Agreement plus attachments hereto, negotiation records,

APS solicitation documents, and the Contractor's response to the solicitation, in that order, shall control the interpretation of the parties respective rights and obligations.

3. TERM: The term of this agreement is ADD START DATE to January 1, 2025 or until all resulting contracts for medical, dental, vision, wellness services, Employee Assistance Program and point solutions have been executed with the awarded administrators/carriers.

4. PAYMENT AND INVOICING: The Contractor shall be paid for services rendered satisfactorily at the submitted rate submitted in Contractors proposal. Per 13-1-154-1 NMSA, the total per contract amount cannot exceed AGREED UPON AMOUNT over the term of the agreement. All payment will be in

arrears on the following schedule:

30% upon release of IBAC RFP for all requested services,

20% upon completion of the RFP technical and cost scoring

30% upon completion of the resulting contracts finalized by the State of New Mexico Risk Management Division, New Mexico Public Schools Insurance Authority and New Mexico Retiree Health Care Authority 20% upon completion of medical, dental and vision contracts finalized by the Albuquerque Public Schools.

Contractor shall provide detailed invoices to the District as each of these milestones is reached. The invoices submitted by Contractor shall note the purchase order number and must be delivered to APS Employee Benefits Department. Payment shall be made by the District within 30 days following receipt of an invoice for completed and accepted work, except to the extent the District disputes the content of the invoice or the amount due and owing. In the event that the District disputes an invoice, the District shall notify the Contractor of the dispute and shall promptly pay the non-disputed portions of the invoice. Any invoice received and payment made shall be subject to this agreement and Purchase Order Terms and Conditions, the RFP and contractors' response to the RFP unless specifically waived by District in a separate written document.

- 5. AUDIT: The District reserves the right to audit the contractor records associated with this contract at any time during the contract period and for a period of up to three years following the expiration or termination of the agreement. Such audit may be conducted by District personnel or a third party under contract with the District. The District shall give the contractor reasonable notice prior to the conduct of any audit and upon receiving the notice from the District the contractor agrees to fully cooperate with the auditors. If contractor subcontracts any portion of its obligation to another party, contractor shall guarantee District access to books and records of such party.
- AMENDMENTS: This Agreement shall not be altered, changed, or amended except by written instrument signed by both parties.
- 7. ASSIGNMENTS: The Contractor shall not assign nor delegate specific duties as part of this Agreement nor transfer any interest nor assign any claims for money due or to become due under this Agreement without the written consent of APS.
- 8. PROCUREMENT CODE: The Procurement Code, Sections 13-1-28 through 13-1-199 NMSA 1978, imposes civil and misdemeanor criminal penalties for its violation. In addition, the New Mexico criminal statutes impose felony penalties for bribes, gratuities, and kickbacks.

#### 9. TERMINATION BY THE DISTRICT:

- For Cause
  - a. The occurrence of either one of the following events will justify termination for cause:
    - i. Contractor's persistent failure to perform the work in accordance with the contract documents (including but not limited to, failure to supply sufficient

skilled workers or suitable materials or equipment).

- ii. Contractor's violation in any substantial way of any provisions of this contract.
- b. If either one of the events identified above occur, the District may, after giving Contractor (and the surety, if any) ten (10) days written notice, terminate the service of Contractor, exclude Contractor from site, and take possession of the work. Contractor shall be paid for project costs incurred up to the date of termination but shall not be paid for loss of profits resulting from such termination.
- c. Where Contractor's services have been so terminated by the District, the termination will not affect any rights or remedies of District against contractor then existing or which may thereafter accrue. Any retention or payment of moneys due the Contractor by the District will not release the Contractor from liability.

#### 2. For Convenience

- a. Upon ten (10) days written notice to contractor, APS may without cause and without prejudice to any other right or remedy of APS, elect to terminate the contract.
- b. In such case, Contractor shall be paid (without duplication of any items):
  - i. for completed and acceptable work executed in accordance with the contract documents prior to the effective date of termination,
  - ii. for expenses sustained prior to the effective date of termination in performing services and furnishing labor, materials or equipment as required by the contract document in connection with uncompleted work.
- c. Contractor shall not be paid on account of loss of anticipated profits or revenue or other economic loss arising out of or resulting from such termination.
- 10. INDEMNIFICATION: The Contractor shall be responsible for damage to persons or property that occurs as a result of his fault or negligence, or that of any of his employees, agents or subcontractors arising out of contractor performance of the contract. Any equipment or facilities damaged by the Contractor's operation shall be repaired and/or restored to their original condition at the Contractor's expense.
- 11. LIMITATION OF LIABILITY: The Contractor's liability to the District for any cause whatsoever shall be limited to the purchase price paid to the Contractor for the products and services that are the subject of the District's claim. The foregoing limitation does not apply to paragraph 10 of this agreement or to damages resulting from personal injury caused by the Contractor's negligence.
- 12. INDEPENDENT CONTRACTOR: The Contractor is an independent contractor performing services for the District. The Contractor shall not accrue leave, retirement, insurance, or any other benefits afforded to employees of the District as a result of this procurement.
- 13. DEBARMENT OR SUSPENSION: A business (contractor, subcontractor or supplier) that has either been debarred or suspended pursuant to the requirements of 13-1-177 through 13-1-180, and 13-4-11 through 13-4-17 NMSA 1978 as amended, shall not be permitted to do business with the District and shall not be considered for award of the contract during the period for which it is debarred or suspended with the District.
- 14. CONFLICT OF INTEREST: By submitting a proposal, the proposer certifies that no relationship exists between the proposer and the District that interferes with fair competition or is a conflict of interest; and no relationship exists between such proposer and another person or firm that constitutes a conflict of interest that is averse to the District.

- 15. GOVERNING LAW: This Agreement will be interpreted and governed by the laws of the State of New Mexico.
- 16. OTHER APPLICABLE LAWS: Any other provisions required to be included in a contract of this type by any applicable and valid executive order, federal, state or local law, ordinance, rule or regulation shall be deemed to be incorporated herein.
- 17. SEVERABILITY: If any provision of the resultant pricing agreement is found invalid or unenforceable, the remainder of the resultant agreement will be enforced to the maximum extent permissible and the legality and enforceability of the other provisions of the agreement will not be affected.
- 18. NON-DISCLOSURE: The contractor shall not disclose any information relating to students, employees and retirees of APS or other IBAC agencies other than such information that may be authorized by the individual student, employee or retiree. The Contractor will ensure compliance with HIPPA and FERPA regulations as applicable, and will execute a Business Associates Agreement with APS. Contractor agrees to indemnify and hold harmless APS from any damages, claims, liabilities, and costs including reasonable attorney fees in the event any unauthorized release of such information occurs.

#### 19. INSURANCE:

Contractor shall, for the duration of the contract, maintain professional liability and automotive liability insurance with limits of liability no less than the limits of liability for governmental entities as provided by the New Mexico Tort Claims Act. Contractor shall provide APS with proof of such insurance as a condition precedent to the execution of this contract. Contractor also agrees to notify APS immediately if such insurance is out of force for any reason at any time during the life of the contract. [Also workers compensation insurance where required by law].
