The Contractor shall comply with Section 31-13-9, Code of Alabama 1975. If the Contractor employees one or more employees in the State of Alabama, Alabama law requires that the Contractor provide the City of Foley proof of enrollment in E-Verify (see <u>www.uscis.gov/everify</u>). The Contractor shall provide proof of enrollment in E-Verify along with the bid.

No bid shall be withdrawn for a period of 120 days subsequent to the opening of bids without the consent of the Owner.
