The project consists of the following major elements of construction including but not limited:

Retrofit of a TPO membrane roofing system onto the existing standing seam metal roof at the Maintenance Building in the City Yards at 1004 East 12th Street. The existing roof is approximately 18,300 square feet in area. The new roofing system shall consist of a new White 0.060" TPO roofing system mechanically fastened over the existing sloped roof panels, including insulation and coverboard to meet 2012 IBC, plus additional work as specified. The completed roofing system must have a 20 year minimum manufacturer's warranty on all materials and labor.
