Letters of interest shall indicate the anticipated scope of services to be completed by subcontractors. The subconsultant shall be one that is pre-qualified by TDOT to perform the specific tasks required. All letters of interest must be received on or before 11:00 AM (Eastern Time) Friday, August 18, 2017. Late submissions will not be considered.
