## **SPECIFICATIONS**

Vendor will need to provide rates and processes related to any shipping costs, and relative to how measurements will be obtained for individuals, including any projected timelines for each. The location of the vendor will be given consideration in the bid award.

## **CONTRACT PERIOD**

This contract shall be for a period of three (3) years commencing on or around **July 1, 2016** and ending on or around **June 30, 2019**. A two-year extension option is available if both parties are in agreement which would extend the contract through June 30, 2021.
