




Sheet P-201 Plumbing Floor Plan revised to show waste line routed around Item 1 structural footings and the mop sink relocated to avoid footing.

1 PLUMBING DEMOLITION PLAN 1/8" = 1'-0"





LOCATION MAP


- PROJECT SITE
