A certificate of insurance <u>must</u> be on file in the Finance Department before work may begin and must be maintained until work is completed.

Union County Board of Education shall be the Certificate Holder and the bid number and title shall show on the certificate. Union County Government shall be named as an additional insured on all policies except worker's compensation and auto. Insurance carrier ratings shall have a Best's rating of A-VII or better, or its equivalent. Cancellation clause on certificate should strike out "endeavor to" and include a 30-day notice of cancellation where applicable. Any deviations from the above requirements *must* be disclosed to the Union County Director of Finance. Any liability deductibles or exclusions must also be disclosed. Exceptions can be granted if applicable. Vendor is not to begin services until Certificate of Insurance is on file with Purchasing Agent.
