#### I. SCOPE OF SOLICITATION

School District Five of Lexington and Richland Counties is seeking competitive sealed proposals from qualified and experienced firms to provide districtwide professional grounds and detention ponds maintenance services complying with the enclosed description and/or specifications and conditions.

**ACQUIRE SERVICES:** The purpose of this solicitation is to acquire services complying with the enclosed description and/or specifications and conditions.

MAXIMUM CONTRACT PERIOD – ESTIMATED: Start date: March 01, 2024 / End date: February 28, 2029. Dates provided are estimates only. Any resulting contract will begin on the date specified in the notice of award. See clause entitled "Term of Contract - Effective Date/Initial Contract Period".

The initial term of the contract will be three (3) years from the date of award with the option to renew for two (2) additional one-year periods if all parties agree. Pricing shall remain fixed for a period of two (2) years. No price increases will be considered during this period. Request for price increases after this period shall be made in writing to the Coordinator of Purchasing at least ninety days prior to the end of the contract term including any optional renewal periods. The District may choose to negotiate a fair and reasonable increase with the current contract holder or may choose to cancel the contract and rebid the services. Approved increases will become effective on July 1st of any year.

#### II. INSTRUCTIONS TO OFFERORS – A. GENERAL INSTRUCTIONS

**DEFINITIONS, CAPITALIZATION, AND HEADINGS:** CLAUSE HEADINGS USED IN THIS SOLICITATION ARE FOR CONVENIENCE ONLY AND SHALL NOT BE USED TO CONSTRUE MEANING OR INTENT. EVEN IF NOT CAPITALIZED, THE FOLLOWING DEFINITIONS ARE APPLICABLE TO ALL PARTS OF THE SOLICITATION, UNLESS EXPRESSLLY PROVIDED OTHERWISE.

AMENDMENT means a document issued to supplement the original solicitation document.

BOARD means the Board of Trustees of District Five of Lexington and Richland Counties.

BUSINESS means any corporation, partnership, individual, sole proprietorship, joint stock company, joint venture, or any other legal entity.

CHANGE ORDER means any written alteration in specifications, delivery point, rate of delivery, period of performance, price, quantity, or other provisions of any contract accomplished by mutual agreement

of the parties to the contract.

CONTRACT means all types of District Five of Lexington and Richland Counties' agreements, regardless of what they may be called, for the procurement or disposal of supplies, services, information technology, or construction. or construction.

CONTRACT MODIFICATION means a written order signed by the Procurement Officer, directing the contractor to make changes which the clause of the contract TITLED Changes: "if included herein, authorizes the Procurement Coordinator to order without the consent of the contractor".

CONTRACTOR means the Offeror receiving an award as a result of this solicitation.

COVER PAGE means the top page of the original solicitation on which the solicitation is identified by number.

Offerors are cautioned that Amendments may modify information provided on the Cover Page.

DISTRICT means District Five of Lexington and Richland Counties.

OFFER means the bid, quote or proposal submitted in response this solicitation. The terms Bid and Proposal are used interchangeably with the term Offer.

OFFEROR means the single legal entity submitting the offer. The term Bidder is used interchangeably with the term Offeror. See bidding provisions entitled Signing Your Offer and Bid/Proposal As Offer To Contract.

PAGE TWO means the second page of the original solicitation, which is labeled Page Two.

PROCUREMENT OFFICER means the person, or his successor, identified as such on either the cover page, an amendment, or an award notice.

YOU and YOUR means Offeror.

SOLICITATION means this document, including all its parts, attachments, and any Amendments.

SUBCONTRACTOR means any person you contract with to perform or provide any part of the work or service. USDA means United States Department of Agriculture.

WORK means all labor, materials, equipment, services, or property of any type, provided or to be provided by

the Contractor to fulfill the Contractor's obligations under the Contract.

AMENDMENTS TO SOLICITATION: (a) The Solicitation may be amended at any time prior to opening. All bidders requesting the bid package will be sent copies of all amendments. (b) Offerors shall acknowledge receipt of any amendment to this solicitation (1) by signing and returning the amendment, (2) by identifying the amendment number and date in the space provided for this purpose on Page Two (3) by letter, or (4) by submitting a bid that indicates in some way that the bidder received the amendment. (c) If this solicitation is amended, then all terms and conditions which are not modified remain unchanged.

AUTHORIZED AGENT: All authority regarding this procurement is vested solely with the responsible Procurement Officer. Unless specifically delegated in writing, the Procurement Officer is the only government official authorized to bind the government with regard to this procurement or the resulting contract.

AWARD NOTIFICATION: Notice regarding any award, cancellation of award, or extension of award will be posted at the location and on the date specified on the Cover Page or, if applicable, any notice of extension of award. Should the contract resulting from this Solicitation have a total or potential value of one hundred thousand dollars or more, such notice will be sent to all Offerors responding to the Solicitation and any award will not be effective until the eleventh day after such notice is given.

BID/PROPOSAL AS OFFER TO CONTRACT: By submitting Your Bid or Proposal, You are offering to enter into a contract with District Five of Lexington and Richland Counties. Without further action by either party, a binding contract shall result upon final award. Any award issued will be issued to, and the contract will be formed with, the entity identified as the Offeror on the Cover Page. An Offer may be submitted by only one legal entity; "joint bids" are not allowed.

BID ACCEPTANCE PERIOD: In order to withdraw Your Offer after the minimum period specified on the Cover Page, You must notify the Procurement Officer in writing.

BID IN ENGLISH and DOLLARS: Offers submitted in response to this solicitation shall be in the English language and in US dollars, unless otherwise permitted by the Solicitation.

CERTIFICATE OF INDEPENDENT PRICE DETERMINATION: GIVING FALSE, MISLEADING, OR INCOMPLETE INFORMATION ON THIS CERTIFICATION MAY RENDER YOU SUBJECT TO PROSECUTION UNDER SECTION 16-9-10 OF THE SOUTH CAROLINA CODE OF LAWS AND OTHER APPLICABLE LAWS.

- (a) By submitting an offer, the Offeror certifies that:
  - (1) The prices in this offer have been arrived at independently, without, for the purpose of restricting competition, any consultation, communication, or agreement with any other Offeror or competitor relating to:
    - (i) Those prices;
    - (ii) The intention to submit an offer; or
    - (iii) The methods or factors used to calculate the prices offered.
  - (2) The prices in this offer have not been and will not be knowingly disclosed by the Offeror, directly or indirectly, to any other Offeror or competitor before bid opening (in the case of a sealed bid solicitation) or contract award (in the case of a negotiated solicitation) unless otherwise required by law; and
  - (3) No attempt has been made or will be made by the Offeror to induce any other concern to submit or not to submit an offer for the purpose of restricting competition.
- (b) Each signature on the offer is considered to be a certification by the signatory that the signatory:
  - (1) Is the person in the Offeror's organization responsible for determining the prices being offered in this bid or proposal, and that the signatory has not participated and will not participate in any action contrary to paragraphs (a)(1) through (a)(3) of this certification; or
  - (2)(i) Has been authorized, in writing, to act as agent for the Offeror's principals in certifying that those principals have not participated, and will not participate in any action contrary to paragraphs (a)(1) through (a)(3) of this certification [As used in this subdivision (b)(2)(i), the term "principals" means the person(s) in the Offeror's organization responsible for determining the prices offered in this bid or proposal].
    - (ii) As an authorized agent, does certify that the principals referenced in subdivision (b)(2)(i) of this certification have not participated, and will not participate, in any action contrary to paragraphs (a)(1) through (a)(3) of this certification; and
    - (iii) As an agent, has not personally participated, and will not participate, in any action contrary to paragraphs (a)(1) through (a)(3) of this certification.
- (c) If the Offeror deletes or modifies paragraph (a)(2) of this certification, the Offeror must furnish with its offer a signed statement setting forth in detail the circumstances of the disclosure.

#### CERTIFICATION REGARDING DEBARMENT AND OTHER RESPONSIBILITY MATTERS:

(a)

- (1) By submitting an Offer, Offeror certifies, to the best of its knowledge and belief, that-
  - (i) Offeror and/or any of its Principals
    - (A) Are not presently debarred, suspended, proposed for debarment, or declared ineligible for the award of contracts by any state or federal agency;
    - (B) Have not, within a three-year period preceding this offer, been convicted of or had a civil judgment rendered against them for: commission of fraud or a criminal offense in connection with obtaining, attempting to obtain, or performing a public (Federal, state, or local) contract or subcontract; violation of Federal or state antitrust statutes relating to the submission of offers; or commission of embezzlement, theft, forgery, bribery, falsification or destruction of records, making false statements, tax evasion, or receiving stolen property; and
    - (C) Are not presently indicted for, or otherwise criminally or civilly charged by a governmental entity with, commission of any of the offenses enumerated in paragraph (a)(1)(i)(B) of this provision.
  - (ii) Offeror has not, within a three-year period preceding this offer, had one or more contracts terminated for default by any public (Federal, state, or local) entity.
- (2) "Principals," for the purposes of this certification, means officers; directors; owners; partners; and,

persons having primary management or supervisory responsibilities within a business entity (e.g., general manager; plant manager; head of a subsidiary, division, or business segment, and similar positions).

- (b) Offeror shall provide immediate written notice to the Procurement Officer if, at any time prior to contract award, Offeror learns that its certification was erroneous when submitted or has become erroneous by reason of changed circumstances.
- (c) If Offeror is unable to certify the representations stated in paragraphs (a)(1), Offer must submit a written explanation regarding its inability to make the certification. The certification will be considered in connection with a review of the Offeror's responsibility. Failure of the Offeror to furnish additional information as requested by the Procurement Officer may render the Offeror non-responsible.
- (d) Nothing contained in the foregoing shall be construed to require establishment of a system of records in order to render, in good faith, the certification required by paragraph (a) of this provision. The knowledge and information of an Offeror is not required to exceed that which is normally possessed by a prudent person in the ordinary course of business dealings.
- (e) The certification in paragraph (a) of this provision is a material representation of fact upon which reliance was placed when making award. If it is later determined that the Offeror knowingly or in bad faith rendered an erroneous certification, in addition to other remedies available to the District, the Procurement Officer may terminate the contract resulting from this solicitation for default.

# DISCLOSURE OF CONFLICTS OF INTEREST OR UNFAIR COMPETITIVE ADVANTAGE:

You warrant and represent that your offer identifies and explains any unfair competitive advantage you may have in competing for the proposed contract and any actual or potential conflicts of interest that may arise from your participation in this competition or your receipt of an award. The two underlying principles are (a) preventing the existence of conflicting roles that might bias a contractor's judgment, and (b) preventing an unfair competitive advantage. If you have an unfair competitive advantage or a conflict of interest, the District may withhold award. Before withholding award on these grounds, an offeror will be notified of the concerns and provided a reasonable opportunity to respond. Efforts to avoid or mitigate such concerns, including restrictions on future activities, may be considered. Without limiting the foregoing, you represent that your offer identifies any services that relate to either this solicitation or the work and that has already been performed by you, a proposed subcontractor, or an affiliated business of either.

**DEADLINE FOR SUBMISSION OF OFFER:** Any offer received after the Procurement Officer of the District or their designee has declared that the time set for opening has arrived, shall be rejected unless the offer has been delivered to the designated District office or mailroom as instructed on the Cover page prior to the bid opening.

**DRUG-FREE WORK PLACE CERTIFICATION:** By submitting an Offer, Contractor certifies that, if awarded a contract, Contractor will comply with all applicable provisions of the Drug-free Workplace Act, Title 44, Chapter 107 of the South Carolina Code of Laws, as amended.

**DUTY TO INQUIRE:** Offeror, by submitting an Offer, represents that it has read and understands the Solicitation and that its Offer is made in compliance with the Solicitation. Offerors are expected to examine the Solicitation thoroughly and should request an explanation of any ambiguities, discrepancies, errors, omissions, or conflicting statements in the Solicitation. Failure to do so will be at the Offeror's risk. All ambiguities, discrepancies, errors, omissions, or conflicting statements in the Solicitation shall be interpreted to require the better quality or greater quantity of work and/or materials, unless otherwise directed by amendment. Offeror assumes responsibility for any patent ambiguity in the Solicitation that Offeror does not bring to the District's attention. See clause entitled "Questions from Offerors."

**ETHICS CERTIFICATE**: By submitting an offer, the offeror certifies that the offeror has and will comply with, and has not, and will not, induce a person to violate Title 8, Chapter 13 of the South Carolina Code of Laws, as amended

(ethics act). The following statutes require special attention: Section 8-13-700, regarding use of official position for financial gain; Section 8-13-705, regarding gifts to influence action of public official; Section 8-13-720, regarding offering money for advice or assistance of public official; Sections 8-13-755 and 8-13-760, regarding restrictions on employment by former public official; Section 8-13-775, prohibiting public official with economic interests from acting on contracts; Section 8-13-790, regarding recovery of kickbacks; Section 8-13-1150, regarding statements to be filed by consultants; and Section 8-13-1342, regarding restrictions on contributions by contractor to candidate who participated in awarding of contract. The District may rescind any contract and recover all amounts expended as a result of any action taken in violation of this provision. If contractor participates, directly or indirectly, in the evaluation or award of public contracts, including without limitation, change orders or task orders regarding a public contract, contractor shall, if required by law to file such a statement, provide the statement required by Section 8-13-150 to the procurement officer at the same time the law requires the statement to be filed.

**OMIT TAXES FROM PRICE:** Do not include any sales or use taxes in your price that the District may be required to pay.

**OPEN TRADE REPRESENTATION:** By submitting an Offer, Offeror represents that the Offeror is not currently engaged in the boycott of a person or an entity based in or doing business with a jurisdiction with whom South Carolina can enjoy open trade, as defined SC Code Section 11-35-5300.

**PROTESTS:** If you are aggrieved in connection with the solicitation or award of the contract, you may be entitled to protest, but only as provided in Section 11-35-4210. To protest a solicitation, you must submit a protest within fifteen days of the date the applicable solicitation document is issued. To protest an award, you must (i) submit notice of your intent to protest within seven business days of the date the award notice is posted, and (ii) submit your actual protest within fifteen days of the date the award notice is posted. Days are calculated as provided in Section 11-35-310(13). Both protests and notices of intent to protest must be in writing and must be received by the appropriate Chief Procurement Officer within the time provided. See clause entitled "Protest- CPO". The grounds of the protest and the relief requested must be set forth with enough particularity to give notice of the issues to be decided.

**PROHIBITION AGAINST CONFLICTS OF INTERESTS, GRATUITIES AND KICKBACKS:** "Any employee or any official of the school District, elective or appointive, who shall take, receive or offer to take or receive either directly or indirectly, any rebate, percentage of contract, money or other things of value, as an inducement or intended inducement, in the procurement of business, or the giving of business, for, or to, or from, any person, partnership, firm of corporation, offering, bidding for, or in open market seeking to make sales to the school District shall be deemed guilty of a felony and upon conviction such person or persons shall be subject to punishment or a fine in accord with State and/or Federal laws."

**PROHIBITED COMMUNICATIONS AND DONATIONS:** Violation of these restrictions may result in disqualification of your offer, suspension or debarment, and may constitute a violation of law. (a) During the period between publication of the solicitation and final award, you must not communicate, directly or indirectly, with the with District or its employees, agents or officials regarding any aspect of this procurement activity, unless otherwise approved in writing by the Procurement Officer. (b) You are advised to familiarize yourself with Regulation 19-445.2165, which restricts donation to a governmental entity with whom you have or seek to have a contract. You represent that your offer discloses any gifts made, directly or through an intermediary, by you or your named subcontractors to or for the benefit of the District during the period beginning eighteen months prior to the Opening Date.

**PUBLIC OPENING:** Offers will be publicly opened at the date/time and at the location identified on the Cover Page, or last Amendment, whichever is applicable.

QUESTIONS FROM OFFERORS: (a) Any prospective Offeror desiring an explanation or interpretation of the solicitation, drawings, specifications, etc., must request it in writing. Questions must be received by the Procurement Officer no later than five (5) days prior to opening unless otherwise stated on the Cover Page. Label any communication regarding your questions with the name of the procurement officer, and the solicitation's title and number. Oral explanations or instructions will not be binding. Any information given a prospective Offeror concerning a solicitation will be furnished promptly to all other prospective Offerors as an Amendment to the

solicitation, if that information is necessary for submitting offers or if the lack of it would be prejudicial to other prospective Offerors. We will not identify you in our answer to your question. (b) The District seeks to permit maximum practicable competition. Offerors are urged to advise the Procurement Officer -- as soon as possible -- regarding any aspect of this procurement, including any aspect of the Solicitation, that unnecessarily or inappropriately limits full and open competition.

Email is the preferred method for submitting with "Questions: Solicitation # as the subject of the email."

**REJECTION/CANCELLATION:** The District may cancel this solicitation in whole or in part. The District may reject any or all proposals in whole or in part.

**RESPONSIVENESS/IMPROPER OFFERS:** (a) Bid as Specified. Offers for supplies or services other than those specified will not be considered unless authorized by the Solicitation.

- (b) Multiple Offers. Offerors may submit more than one Offer, provided that each Offer has significant differences other than price. Each separate Offer must satisfy all Solicitation requirements. If this solicitation is an Invitation for Bids, each separate offer must be submitted as a separate document. If this solicitation is a Request for Proposals, multiple offers may be submitted as one document, provided that you clearly differentiate between each offer and you submit a separate cost proposal for each offer, if applicable.
- (c) Responsiveness. Any Offer which fails to conform to the material requirements of the Solicitation may be rejected as nonresponsive. Offers which impose conditions that modify material requirements of the Solicitation may be rejected. If a fixed price is required, an Offer will be rejected if the total possible cost to the District cannot be determined. Offerors will not be given an opportunity to correct any material nonconformity. Any deficiency resulting from a minor informality may be cured or waived at the sole discretion of the Procurement Officer.
- (d) Price Reasonableness: Any offer may be rejected if the Procurement Officer determines in writing that it is unreasonable as to price.
- (e) Unbalanced Bidding. The District may reject an Offer as nonresponsive if the prices bid are materially unbalanced between line items or subline items. A bid is materially unbalanced when it is based on prices significantly less than cost for some work and prices which are significantly overstated in relation to cost for other work, and if there is a reasonable doubt that the bid will result in the lowest overall cost to the District even though it may be the low evaluated bid, or if it is so unbalanced as to be tantamount to allowing an advance payment.

SIGNING YOUR OFFER: Every Offer must be signed by an individual with actual authority to bind the Offer. (a) If the Offeror is an individual, the Offer must be signed by that individual. If the Offeror is an individual doing business as a firm, the Offer must be submitted in the firm name, signed by the individual, and state that the individual is doing business as a firm. (b) If the Offeror is a partnership, the Offer must be submitted in the partnership name, followed by the words by its Partner, and signed by a general partner. (c) If the Offeror is a corporation, the Offer must be submitted in the corporate name, followed by the signature and title of the person authorized to sign. (d) An Offer may be submitted by a joint venture involving any combination of individuals, partnerships, or corporations. #### III. SCOPE OF WORK / SPECIFICATIONS

School District Five of Lexington and Richland Counties is soliciting proposals from qualified and experienced firms to provide District-wide professional grounds and detention pond maintenance services complying with the enclosed description and/or specifications and conditions.

Grounds maintenance services will be provided at twenty-two schools and four administrative offices. The maintenance services shall include, but are not limited, to the following:

- Mowing, edging, string trimming, blowing, shrubbery and tree maintenance.
- Servicing pine straw and mulch.
- Exterior pest control.
- Fertilization of turf, trees, and shrubbery.
- Weed control
- Mowing and maintaining vegetation on slopes.

Detention pond maintenance services will be provided at seventeen schools. The detention pond maintenance services shall include, but are not limited to, the following:

- Mowing of vegetation.
- Removing vegetation and debris.
- Making necessary repairs to eroded areas when required.
- Repairing inlet heads.
- Checking dams and outlet structures, to include but not be limited to: damage, sediment accumulation, and to ensure that inlet and outlet devices are free of debris and operational.
- Ensuring that the ponds dewater completely.
- Ensuring ponds are inspected annually

Aerial photos are provided to reference the limits of school boundaries, the locations of detention/retention ponds, slopes, and curb appeal areas. They are not intended to be exact measurements or location of boundaries and features.

Bidders are required to conduct site visits and to have taken into consideration all conditions which might affect the work prior to submitting a bid. No consideration will be given to any claim based on lack of knowledge of existing conditions. Visitors to the schools are required to sign in and out at the main office prior to walking the campus. A site visit log is included in this solicitation and must be returned with the bid.

#### GENERAL INFORMATION

School District Five of Lexington and Richland Counties encompasses an area of approximately 196 square miles, approximately one-half of which is situated in both Lexington and Richland Counties. The School District consists of the northern portion of Lexington County north of Lake Murray and the Saluda River and the northwestern portion of Richland County south of the Broad River. The School District is primarily a residential suburb located to the northwest of the city of Columbia, the capital city of South Carolina. The District has a student population of approximately 17,505 and 2,600 staff members. The District currently operates a total of 13 elementary schools, 2 intermediate schools, 3 middle schools, 4 high schools, 1 Center for Advanced Technical Studies and 1 alternative school. #### **MEETINGS**

The District will schedule a minimum of one (1) meeting per calendar year with the Contractor(s) to ensure that the contract complies with all terms and conditions of the contract by both parties. Either party may schedule additional meetings as the need arises. The meetings will be scheduled with a letter or email to the affected parties, to include required participants and agenda.

Standard of Performance: Contractor must begin and complete the performance of the work required under the contract with all due diligence and must exercise the highest degree of professional skill, confidentiality, and

competence in the performance of the services described herein. All services required of Contractor(s) must be performed to the satisfaction and approval of the District Representative.

#### **Contractor Employee Policy:**

- 1. The Contractor agrees to be responsible for and provide general supervision of all employees working under this contract. Whenever any employee is working, there shall be a designated supervisor on-site directing his/her work.
- 2. The Contractor shall enforce strict discipline and good order among the Contractor's employees and other persons carrying out the Contract. The Contractor shall not permit employment of unfit persons or persons not skilled in tasks assigned to them.
- 3. The Contractor shall have all their employees wear a distinctive uniform provided by the contractor containing the firm's name at all times while on District property.
- 4. **BACKGROUND CHECKS** The vendor and all representatives of the vendor must have an acceptable background check to enter school property. At a minimum, the Offeror shall obtain a complete South Carolina statewide criminal background investigation and a National Sex Offender Registry check for all individuals and employees performing work or services for Offeror or any other entities such as subcontractors who will perform work on this contract. Any individual that is registered as a sex offender will not be permitted on school property. All costs associated with these criminal background checks are the responsibility of the offeror. The District reserves the right to request a copy of SLED checks on any representatives of the contractor who will be on District property. The District reserves the right to deny access to any employee, contractor or person caused to be present on District property by the vendor/contractor. Removal of employees on this basis shall not disrupt the project schedule or cost. The successful contractor shall provide background reports to the District.
- 5. The Contractor shall not allow any employees with a criminal record to enter onto or work on District property without written permission of the District.
- 6. The Contractor shall provide the names of all employees working on District property.
- 7. All employees of the Contractor shall comply with the Districts smoke-free regulations. The District provides a smoke and tobacco free environment for its staff, students and the general public. No tobacco products are permitted in any building or on the grounds of any District building.
- 8. The use or possession of alcoholic beverages or non-prescribed drugs will not be permitted on District premises. Contractor's employees who report for work showing evidence of any impaired condition will not be permitted to remain on the premises of the District.
- 9. No knives, firearms or other weapons are allowed on District property.
- 10. Employees shall report any property damage to their supervisor immediately. The supervisor shall report such damage in writing within 24 hours to the Facilities Supervisor and the District Representative specifying the location and extent of the damage. Failure to report such damage, as required, may be construed as default of the contract. Upon investigation of the incident, the District Representative shall determine if the contactor is at fault.
- 11. Employees, through their supervisor, will be expected to honor reasonable requests from the Facilities Supervisor or District Representative in preparation of special events or activities.
- 12. Employees shall not engage in idle or unnecessary conversation with District employees, other employees of the contractor, students, or visitors to the building and/or campus.
- 13. Employees shall not remove any article or material from the premises, regardless of its value. This includes the contents of trash containers and items on or around the premises. Items deemed as trash are to be placed in dumpsters or trash cans designated for that purpose.
- 14. Employees shall abide by all rules, regulations, and board policies while conducting business on District property.
- 15. The Contractor's supervisor(s) must possess the ability to communicate professionally and effectively, both orally and written, with the school staff and other employees. The supervisor shall make contact on a regular basis with the Facilities Supervisor and District Representative to ensure adequate communication concerning the contract. He/she is responsible for reporting maintenance problems as they arise as well as other problems of mutual concern.
- 16. Contractor's employees shall not use any part of the building and/or grounds other than for purposes expressly stated in the solicitation.

The District reserves the right to request that any employee of the Contractor who fails to abide by the District's rules, regulations, expectations, and board policies to be removed from the job and replaced, upon written request of the

District Representative to the contractor.

#### **SPECIFICATIONS**

#### LOT 1- GROUNDS, SHRUBBERY, TREE AND BED MAINTENANCE

#### A. GROUNDS MAINTENANCE

#### General

- 1. Turf areas (excluding athletic fields and practice fields)
  - a. Mowed to a height between 2" 2 ½"
  - b. String trimmed
  - c. Sidewalks and curbs edged
  - d. Sidewalks and curbs blown of debris
  - e. Active ant mounds treated during each visit
- 2. The District shall be responsible for removing trash, paper, bottles, cans, etc., prior to mowing. However, the Contractor is expected to pick up trash from time to time while mowing rather than mowing over or around it. If the Contractor mows over any trash, the Contractor will be required to clean up the trash. The Contractor shall inform the District Representative of any problems with excessive amounts of trash on District properties.
- 3. All tree and shrubbery debris shall be removed from District property unless otherwise approved in writing by the District Representative.
- 4. All chain link fence and buildings/structures shall be string trimmed. Use of herbicide to kill vegetation in these areas requires approval in writing by the District Representative.
- 5. Rotary cutters "bush hogging" shall be permitted at locations as deemed practical and approved in writing by the District Representative prior to their use.
- 6. Any location that cannot be maintained with a rotary motor where soil sterilant/weed killer is not permitted shall be maintained by the use of string trimmers or other methods as approved by the District Representative. This includes areas of fence lines, pond dams and slopes.
- 7. All fixtures located on District property, flagpoles, tennis courts, playground equipment, fences, transformers, etc., shall be string trimmed or edged as appropriate.
- 8. Plant growth regulator (PGR) may be used only when approved in writing by the District Representative.
- 9. When necessary, the Contractor shall place appropriate signage to warn students, staff and the general public of chemical applications. The Contactor shall notify, in writing, the Facilities Supervisor and District Representative when chemical applications have been made.

### **Athletic Areas**

Areas surrounding athletic areas to be maintained by this contract are:

- 1. Bleacher and seating areas.
- 2. Athletic field fence exterior.
- 3. Common areas.
- 4. Areas around concession stands and around baseball and softball fields.
- 5. Areas within stadiums that have landscaping or grass are to be serviced as specified with the regular ground's maintenance services.

#### **Curb Appeal Areas**

Curb appeal areas are defined as the front of the main campus including driveways, parking lots, main drives/entrances and car pool pick-up and drop-off staging areas. Areas are highlighted with the color green on the aerial photos.

- 1. The Contractor shall keep all sidewalks, curbs and gutters clean of debris during each visit.
- 2. Active ant mounds shall be treated during each visit.
- 3. Curbs shall be edged during each visit.
- 4. Weeds growing through asphalt or concrete curbs, gutters, sidewalks, parking lots, and driveways shall be string trimmed and treated with an herbicide during each visit.

#### **Campus Wide**

- 1. All campuses shall be serviced within every seven (7) calendar days throughout the contract term.
- 2. Leaf and debris clean-up during the fall and winter months shall be performed during the weekly service.
- 3. Each high school campus that hosts home football games shall be serviced on Thursday during football season.
- 4. All sidewalks and curbs shall be edged using equipment designed specifically for edging (string trimming shall not be used to edge) in conjunction with mowing to provide a well-groomed appearance.
- 5. All buildings/structures, fences, trees, shrub beds, etc. shall be trimmed with a string trimmer. Use of PGR is not permitted around building and structures without written approval by the District Representative.
- 6. All fallen or broken tree limbs and debris (large or small) shall be removed at time of service. Removal shall not to exceed seven (7) calendar days.
- 7. All curbs and gutters shall be cleaned of debris including soils and gravel during each service. Soil and gravel shall be removed from the affected area and disposed of on-site at a location approved by the Field Supervisor or District Representative.
- 8. Catch basin openings and grate tops shall be cleaned of debris during each service.
- 9. Contractor shall control fire ants using TopChoice or approved alternate. The treatment shall be applied in March/April. The Contractor shall apply two pounds of TopChoice per one thousand square feet of turf area. Active ant mounds shall be treated during each service and when requested by the Field Supervisor or District Representative with a fast-acting product that achieves immediate results. Requests for treatments shall be responded to within twenty-four (24) hours of the request. The applicator shall control operations in such a manner so as not to expose students, staff, and the general public to the chemicals
- 10. Insect and disease control shall be administered to turf and outside trash receptacles on an as-needed basis and when requested.
- 11. Contractor shall string-trim and treat with herbicide all vegetation growing in/through asphalt, cracks, concrete joints, curbs, driveways and parking lots during each visit. This includes common areas and seating areas within stadiums and athletic facilities.

#### Slopes and Banks Areas (Refer to aerial photograph/drawings for specific locations)

- 1. All drainage ditches and slopes shall be maintained as a part of this contract.
- 2. All slopes, banks, and drainage ditches shall be maintained in January, April, July, and October. Vegetation shall be cut to a height of six (6") inches. Volunteer woody material, sapling trees, and brush shall be cut to ground level and removed.

#### Playground Areas

- 1. Contractor shall scrape, clean and remove any growth of mold or fungus from all wood mulched playground fall surface areas as needed during each service.
- 2. Dangerous items such as broken glass, sharp objects, etc., shall be removed by the Contractor during each service and the contractor shall notify the Facility Supervisor and the District Representative in writing when items are found.
- 3. Contractor shall maintain certified wood mulch fall surfaces within playground areas throughout the year in accordance with the latest ASTM and IPEMA standards. The Contractor shall add the appropriate amount of certified wood mulch during the contract period and maintain a minimum depth of nine (9") inches.
- 4. Contractor shall replenish sandboxes when requested.

#### **School Opening Preparations**

- 1. Four (4) weeks prior to school opening, the contractor shall provide a schedule to the DR listing all activities that will be performed at each campus.
- 2. All sites must be moved within five (5) calendar days of school opening.
- 3. The Contactor shall treat all active ant mounds at each campus/office twenty (20) days prior to the opening of a new school-year.
- 4. All areas that contain wood mulch as the fall surface shall have the mulch removed and replaced annually using certified wood. Mulch shall be evenly distributed. The Contractor shall install and maintain the fall

surface to comply with ASTM and IPEMA (latest specifications) for playground fall surfaces. All areas shall be serviced and mulch added per ASTM and IPEMA (latest specifications) twenty (20) days prior to the opening of school. Contractor shall maintain wood mulch fall surface throughout the year to comply with ASTM and IPEMA (latest specifications) for fall surface. The Contractor shall dispose of material off of District property.

- 5. New pine straw and mulch shall be placed in shrubbery and plant beds and around trees forty-five (45) days prior to school opening. Hardwood mulch shall be added to existing mulched areas to a depth of one-half to three-quarters of an inch.
- 6. Contractor shall provide a quick response crew during the month of August to respond to requests made by the District Representative. Requests shall be addressed within twenty-four hours.

#### **Service Schedules for Grounds Maintenance:**

- 1. Contractor shall furnish the District Representative in writing with the following schedules at the beginning of each month:
  - a. Schedule of weekly services, shown on a monthly basis for each site. (Rain-outs shall be shown as make-up during weekends.)
  - b. Specific chemical applications by location.
  - c. Shrubbery trimming.
  - d. Tree pruning.
  - e. Slope maintenance.
  - f. Pine straw and mulch installation.
  - g. Playground mulch maintenance and mulch applications.
  - h. Treatments for ant control.
- 2. Contractor shall adjust their service schedule to accommodate special requests for services based on special events at schools or offices. When possible, the District will provide advanced notice for such events.
- 3. During times of testing, the Contractor shall adjust his/her schedule so that service doesn't occur while students are testing. The majority of testing takes place in the month of May. Elementary schools may only be serviced after 12:00 pm on days when students are testing.
- 4. Testing will take precedence over service. Testing schedules do not relieve the contractor of their obligation to service campuses on their appointed day.

#### B. SHRUBBERY, TREE AND BED MAINTENANCE

#### **Shrubbery Maintenance**

- 1. All shrubbery will be trimmed in April, July, and October. The Contractor shall provide a pruning schedule to the District Representative.
- 2. Contractor shall also prune shrubs when requested in addition to the pruning schedule to provide a well-groomed appearance and to maintain CPTED standards as well as desired height and spread of shrubs.
- 3. For safety reasons, all shrubs around buildings and windows shall be maintained at a height of not more than three (3) feet from the window in vertical or horizontal direction. Contractor shall also trim the back side of the shrubs to one foot off of the building or structure to maintain a walk area between the shrub and building or structure.
- 4. Contractor shall perform structural pruning on all shrubs at least once per year. Appropriate pruning techniques shall be performed based on the type of shrub or plant.
- 5. Contractor shall fertilize shrubs in the spring with good quality 16-4-8 ( $N^2$ ) 50% slow release fertilizer or other appropriate fertilizer.
- 6. Contractor shall treat shrubs for insects and disease when needed. The Contractor's applicator shall conduct spray operations in such a manner so as not to expose students, staff or the general public to exposure of chemicals. No treatment is allowed around buildings when students and staff occupy the building.
- 7. The Contractor shall remove shrubbery debris and tree debris from beds and around trees after pruning has occurred. The Contractor shall dispose of debris off-site unless approved by the District Representative.

#### **Bedding Material and Bed Maintenance**

- 1. Pine straw shall be fluffed during each visit and mulch shall be turned once every 3 months.
- 2. Installation of new pine straw and mulch shall take place in February and again in July.

- 3. Vendor shall use a good quality, long leaf pine straw or hard wood mulch. Mulch selection and color will be determined by location prior to application.
- 4. Bedding material, whether pine straw or mulch, shall be replaced per the schedule and when requested to maintain a good appearance.
- 5. Contractor shall completely remove all bedding material from tree rings, plant beds and areas containing mulch or pine straw two (2) times during the five-year term. The initial removal will take place during the first contract term. The second removal shall take place in year number four (4) of the contract term if the contract is renewed. All bedding material shall be removed from District property. Removal shall be coordinated with the installation schedule for mulch and straw.
- 6. Contractor shall utilize a bed shaping machine to define all bed areas once per calendar year.
- 7. Contractor shall use edging equipment with a metal blade to maintain a distinct bed line between lawn and bed areas. The contractor shall edge the bed line/grass line during each visit to prevent grass from encroaching into the bed. Contractor shall not use a string trimmer or herbicide to edge the beds.
- 8. The contractor shall maintain weed-free tree rings, flower beds, shrubs beds, as well as any areas that contain mulch or pine straw campus wide during each service.
- 9. Particular attention shall be given to curb appeal areas which are highlighted with the color green on the aerial photographs/drawings.
- 10. Insect and disease control shall be administered to shrubbery on an as -needed basis and when requested.

#### **Tree Maintenance**

- 1. Contractor shall maintain large trees along drives and in parking areas by pruning low hanging limbs to a height no lower than twelve (12) feet. Contractor shall maintain all other tree limbs above a 7 ft. height and to Crime Prevention Through Environmental Design (CPETD) standards.
- 2. New growth "suckers" growing near the base of trees shall be removed/pruned during each visit.
- 3. Contractor shall prune tree limbs that overhang or obstruct cameras and structures or that are within 3 feet of building walls and roofs to prevent contact with walls, roofs, and structures.
- 4. Contractor shall provide structural pruning to trees once per year, preferably in the winter months when trees are dormant.
- 5. All pruning material shall be removed from District property.
- 6. Contractor shall follow the same straw/mulch schedule as specified in bed maintenance around all trees.
- 7. Insect and disease control shall be administered to trees on an as-needed basis and when requested.

#### **LOT 2- DETENTION POND MAINTENANCE**

#### **Detention Pond Maintenance**

- 1. All detention ponds, slopes, banks and drainage ditches shall be mowed in April, July, and October. Vegetation shall be cut to a height of six (6) inches. Volunteer woody material, sapling trees, cattails, and brush shall be cut to ground level and removed from the pond and district property.
- 2. When grassed areas are wet or saturated with water so that mowing cannot be done without damaging the vegetation, then mowing shall be postponed. Any damage to the vegetation caused by mowing during wet conditions will be repaired at Contractor's expense.
- 3. Contractor shall mow all vegetation and remove trees within the pond per the scope shown in the contract documents to include but not limited to any outfall structures, rip-rap berms, check dams, sediment forebays, along fences or other structures associated with the detention pond.
- 4. Dead trees, volunteer sapling trees, cattails and excess clippings of vegetation shall be removed from the pond and disposed of off-site at the Contractor's expense.
- 5. The Contractor is responsible having each pond inspected annually by an inspector licensed by the South Carolina Department of Health and Environmental Services. A copy of the inspection report can be found in Attachment H of the solicitation document.
- 6. The Contractor shall be responsible for acquiring all permits and or business licenses required by local and/or state agencies and municipalities. The expense for all permits shall be incurred by the contractor.

**DISCUSSIONS AND NEGOTIATIONS – OPTIONAL:** Submit your best terms from both a price and a technical standpoint. Your proposal may be evaluated and your offer accepted without any discussions, negotiations, or prior notice. Ordinarily, nonresponsive proposals will be rejected outright without prior notice. Nevertheless, the District may elect to conduct discussions, including the possibility of limited proposal revisions, but only for those proposals reasonably susceptible of being selected for award. If improper revisions are submitted during discussions, the District may elect to consider only your unrevised initial proposal, provided your initial offer is responsive. The District may also elect to conduct negotiations, beginning with the highest ranked offeror, or seek best and final offers. Negotiations may involve both price and matters affecting the scope of the contract, so long as changes are within the general scope of the request for proposals. #### VII. TERMS AND CONDITIONS - A. GENERAL

#### ASSIGNMENT, NOVATION, AND CHANGE OF NAME, IDENTITY, OR STRUCTURE:

(a) Contractor shall not assign this contract, or its rights, obligations, or any other interest arising from this contract, or delegate any of its performance obligations, without the express written consent of the responsible procurement officer. The foregoing restriction does not apply to a transfer that occurs by operation of law (e.g., bankruptcy; corporate reorganizations and consolidations, but not including partial asset sales). Notwithstanding the foregoing, contractor may assign monies receivable under the contract provided that the District shall have no obligation to make payment to an assignee until thirty days after contractor (not the assignee) has provided the responsible procurement officer with (i) proof of the assignment, (ii) the identity (by contract number) of the specific District contract to which

the assignment applies, and (iii) the name of the assignee and the exact address or account information to which assigned payments should be made. (b) If contractor amends, modifies, or otherwise changes its name, its identity (including its trade name), or its corporate, partnership or other structure, or its FEIN, contractor shall provide the procurement officer prompt written notice of such change. (c) Any name change, transfer, assignment, or novation is subject to the conditions and approval required by Regulation 19-445.2180, which does not restrict transfers by operation of law.

**BANKRUPTCY - GENERAL:** (a) Notice. In the event the Contractor enters into proceedings relating to bankruptcy, whether voluntary or involuntary, the Contractor agrees to furnish written notification of the bankruptcy to the District. This notification shall be furnished within two (2) days of the initiation of the proceedings relating to the bankruptcy filing. This notification shall include the date on which the bankruptcy petition was filed, the identity of the court in which the bankruptcy petition was filed, and a listing of all State contracts against which final payment has not been made. This obligation remains in effect until final payment under this Contract. (b) Termination. This contract is voidable and subject to immediate termination by the District upon the contractor's insolvency, including the filing of proceedings in bankruptcy.

**CHOICE-OF-LAW:** The Agreement, any dispute, claim, or controversy relating to the Agreement, and all the rights and obligations of the parties shall, in all respects, be interpreted, construed, enforced and governed by and under the laws of the State of South Carolina, except its choice of law rules. As used in this paragraph, the term "Agreement" means any transaction or agreement arising out of, relating to, or contemplated by the solicitation.

CONTRACT DOCUMENTS & ORDER OF PRECEDENCE: (a) Any contract resulting from this solicitation shall consist of the following documents: (1) a Record of Negotiations, if any, executed by you and the Procurement Officer, (2) documentation regarding the clarification of an offer, if applicable, (3) the solicitation, as amended, (4) modifications, if any, to your offer, if accepted by the Procurement Officer, (5) your offer, (6) any statement reflecting the District's final acceptance (a/k/a "award"), and (7) purchase orders. These documents shall be read to be consistent and complimentary. Any conflict among these documents shall be resolved by giving priority to these documents in the order listed above. (b) The terms and conditions of documents (1) through (6) above shall apply notwithstanding any additional or different terms and conditions in either (i) a purchase order or other instrument submitted by the District or (ii) any invoice or other document submitted by Contractor. Except as otherwise allowed herein, the terms and conditions of all such documents shall be void and of no effect. (c) No contract, license, or other agreement containing contractual terms and conditions will be signed by the District. Any document signed or otherwise agreed to by persons other than the Procurement Officer or designee shall be void and of no effect.

**DISCOUNT FOR PROMPT PAYMENT**: (a) Discounts for prompt payment will not be considered in the evaluation of offers. However, any offered discount will form a part of the award, and will be taken if payment is made within the discount period indicated in the offer by the Offeror. As an alternative to offering a discount for prompt payment in conjunction with the offer, Offerors awarded contracts may include discounts for prompt payment on individual invoices. (b) In connection with any discount offered for prompt payment, time shall be computed from the date of the invoice. If the Contractor has not placed a date on the invoice, the due date shall be calculated from the date the designated billing office receives a proper invoice, provided the District annotates such invoice with the date of receipt at the time of receipt. For the purpose of computing the discount earned, payment shall be considered to have been made on the date that appears on the payment check or, for an electronic funds transfer, the specified payment date. When the discount date falls on a Saturday, Sunday, or a legal holiday when Federal Government offices are closed and Government business is not expected to be conducted, payment may be made on the following business day.

**DISPUTES:** (1) Choice-of-Forum. All disputes, claims, or controversies relating to the Agreement shall be resolved exclusively by the appropriate Chief Procurement Officer in accordance with Title 11, Chapter 35, Article 17 of the South Carolina Code of Laws, or in the absence of jurisdiction, only in the Court of Common Pleas for, or a federal court located in, Richland County, State of South Carolina. Contractor agrees that any act by the government regarding the Agreement is not a waiver of either the government's sovereign immunity or the government's immunity under the Eleventh Amendment of the United States Constitution. As used in this paragraph, the term "Agreement" means any transaction or agreement arising out of, relating to, or contemplated by the solicitation. (2) Service of Process. Contractor consents that any papers, notices, or process necessary or proper for the initiation or continuation of any disputes, claims, or controversies relating to the Agreement; for any court action in connection therewith; or for the

entry of judgment on any award made, may be served on Contractor by certified mail (return receipt requested) addressed to Contractor at the address provided as the Notice Address on Page Two or by personal service or by any other manner that is permitted by law, in or outside South Carolina. Notice by certified mail is deemed duly given upon deposit in the United States mail.

**EQUAL OPPORTUNITY:** Contractor is referred to and shall comply with all applicable provisions, if any, of Title 41, Part 60 of the Code of Federal Regulations, including but not limited to Sections 60-1.4, 60-4.2, 60-4.3, 60-250.5(a), and 60-741.5(a), which are hereby incorporated by reference.

**FALSE CLAIMS:** According to the S.C. Code of Laws § 16-13-240, "a person who by false pretense or representation obtains the signature of a person to a written instrument or obtains from another person any chattel, money, valuable security, or other property, real or personal, with intent to cheat and defraud a person of that property is guilty" of a crime.

**FIXED PRICING REQUIRED**: Any pricing provided by contractor shall include all costs for performing the work associated with that price. Contractor's price shall be fixed for the duration of this contract, including option terms, except as otherwise provided in this solicitation. This clause does not prohibit contractor from offering lower pricing after award.

**NO INDEMNITY OR DEFENSE:** Any term or condition is void to the extent it requires the District to indemnify, defend, or pay attorney's fees to anyone for any reason.

**NOTICE:** (A) After award, any notices shall be in writing and shall be deemed duly given (1) upon actual delivery, if delivery is by hand, (2) upon receipt by the transmitting party of automated confirmation or answer back from the recipient's device if delivery is by telex, telegram, facsimile, or electronic mail, or (3) upon deposit into the United States mail, if postage is prepaid, a return receipt is requested, and either registered or certified mail is used. (B) Notice to contractor shall be to the address identified on Cover Page. Notice to the District shall be to the Procurement Officer's address on the Cover Page. Either party may designate a different address for notice by giving notice in accordance with this paragraph.

**OPEN TRADE:** During the contract term, including any renewals or extensions, Contractor will not engage in the boycott of a person or an entity based in or doing business with a jurisdiction with whom South Carolina can enjoy open trade, as defined in SC Code Section 11-35-5300.

**PUBLICITY**: Contractor shall not publish any comments or quotes from District employees, or include the District in either news releases or a published list of customers, without the prior written approval of the Procurement Officer.

**PURCHASE ORDERS:** Contractor shall not perform any work prior to the receipt of a purchase order from the District. The District shall order any supplies or services to be furnished under this contract by issuing a purchase order. Purchase orders may be used to elect any options available under this contract, e.g., quantity, item, delivery date, payment method, but are subject to all terms and conditions of this contract. Purchase orders may be electronic. No particular form is required. An order placed pursuant to the purchasing card provision qualifies as a purchase order. Purchase order number must be clearly stated on each carton or package, shipping ticket, invoice and any/all other information related to the order.

**SURVIVAL OF OBLIGATIONS:** The Parties' rights and obligations which, by their nature, would continue beyond the termination, cancellation, rejection, or expiration of this contract shall survive such termination, cancellation, rejection, or expiration, including, but not limited to, the rights and obligations created by the following clauses: Indemnification - Third Party Claims, Intellectual Property Indemnification, and any provisions regarding warranty or audit.

**SWMBE PARTICIPATION**: District Five of Lexington and Richland Counties encourages SWMBE businesses to participate in the Solicitation process. All business conducted with SWMBE businesses certified by the South Carolina Governor's Office of Small and Minority Business Assistance is recorded in an annual report submitted to the Board of Trustees. In order to be included in this report, you must submit a copy of your certificate with your bid.

TAXES: Any tax the contractor may be required to collect or pay upon the sale, use or delivery of the products shall be paid by the District, and such sums shall be due and payable to the contractor upon acceptance. Any personal property taxes levied after delivery shall be paid by the District. It shall be solely the District's obligation, after payment to contractor, to challenge the applicability of any tax by negotiation with, or action against, the taxing authority. Contractor agrees to refund any tax collected, which is subsequently determined not to be proper and for which a refund has been paid to contractor by the taxing authority. In the event that the contractor fails to pay, or delays in paying, to any taxing authorities, sums paid by the District to contractor, contractor shall be liable to the District for any loss (such as the assessment of additional interest) caused by virtue of this failure or delay. Taxes based on Contractor's net income or assets shall be the sole responsibility of the contractor.

**TERMINATION:** Subject to the conditions below, the District, providing a (30) thirty-day advance written notice is given to the vendor, may terminate the contract for any reason.

NON-APPROPRIATIONS: Any contract entered into by the District resulting from this bid invitation shall be subject to cancellation without damages or further obligation when funds are not appropriated or otherwise made available to support continuation of performance in a subsequent fiscal period or appropriated year.

FOR CONVENIENCE: In the event that this contract is terminated or canceled upon request and for the convenience of the District without the required thirty (30) days advance written notice, then the District may negotiate reasonable termination costs, if applicable.

FOR CAUSE: Termination by the District for cause, default or negligence on the part of the vendor shall be excluded from the foregoing conditions; termination costs, if any, shall not apply. The thirty (30) days advance notice requirement is waived and the default clause in this bid shall apply.

DEFAULT: In case of default by the vendor, the District reserves the right to purchase any or all items in default in the open market, charging the vendor with any additional costs. The defaulting vendor shall not be considered a responsible bidder until the assessed charge has been satisfied.

**TERMINATION DUE TO UNAVAILABILITY OF FUNDS:** Payment and performance obligations for succeeding fiscal periods shall be subject to the availability and appropriation of funds therefore. When funds are not appropriated or otherwise made available to support continuation of performance in a subsequent fiscal period, the contract shall be canceled. In the event of a cancellation pursuant to this paragraph, contractor will be reimbursed the resulting unamortized, reasonably incurred, nonrecurring costs. Contractor will not be reimbursed any costs amortized beyond the initial contract term.

**THIRD PARTY BENEFICIARY**: This Contract is made solely and specifically among and for the benefit of the parties hereto, and their respective successors and assigns, and no other person will have any rights, interest, or claims hereunder or be entitled to any benefits under or on account of this Contract as a third-party beneficiary or otherwise.

**WAIVER:** The District does not waive any prior or subsequent breach of the terms of the Contract by making payments on the Contract, by failing to terminate the Contract for lack of performance, or by failing to strictly or promptly insist upon any term of the Contract. Only the Procurement Officer has actual authority to waive any of District's rights under this Contract. Any waiver must be in writing.

#### VII. TERMS AND CONDITIONS – B. SPECIAL

- 1. This solicitation does not commit the District to award a contract for products or services or to pay any costs incurred in the preparation of a proposal or any pre-contract expense. The District reserves the right to accept or reject any of all proposals received as a result of this request, or to cancel in part or in its entirety, this request for proposal, without liability whatsoever, if it is in the best interest of the District to do so or if funding is not available.
- 2. The Contractor shall be licensed by the State of South Carolina to apply all chemicals used in conjunction with this solicitation. The Contractor must include a copy of their license with their bid. The Contractor shall maintain records of all chemical applications and comply with all local, state, and federal laws relating to chemical applications.
- 3. The successful contractor shall have an adequate workforce of skilled work persons, supply all equipment, materials and supplies necessary to comply with the specifications of the contract. This includes, but is not limited to, all fertilizers, herbicides, pesticides, certified wood mulch used for fall surfaces on playgrounds, hardwood and cedar mulch, pine straw, and sand used in sandboxes.
- 4. All employees shall be thoroughly experienced in the particular trade or class in which they are employed. All work shall be done according to the specifications covering the class or type of work and shall meet the approval, in the field, of the District Representative.
- 5. Contractor's personnel must wear an identification badge as approved by the District and shall utilize the procedures authorized by the District to obtain access to District buildings.
- 6. Contractor shall provide service tickets for each location at the time of service. The service ticket will provide detailed information of the services performed along with a start and completion time stamp. Tickets shall be signed by a designee at each location. Service tickets shall be provided to the District Representative at the end of each month.
- 7. Playgrounds, commons areas, and student activity areas shall be maintained at times when there is no threat to the safety of students or personnel and shall be coordinated with the Field Supervisor at each location.
- 8. All tree and shrubbery debris shall be removed from District property unless otherwise approved in writing by the District Representative.
- 9. The specifications cover provisions for grounds maintenance service, including all reasonable and necessary labor, supervision, equipment, materials and supplies to provide well-groomed, presentable grounds.
- 10. Submitted prices shall be all inclusive. The District will not honor any hidden costs that may be invoiced at a later date related to items in this solicitation.
- 11. The contractor shall maintain on file, all Safety Data Sheets for all chemicals used on District property. When requested, the contractor will provide copies to the District Representative.
- 12. All chemicals used on District property shall be approved by the manufacturer for use on school grounds.
- 13. All equipment used on this project shall meet OSHA standards for safety and all other local, state, and federal laws and/or regulations that may pertain to this solicitation.
- 14. All noise reduction devices, as designed by the original equipment manufacturer, shall be maintained in good working order on all equipment to minimize noise during school hours.
- 15. Equipment shall not be stored, housed or left on District property, or left unattended without prior approval from the District Representative.
- 16. The Contractor shall be responsible for providing the proper training for all of their employees regarding the proper handling of equipment and the application of chemical substances. Damages resulting from the improper use of equipment, application or use of chemical substances will be the responsibility of the contractor. Additionally, the Contractor is responsible for providing for all training and certification for his/her employees as required by AHERA, DHEC, OSHA, EPA regulations, and all local, state, and federal requirements.
- 17. All licenses or permits required to operate in any location utilized in this contract shall be the responsibility of the Contractor.
- 18. The Contractor shall be familiar with and in complete compliance with, OSHA, AHERA, DHEC, and EPA requirements and shall report any loss time or major injuries to the District.
- 19. Contractor's employees shall report any property damage to their supervisor immediately. The supervisor shall report such damage in writing within 24 hours to the District Representative specifying the location and extent of the damage. Failure to report such damage, as required, may be construed as default of the

- contract. Upon investigation of the incident, the District Representative shall determine if the contactor is at fault.
- 20. The District will furnish keys and the Contractor shall not have additional keys duplicated. If additional keys are needed, a request will be made to the District Representative. Upon termination of the contract, the contractor shall return all keys to the District Representative before the final payment is made.
- 21. The Contractor shall maintain an email account, landline and cellular telephone service that shall be local or toll free to the District.
- 22. The Contractor shall assume liability for damage or loss resulting from the wrongful act(s) and/or negligence of their employees while they are on premises. The Contractor or his insurer shall reimburse the District for any such damage or loss within 30 days after a claim is submitted. For example: windows and glass doors, car windows and windshields. Note: The District Representative will investigate claims of this nature with the authorized contractor's representative for validity.
- 23. The Contractor shall notify the Field Supervisor and the District Representative as soon as possible of any damage or loss, particularly to automobile glass, building windows and storefronts.
- 24. For damages to District windows and glass doors, the Field Supervisor will have the repairs made and the contractor will reimburse the District for the repairs. For damages to automobiles and automotive windows and windshield, the contractor shall deal directly with the owner of the vehicle.
- 25. The District reserves the right to negotiate a fair and reasonable cost with the successful contractor to install new landscaping, replace trees and shrubbery, and other landscaping services that may arise during the contract term.
- 26. The District reserves the right to add additional schools/property to the contract.
- 27. The Contractor shall comply with all laws, ordinances, codes, rules and regulations bearing on the conduct of the work, including those of federal, state and local agencies having jurisdiction. This shall include, but not be limited to minimum wage, labor, and equal employment opportunity laws.
- 28. No subcontracting shall be allowed unless the subcontractor is identified in the bid documents. Note: All subcontractors must be approved in writing by the District prior to commencing on any work under this contract.
- 29. Contractor shall be observant of washouts and safety issues and shall communicate in writing all such details to the Field Supervisor and District Representative.
- 30. Damage to shrubbery and trees caused by vandalism or inclement weather, etc. shall be reported in writing to the Field Supervisor and District Representative. Depending on the extent of damage, contractor may be asked to do structural pruning in an effort to restore the plant/shrub.
- 31. Contractor's vehicles shall have signage that is clearly visible and legible identifying the name of the business.
- 32. Contractor shall refer to contract specifications and document details for definition of the scope of work. Specifications apply to the entire campus/property. It is not the intent of the District for the Contractor to provide weekly service to natural areas, wooded areas, and perimeter fence lines, etc. However, this does not relieve the Contractor of these duties when they are required.
- 33. Missed service as a result of inclement weather shall be made up within two (2) days of the missed service. The Contractor shall maintain the integrity of the schedule to ensure that all campuses are serviced once every seven (7) days during the growing season and once every ten (10) days during the non-growing season.
- 34. When service is missed and not made up during the service cycle at any site for any reason, the cost of the service will be deducted from the monthly invoice. Service cost will be calculated by using the annual cost by site/location and dividing by the number of annual services.
- 35. The Contractor shall exercise precautions at all times for the protection and safety of their employees, school staff, students, and the general public. Barricades will be provided at the contractor's expense when work is performed in areas traversed by persons or vehicles or when deemed necessary by District Five.
- 36. S.C. law requires that contractors awarded contracts in excess of \$5,000 be licensed by the S.C. Contractors Licensing Board if required for the project. The Contractor's S.C. General Contractor's license number must be clearly indicated on the face of the envelope of bids exceeding this amount. Contractors must include a copy of their license(s) with their bid.

**CHANGES:** (1) Contract Modification. By a written order, at any time, and without notice to any surety, the Procurement Officer may, subject to all appropriate adjustments, make changes within the general scope of this contract in any one or more of the following:

- (a) Drawings, designs, or specifications, if the supplies to be furnished are to be specially manufactured for the District in accordance therewith:
- (b) Method of shipment or packing;
- (c) Place of delivery;
- (d) Description of services to be performed;
- (e) Time of performance (i.e., hours of the day, days of the week, etc.); or,
- (f) Place of performance of the services.
- Subparagraphs (a) to (c) apply only if supplies are furnished under this contract. Subparagraphs (d) to (f) apply only if services are performed under this contract.
- (2) Adjustments of Price or Time for Performance. If any such change increases or decreases the contractor's cost of, or the time required for, performance of any part of the work under this contract, whether or not changed by the order, an adjustment shall be made in the contract price, the delivery schedule, or both, and the contract modified in writing accordingly. Any adjustment in contract price made pursuant to this clause shall be determined in accordance with the Price Adjustment Clause of this contract. Failure of the parties to agree to an adjustment shall not excuse the contractor from proceeding with the contract as changed, provided that the District promptly and duly make such provisional adjustments in payment or time for performance as may be reasonable. By proceeding with the work, the contractor shall not be deemed to have prejudiced any claim for additional compensation, or an extension of time for completion. (3) Time Period for Claim. Within 30 days after receipt of a written contract modification under Paragraph (1) of this clause, unless such period is extended by the Procurement Officer in writing, the contractor shall file notice of intent to assert a claim for an adjustment. Later notification shall not bar the contractor's claim unless the District is prejudiced by the delay in notification.
- (4) Claim Barred After Final Payment. No claim by the contractor for an adjustment hereunder shall be allowed if notice is not given prior to final payment under this contract.

**CISG:** The parties expressly agree that the UN Convention on the International Sale of Goods shall not apply to this agreement.

**COMPLIANCE WITH LAWS:** During the term of the contract, contractor shall comply with all applicable provisions of laws, codes, ordinances, rules, regulations, and tariffs

**CONTRACTS:** Every resulting contract is subject to all terms of the District procurement code including limitations as to duration, rights of the District to terminate and means of dispute resolution. No resulting contract is renewable except to the extent provided in the solicitation. No vendor terms take precedence over the solicitation and the District's procurement code.

**CONTRACT LIMITATIONS:** No sales may be made pursuant to this contract for any item or service that is not expressly listed. No sales may be made pursuant to this contract after expiration of this contract. Violation of this provision may result in termination of this contract and may subject contractor to suspension or debarment.

#### **CONTRACTOR'S LIABILITY INSURANCE (GENERAL):**

- (a) Without limiting any of the obligations or liabilities of Contractor, Contractor shall procure from a company or companies lawfully authorized to do business in South Carolina and with a current A.M. Best rating of no less than A: VII, and maintain for the duration of the contract, insurance against claims for injuries to persons or damages to property which may arise from or in connection with the performance of the work and the results of that work by the contractor, his agents, representatives, employees or subcontractors.
- (b) Coverage shall be at least as broad as:
- (1) Commercial General Liability (CGL): Insurance Services Office (ISO) Form CG 00 01 12 07 covering CGL on an "occurrence" basis, including products-completed operations, personal and advertising injury, with limits no less than \$1,000,000 per occurrence. If a general aggregate limit applies, the general aggregate limit shall be twice the required occurrence limit. This contract shall be considered to be an "insured contract" as defined in the policy.
- (2) Auto Liability: ISO Form Number CA 00 01 covering any auto (Code 1), or if Contractor has no owned autos, hired, (Code 8) and non-owned autos (Code 9), with limits no less than \$1,000,000 per accident for bodily injury and property damage.
- (3) Worker's Compensation: As required by the State of South Carolina, with Statutory Limits, and Employer's Liability Insurance with limit of no less than \$1,000,000 per accident for bodily injury or disease.

- (c) The District and its officers, officials, employees and volunteers must be covered as additional insureds on the CGL policy with respect to liability arising out of work or operations performed by or on behalf of the Contractor including materials, parts or equipment furnished in connection with such work or operations. General liability coverage can be provided in the form of an endorsement to the Contractor's insurance at least as broad as ISO Form CG 20 10 11 85 or if not available, through the addition of both CG 20 10 and CG 20 37 if a later edition is used.
- (d) For any claims related to this contract, the Contractor's insurance coverage shall be primary insurance as respects the District and its officers, officials, employees and volunteers. Any insurance or self-insurance maintained by the District and its officers, officials, employees and volunteers shall be excess of the Contractor's insurance and shall not contribute with it.
- (e) Prior to commencement of the work, the Contractor shall furnish the District with original certificates and amendatory endorsements or copies of the applicable policy language effecting coverage required by this section. All certificates are to be received and approved by the District before work commences. However, failure to obtain the required documents prior to the work beginning shall not waive the Contractor's obligation to provide them. The District reserves the right to require complete, certified copies of all required insurance policies, including endorsements required by this section, at any time.
- (f) Should any of the above described policies be cancelled before the expiration date thereof, notice will be delivered in accordance with the policy provisions. In addition, the Contractor shall notify the District immediately upon receiving any information that any of the coverages required by this section are or will be changed, cancelled, or replaced.
- (g) Contractor hereby grants to the District and all of its officers, officials, employees and volunteers a waiver of any right to subrogation which any insurer of said Contractor may acquire against the District by virtue of the payment of any loss under such insurance. Contractor agrees to obtain any endorsement that may be necessary to effect this waiver of subrogation, but this provision applies regardless of whether or not the District has received a waiver of subrogation endorsement from the insurer.
- (h) Any deductibles or self-insured retentions must be declared to and approved by the District. The District may require the Contractor to purchase coverage with a lower deductible or retention or provide proof of ability to pay losses and related investigations, claim administration, and defense expenses within the retention.
- (i) The District reserves the right to modify these requirements, including limits, based on the nature of the risk, prior experience, insurer, coverage, or other special circumstances.

CONTRACTOR PERSONNEL: The Contractor shall enforce strict discipline and good order among the Contractor's employees and other persons carrying out the Contract. Contractor personnel shall present a professional appearance at all times while on District property. Personnel shall be neat, clean, well groomed, properly uniformed, and conduct themselves in a respectable and courteous manner and display proper identification. The Contractor shall not permit employment of unfit persons or persons not skilled in tasks assigned to them. No forms of tobacco products, alcohol, and drugs, guns, knives, or other weapons are allowed on the District's premises. The District reserves the right to prohibit any individual employee of the Contractor from providing services on District property or at District events if the District determines, in its sole discretion, that such employee poses a threat to the safety or well-being of students, District/school personnel, or others.

**CONTRACTOR'S OBLIGATION** – **GENERAL:** The contractor shall provide and pay for all materials, tools, equipment, labor and professional and non-professional services, and shall perform all other acts and supply all other things necessary, to fully and properly perform and complete the work. The contractor must act as the prime contractor and assume full responsibility for any subcontractor's performance. The contractor will be considered the sole point of contact with regard to all situations, including payment of all charges and the meeting of all other requirements.

**CONTRACTOR'S USE OF DISTRICT PROPERTY:** Upon termination of the contract for any reason, the District shall have the right, upon demand, to obtain access to, and possession of, all District properties, including, but not limited to, current copies of all District application programs and necessary documentation, all data, files, intermediate materials and supplies held by the contractor. Contractor shall not use, reproduce, distribute, display, or sell any data, material, or documentation owned exclusively by the District without the District's written consent, except to the extent necessary to carry out the work.

**DEFAULT:** (a)(1) The District may, subject to paragraphs (c) and (d) of this clause, by written notice of default to the Contractor, terminate this contract in whole or in part if the Contractor fails to-

- (i) Deliver the supplies or to perform the services within the time specified in this contract or any extension;
- (ii) Make progress, so as to endanger performance of this contract (but see paragraph (a)(2) of this clause); or
- (iii) Perform any of the other material provisions of this contract (but see paragraph (a)(2) of this clause). (2) The District's right to terminate this contract under subdivisions (a)(1)(ii) and (1)(iii) of this clause, may be exercised if the Contractor does not cure such failure within 10 days (or more if authorized in writing by the Procurement Officer) after receipt of the notice from the Procurement Officer specifying the failure.
- (b) If the District terminates this contract in whole or in part, it may acquire, under the terms and in the manner the Procurement Officer considers appropriate, supplies or services similar to those terminated, and the Contractor will be liable to the District for any excess costs for those supplies or services. However, the Contractor shall continue the work not terminated.
- (c) Except for defaults of subcontractors at any tier, the Contractor shall not be liable for any excess costs if the failure to perform the contract arises from causes beyond the control and without the fault or negligence of the Contractor. Examples of such causes include (1) acts of God or of the public enemy, (2) acts of the State in either its sovereign or contractual capacity, (3) fires, (4) floods, (5) epidemics, (6) quarantine restrictions, (7) strikes, (8) freight embargoes, and (9) unusually severe weather. In each instance the failure to perform must be beyond the control and without the fault or negligence of the Contractor.
- (d) If the failure to perform is caused by the default of a subcontractor at any tier, and if the cause of the default is beyond the control of both the Contractor and subcontractor, and without the fault or negligence of either, the Contractor shall not be liable for any excess costs for failure to perform, unless the subcontracted supplies or services were obtainable from other sources in sufficient time for the Contractor to meet the required delivery schedule.
- (e) If this contract is terminated for default, may require the Contractor to transfer title and deliver to the District, as directed by the Procurement Officer, any (1) completed supplies, and (2) partially completed supplies and materials, parts, tools, dies, jigs, fixtures, plans, drawings, information, and contract rights (collectively referred to as "manufacturing materials" in this clause) that the Contractor has specifically produced or acquired for the terminated portion of this contract. Upon direction of the Procurement Officer, the Contractor shall also protect and preserve property in its possession in which the District has an interest.
- (f) The District shall pay contract price for completed supplies delivered and accepted. The Contractor and Procurement Officer shall agree on the amount of payment for manufacturing materials delivered and accepted and for the protection and preservation of the property; if the parties fail to agree, the Procurement Officer shall set an amount subject to the Contractor's rights under the Disputes clause. Failure to agree will be a dispute under the Disputes clause. The District may withhold from these amounts any sum the Procurement Officer determines to be necessary to protect the District against loss because of outstanding liens or claims of former lien holders.
- (g) If, after termination, it is determined that the Contractor was not in default, or that the default was excusable, the rights and obligations of the parties shall, if the contract contains a clause providing for termination for convenience of the District, be the same as if the termination had been issued for the convenience of the District. If, in the foregoing circumstances, this contract does not contain a clause providing for termination for convenience of the District, the contract shall be adjusted to compensate for such termination and the contract modified accordingly subject to the contractor's rights under the Disputes clause.
- (h) The rights and remedies of the District in this clause are in addition to any other rights and remedies provided by law or under this contract.

**DEFECTIVE GOODS:** Any item delivered in an unacceptable condition will not be accepted. Successful bidder agrees to pay for return shipment of goods that arrive in a defective or inoperable condition. Offeror must agree to arrange for return shipment of damaged goods.

**ILLEGAL IMMIGRATION**: (An overview is available at <a href="www.procurement.sc.gov">www.procurement.sc.gov</a>) By signing your offer, you certify that you will comply with the applicable requirements of Title 8, Chapter 14 of the South Carolina Code of Laws and agree to provide to the District upon request any documentation required to establish either: (a) that Title 8, Chapter 14 is inapplicable to you and your subcontractors or sub-subcontractors; or (b) that you and your subcontractors or sub-subcontractors are in compliance with Title 8, Chapter 14. Pursuant to Section 8-14-60, "A person who knowingly makes or files any false, fictitious, or fraudulent document, statement, or report pursuant to this chapter is guilty of a felony, and, upon conviction, must be fined within the discretion of the court or imprisoned for not more than five years, or both." You agree to include in any contracts with your subcontractor's language requiring your subcontractors to (a) comply with the applicable requirements of Title 8, Chapter 14, and (b) include

in their contracts with the sub-subcontractor's language requiring the sub-subcontractors to comply with the applicable requirements of Title 8, Chapter 14.

INDEMNIFICATION - THIRD PARTY CLAIMS - GENERAL: Notwithstanding any limitation in this agreement, and to the fullest extent permitted by law, Contractor shall defend and hold harmless Indemnitees for and against any and all suits or claims of any character (and all related damages, settlement payments, attorneys' fees, costs, expenses, losses or liabilities) by a third party which are attributable to bodily injury, sickness, disease or death, or to injury to or destruction of tangible property arising out of or in connection with the goods or services acquired hereunder or caused in whole or in part by any act or omission of contractor, its subcontractors, their employees, workmen, servants, agents, or anyone directly or indirectly employed by them or anyone for whose acts any of them may be liable, regardless of whether or not caused in part by an Indemnitee, and whether or not such claims are made by a third party or an Indemnitee; however, if an Indemnitee's negligent act or omission is subsequently determined to be the sole proximate cause of a suit or claim, the Indemnitee shall not be entitled to indemnification hereunder. Contractor shall be given timely written notice of any suit or claim. Contractor's obligations hereunder are in no way limited by any protection afforded under workers' compensation acts, disability benefits acts, or other employee benefit acts. This clause shall not negate, abridge, or reduce any other rights or obligations of indemnity which would otherwise exist. The obligations of this paragraph shall survive termination, cancelation, or expiration of the parties' agreement. This provision shall be construed fairly and reasonably, neither strongly for nor against either party, and without regard to any clause regarding insurance. As used in this clause, "Indemnitees" means District Five of Lexington and Richland Counties, its instrumentalities, agencies, departments, boards, and all their respective officers, agents and employees.

LICENSES AND PERMITS: During the term of the contract, the Contractor shall be responsible for obtaining, and maintaining in good standing, all licenses (including professional licenses, if any), permits, inspections and related fees for each or any such licenses, permits and /or inspections required by the State, county, city or other government entity or unit to accomplish the work specified in this solicitation and the contract.

**MATERIAL AND WORKMANSHIP:** Unless otherwise specifically provided in this contract, all equipment, material, and articles incorporated in the work covered by this contract are to be new and of the most suitable grade for the purpose intended.

**PRICE ADJUSTMENTS:** (1) Method of Adjustment. Any adjustment in the contract price made pursuant to a clause in this contract shall be consistent with this Contract and shall be arrived at through whichever one of the following ways is the most valid approximation of the actual cost to the Contractor (including profit, if otherwise allowed):

- (a) By agreement on a fixed price adjustment before commencement of the pertinent performance or as soon thereafter as practicable;
- (b) By unit prices specified in the Contract or subsequently agreed upon;
- (c) by the costs attributable to the event or situation covered by the relevant clause, including profit if otherwise allowed, all as specified in the Contract; or subsequently agreed upon;
- (d) in such other manner as the parties may mutually agree; or,
- (e) in the absence of agreement by the parties, through a unilateral initial written determination by the Procurement Officer of the costs attributable to the event or situation covered by the clause, including profit if otherwise allowed, all as computed by the Procurement Officer in accordance with generally accepted accounting principles, subject to the provisions of Title 11, Chapter 35, Article 17 of the S.C. Code of Laws.
- (2) Submission of Price or Cost Data. Upon request of the Procurement Officer, the contractor shall provide reasonably available factual information to substantiate that the price or cost offered, for any price adjustments is reasonable, consistent with the provisions of Section 11-35-1830.

**PRICING DATA – AUDIT – INSPECTION:** [Clause Included Pursuant to Section 11-35-1830, - 2210, & -2220] (a) Cost or Pricing Data. Upon Procurement Officer's request, you must submit cost or pricing data, as defined by 48 C.F.R. Section 2.101 (2004), prior to either (1) any award to contractor pursuant to 11-35-1530 or 11-35-1560, if the total contract price exceeds \$500,000, or (2) execution of a change order or contract modification with contractor which exceeds \$100,000. Your price, including profit or fee, must be adjusted to exclude any significant sums by

which the District finds that such price was increased because you furnished cost or pricing data that was inaccurate, incomplete, or not current as of the date agreed upon between parties. (b) Records Retention. You must maintain your records for three years from the date of final payment, or longer if requested by the chief Procurement Officer. The District may audit your records at reasonable times and places. As used in this subparagraph (b), the term "records" means any books or records that relate to cost or pricing data submitted pursuant to this clause. In addition to the obligation stated in this subparagraph (b), you must retain all records and allow any audits provided for by 11-35-2220(2). (c) Inspection. At reasonable times, the District may inspect any part of your place of business which is related to performance of the work. (d) Instructions Certification. When you submit data pursuant to subparagraph (a), you must (1) do so in accordance with the instructions appearing in Table 15-2 of 48 C.F.R. Section 15.408 (2004) (adapted as necessary for the District context), and (2) submit a Certificate of Current Cost or Pricing Data, as prescribed by 48 CFR Section 15.406-2(a) (adapted as necessary for the District context). (e) Subcontracts. You must include the above text of this clause in all of your subcontracts. (f) Nothing in this clause limits any other rights of the District.

**RELATIONSHIP OF THE PARTIES**: Neither party is an employee, agent, partner, or joint venturer of the other. Neither party has the right or ability to bind the other to any agreement with a third party or to incur any obligation or liability on behalf of the other party.

**TERM OF CONTRACT – EFFECTIVE DATE / INITIAL CONTRACT PERIOD**: The effective date of this contract is the first day of the Maximum Contract Period as specified on the <u>final</u> statement award. The initial term of this agreement is three (3) years from the effective date. Regardless, this contract expires no later than the last date stated on the final statement of award.

**TERM OF CONTRACT – OPTION TO RENEW:** At the end of the initial term, and at the end of each renewal term, the District reserves the right to extend the contract for a period up to two (2) additional one (1) year period(s) upon mutual agreement of the District and the Offeror.

**TERMINATION FOR CONVENIENCE:** (1) Termination. The Procurement Officer may terminate this contract in whole or in part, for the convenience of the District. The Procurement Officer shall give written notice of the termination to the contractor specifying the part of the contract terminated and when termination becomes effective. (2) Contractor's Obligations. The contractor shall incur no further obligations in connection with the terminated work and on the date set in the notice of termination the contractor will stop work to the extent specified. The contractor shall also terminate outstanding orders and subcontracts as they relate to the terminated work. The contractor shall settle the liabilities and claims arising out of the termination of subcontracts and orders connected with the terminated work. The Procurement Officer may direct the contractor to assign the contractor's right, title, and interest under terminated orders or subcontracts to the District. The contractor must still complete the work not terminated by the notice of termination and may incur obligations as are necessary to do so.

- (3) Right to Supplies. The Procurement Officer may require the contractor to transfer title and deliver to the District in the manner and to the extent directed by the Procurement Officer: (a) any completed supplies; and (b) such partially completed supplies and materials, parts, tools, dies, jigs, fixtures, plans, drawings, information, and contract rights (hereinafter called "manufacturing material") as the contractor has specifically produced or specially acquired for the performance of the terminated part of this contract. The contractor shall, upon direction of the Procurement Officer, protect and preserve property in the possession of the contractor in which the District has an interest. If the Procurement Officer does not exercise this right, the contractor shall use best efforts to sell such supplies and manufacturing materials in a accordance with the standards of Uniform Commercial Code Section 2-706. Utilization of this Section in no way implies that the District has breached the contract by exercise of the Termination for Convenience Clause.
- (4) Compensation. (a) The contractor shall submit a termination claim specifying the amounts due because of the termination for convenience together with cost or pricing data required by Section 11-35-1830 bearing on such claim. If the contractor fails to file a termination claim within one year from the effective date of termination, the Procurement Officer may pay the contractor, if at all, an amount set in accordance with Subparagraph (c) of this Paragraph.
- (b) The Procurement Officer and the contractor may agree to a settlement and that the settlement does not exceed the total contract price plus settlement costs reduced by payments previously made by the District, the proceeds of any

sales of supplies and manufacturing materials under Paragraph (3) of this clause, and the contract price of the work not terminated:

- (c) Absent complete agreement under Subparagraph (b) of this Paragraph, the Procurement Officer shall pay the contractor the following amounts, provided payments agreed to under Subparagraph (b) shall not duplicate payments under this Subparagraph:
- (i) contract prices for supplies or services accepted under the contract;
- (ii) costs reasonably incurred in performing the terminated portion of the work less amounts paid or to be paid for accepted supplies or services;
- (iii) reasonable costs of settling and paying claims arising out of the termination of subcontracts or orders pursuant to Paragraph (2) of this clause. These costs must not include costs paid in accordance with Subparagraph (c)(ii) of this paragraph;
- (iv) any other reasonable costs that have resulted from the termination. The total sum to be paid the contractor under this Subparagraph shall not exceed the total contract price plus the reasonable settlement costs of the contractor reduced by the amount of payments otherwise made, the proceeds of any sales of supplies and manufacturing materials under Subparagraph (b) of this Paragraph, and the contract price of work not terminated.
- (d) Contractor must demonstrate any costs claimed, agreed to, or established under Subparagraphs (b) and (c) of this Paragraph using its standard record keeping system, provided such system is consistent with any applicable Generally Accepted Accounting Principles.
- (5) Contractor's failure to include an appropriate termination for convenience clause in any subcontract shall not (i) affect the District's right to require the termination of a subcontract, or (ii) increase the obligation of the District beyond what it would have been if the subcontract had contained an appropriate clause.

**TERM OF CONTRACT – TERMINATION BY CONTRACTOR**: Contractor may terminate this contract at the end of the initial term, or any renewal term, by providing the Procurement Officer notice of its election to terminate under this clause at least ninety (90) days prior to the expiration of the then current term.
