In order to be considered, all bids must be hand carried or mailed <u>in a sealed envelope</u> to the Florence County Procurement Office, Florence County Complex, 180 N. Irby Street – MSC-R, Rm. B-5, Florence, SC 29501-3431 later than <u>October 24, 2017 at 3:00 p.m. (EST).</u>

The sealed bids will then be opened and read aloud in room 210-C of the County Complex at 3:05 p.m. (ET).

Sealed bids must be received in a sealed envelope and clearly marked as follows:

"Invitation-To-Bid #09-17/18 – "Property Located At 124 Epps Street, Lake City, SC"

Sealed bids MUST be in the actual possession of the Florence County Procurement Department on or before the exact time and date indicated above. Bids received after the published time and date shall not be opened and shall be disqualified and returned unopened to sender. Emails or facsimiles will not be accepted.

Sealed bids submitted by mail and/or carrier must meet the same requirements as above and should be addressed to the same address listed above. Florence County shall not be responsible for late delivery of bids.

All bids should be good for a period of ninety (90) days from the date the bids are opened, and no bid shall be received, nor shall any responder be allowed to withdraw a bid after the bid opening commences.

The bid will be awarded to the highest responsible bidder.

A responsible bidder means a bidder who has the capability to fully comply with all the requirements of the bid documents.

The bid will not be awarded until the Procurement Director and the applicable Department Director have had ample time to review each bid and will be subject to the Florence County Council acceptance and approval. Transfer of ownership to the successful bidder will not occur until after Council's acceptance of the successful bid.

Florence County reserves the right to accept or reject any or all bids received as a result of this request; to negotiate with any or all qualified proposers; or, to cancel in part or in its entirety this bid invitation, if it is in the best interest of the County to do so.
