- Is there a page limit?
 - o There is no page limit

- Based on the updated cost proposal form, as a vendor, are the fees we are providing based on position type/category or is there a way to provide multiple fees for each phase per position/level/category? For example: if I am in phase 1 and my fee is \$100, a lower-level general position vs a high-level executive level position, would those positions be the same fee.
 - Offerors may submit different rates for the different categories outlined in the Scope of Work. Offerors should fill out multiple cost proposals and indicate which category that pricing is for. Generally speaking, this contract will be used for harder to fill positions, rather than lower level, so the level of work involved generally shouldn't fluctuate dramatically from one category to the next.
