RESPONSES TO PROPOSER QUESTIONS

Responses Dated: October 28, 2021

- Question 1.** Can we bid on only one-line item?
- Answer.** **Yes, vendors may bid on individual items however due to the audit process associated with the FEMA grant process, it is preferable to utilize a vendor who can supply all items listed in Appendix A. However, all submittals will be reviewed for the best value for the city of Kingman.**
- Question 2.** Are we required to have an Arizona Sales Tax License?
- Answer.** **A TPT license is not required to respond to a Request for Proposal (RFP). The winning bidder may be subject to transaction privilege tax on the sale of items or services within the State of Arizona. - Question 3.** Could you please provide to us, if we can provide a price a substitute product or we should just provide the price for the branded products named in the sheet?
- Answer.** **The items specified are the only ones allowed for submittal. Any substitutions will not be considered.**
- Question 4.** I also needed some clarity on the quantity, which is 16,000 individual pieces or 16,000 Boxes or 16,000 cartons.
- Answer.** **This is listed as 16,000 individual items. They may come in a variety of container types and quantities which must equal 16,000 individual pieces.**
- Question 5.** I wanted to know if the city would consider my brand rather than 3M N95 Masks 1870+Bulk, Particulate Respirator Regular size. For the mask how many pieces would you like in each box and how many boxes would you like in a case or carton?
- Answer.** **No, the items listed are currently utilized by our organization and all personnel are currently fitted as specified by OSHA fit testing requirements.**
- Question 6.** Are the quantities requesting a one-time order for immediate delivery? Or is the City of Kingman Fire Dept. going to be ordering these items over a longer-term period?
- Answer.** **This will be a one-time with the Assistance to Firefighter Grant award from FEMA.**
- Question 7.** For the Alcohol wipes and liquid - Can you please confirm the size and also if the quantity is per can/tub or per case
- Answer.** **For the liquid it is in gallon size and per case while the Alcohol Wipes are quantity of 200 individual packages.**
- Question 8.** Nitrile gloves – can we offer substitute options and also ones that are chemo rated?
- Answer.** **No, due to department current stock.**

Question 9. For the N95, does it have to be 3M or can it also be another N95 (Made in the USA and also NIOSH approved) brand?

Answer. **No, the items listed are currently utilized by our organization and all personnel are currently fitted as specified by OSHA fit testing requirements.**

Question 10. Do you plan to place a single order for the entire list of items?

Answer. **This will be a one-time with the Assistance to Firefighter Grant award from FEMA.**

Question 11. Do you plan on awarding to a single vendor if possible?

Question 12. Isopropyl Alcohol wipes - what size do you want? I'm assuming you mean boxes or cases. They come in medium and large. Which would you prefer? Do you want 200 boxes, or 200 cases?

Question 13. Isopropyl Liquid - Do you want regular rubbing alcohol which is 70%? Do you want pints, quarts, or gallons? Did you mean 20 bottles, or 20 cases?

Question 14. Apex Surgical gloves - 160 -do you mean boxes or cases?

Answer. **160 boxes**

Question 15. Isolation Gowns - surgical gowns are referenced. Do you want sterile gowns, or a protective isolation gown that fits that description?

Answer. **A protective isolation gown that fits the description**

Question 16. What level of protection are you looking for? There are four levels of protection. I'm assuming you want something that protects against penetration of bodily fluids.

Answer. **An isolation gown that isolates against bodily fluids.**

Question 17. Surgical Face Masks 3-Ply, ear loops, Blue - Do you want 20,000 each?

Answer. **Yes, 20,000 total.**

Question 18. This Item comes 440 each in a box total = 19,800 each or you would need to increase your demand to 20,240 each. I can either quote 19,800 or 20,240.

Question 19. These gloves Come 100 each in a box, not in 160 packaging. Also, do you need a total of 160 pieces or 160 pieces of each size M, L, XL so a total of 480? But you would need to purchase 500 total. I can quote 500.

Question 20. This item comes in 99% Purified or 70% Purified also comes in gallons or spray bottles so would you like 20 Gallon or 20 spray bottles. There is a price difference on the purification level.

Answer. It has to be 99%. See Question 7 for clarification on quantity.

Question 21. Our business is in California and we and we have a California sales tax license, is a compulsory requirement to have a "Arizona Sales Tax License Number" before we know if we have been awarded the contract ?.
