I. SCOPE OF SOLICITATION

ACQUIRE SERVICES & SUPPLIES / EQUIPMENT (JAN 2006): The purpose of this solicitation is to acquire services and supplies or equipment complying with the enclosed description and/or specifications and conditions. [01-1005-1].

It is the intent of the Horry County Schools Office of Procurement to solicit offers from qualified vendors to provide a district term contract from qualified offerors to provider filter replacement services for Heating, Ventilation, and Air Conditioning (HVAC) Systems, and Preventive Maintenance cleaning of all HVAC unit coils at each school location located throughout the District in accordance with all requirements stated herein. Equipment type and location can be determined from Attachment A, B and C. HCS will determine what sites will receive HVAC coil cleaning annually. The school sites bid received should be based on equipment type and location at all HCS Elementary, Middle, High School and support building facilities.

MAXIMUM CONTRACT PERIOD - (ESTIMATED) (JAN 2006): Start date: 07/01/2023 End date: 06/30/2028.

Dates provided are estimates only. Any resulting contract will begin on the date specified in the notice of award. See clause entitled "Term of Contract – Effective Date / Initial Contract Period". [01-1040-1]

The contract resulting from this solicitation will be a one (1) year contract with four (4) additional one-year renewal options. The maximum potential contract life is five years.

II. INSTRUCTIONS TO OFFERORS - A. GENERAL INSTRUCTIONS:

DEFINITIONS, CAPITALIZATION, AND HEADINGS

AMENDMENT means a document issued to supplement the original solicitation document. **BOARD** means the Horry County Schools Board of Education or its successor in interest.

BUSINESS means any corporation, partnership, individual, sole proprietorship, joint stock company, joint venture, or any other legal entity

BUYER means the Procurement Officer/Specialist.

CHANGE ORDER means any written alteration in specifications, delivery point, rate of delivery, period of performance, price, quantity, or other provisions of any contract accomplished by mutual agreement of the parties to the contract.

INTRODUCTION:

Horry County Schools (HCS) is the third largest school district among the 85 school districts in the State of South Carolina and is coterminous with Horry County's land area of approximately 1,152 square miles. The present boundaries of the District were established in 1952 as a result of the consolidation of all existing school Districts in the county. Horry County Schools has more than 45,000 students and more than 6,000 employees. The district is made up 52 school sites and four additional program schools within nine attendance areas: Aynor, Carolina Forest, Conway, Green Sea Floyds, Loris, Myrtle Beach, North Myrtle Beach, Socastee, and St. James

The District is governed by a board of trustees, the Horry County Board of Education, consisting of a 12-member Board of Education, elected from single-member Districts with the Board Chairman elected at-large. The Horry County Board of Education members have decision-making authority, the power to designate management, the ability to significantly influence operations, and have primary accountability for fiscal matters.

PURPOSE: Heating, Ventilation and Air-Condition (HVAC) systems are to help maintain indoor air quality through adequate ventilation with filtration and provide thermal comfort.

Horry County Schools is seeking bids from qualified offerors to provide filters and perform filter replacement services for Heating, Ventilation, and Air Conditioning Systems and annual HVAC coil cleaning of all unit coils located throughout the District. All supplies, materials, service vehicles, communication needs, labor, labor supervision, tools, test equipment, special equipment and lubricants necessary to provide turn-key services during non-instructional school hours, evening hours, weekends and holidays shall be included in pricing.

Currently, the top 20 highest volume of filters purchased by the district which required replacement services have been provided in a market basket as identified in the Bid Schedule Attachment A. The remainder of filter products required for the facilities (as identified in the attachment for the filters at the other various locations in Attachments B & C) will be provided at the percentage discount offered. The % discount will remain fixed for the initial contract period plus all exercised optional renewal periods.

APPLICABLE STANDARDS. The most current version of the following documents applies throughout the life of the contract. ASHRAE (American Society of Heating, Refrigerating and Air Conditioning Engineers) test method 52.1-92, 52.2-1999.

GENERAL REQUIREMENTS: The Contractor shall perform the following services for Heating, Ventilation, and Air Conditioning (HVAC) Systems.

- 1. The Contractor shall provide and replace air condition filters in each HVAC unit.
- 2. The Contractor shall provide annual inspections and preventative maintenance to coil units (as requested).
- 3. Contractor shall include travel time for all services in pricing.

FILTER REPLACEMENT: Contractor shall supply and replace all air filters. Disposal of air filters shall be in accordance with Federal, State and City Regulatory Requirements. The District has provided a suggested schedule for the replacement of filters and may change based on contractor recommendation.

- 1. Replace all air filters per manufacturer's recommendations.
- 2. Review manufacturer's instructions and become familiar with manufacturer's recommended operating velocity. The information will assist in selecting proper efficiencies.
- 3. Verify each air handler has proper number of filters.
- 4. Verify the size and measurement of filter to ensure the proper fit.
- 5. Review the Safety Training Modules for "Controlling Hazardous Energy Sources".
- 6. De-energize, tag and lock out fan motor circuit.
- 7. Delivery location may not have a loading dock or building elevator.
- 8. Contractor shall indicate on the filter in black permanent marker the date that the install occurred.
- 9. Clean and vacuum inside filter area and exterior return grills, remove dust debris, replace all return grill clips or screws that secures return grills, and provide a suitable work environment for teachers, students, and staff.
- 10. Dispose and remove all filters from District property in accordance with all local, state, and federal regulations.
- 11. Filter replacement service is required to be provided to the following type of units:
 - a. Roof Top and Split System units.
 - b. Wall Hung/Scholar Units and Thru-the-Wall Units
 - c. Dedicated Fresh Air Units
 - d. Fan Coil units
 - e. P-Tac units
 - f. Water Source units
 - q. Window units
 - h. VAV units
 - Mixed Air units
 - j. Mini Split units (These units are washable. During the cleaning of the min splits, if damage occurs to the filter, contractor will be responsible for replacing filter.)

FILTER REPLACEMENT SCHEDULE: Contractor shall begin performance under the resulting contract within five (5) working days of final award.

1. First scheduled filter replacement filter service shall start within one (1) month or thirty (30) days of the commencement of the contract.

- 2. Service shall continue on a 60- day rotation cycle with a total of six (6) changes each year.
- 3. District will consider replacement service for equipment requiring a 4" to 12" filter be scheduled annually.

FILTER REPLACEMENT CHECKPOINTS: Contractor shall:

- 3. Remove tags, restore to service, and check for proper operation.
- 4. Clean air handler unit coils and drain pans.
- 5. Clean up work area and remove trash.
- 6. Verify all filter doors are secure and no items are left on roofs or grounds.

FILTER REQUIREMENTS: All new filters shall meet or exceed the below requirements:

- 1. Unit cost provided shall include shipping and delivery.
- 2. Filters shall be new.
- 3. Minimum MERV 8 efficiency rating as per ASHRAE (American Society of Heating, Refrigerating and Air Conditioning Engineers) test method 52.1-92
- 4. Internal Ring Panel, or approved equivalent
- 5. Steel internal support ring
- 6. Self-sealing zero air bypass design
- 7. Initial resistance below 0.32" @ 375 FPM (77 PA)
- 8. Final resistance rating 1.00"
- 9. EPA approved anti-microbial treatment to inhibit growth within media.

COIL CLEANING MAINTENANCE: Annual Inspections and Maintenance of coil ac units, to include rooftop units, air handlers, makeup air units, fan coil units, and exhaust fans. The Contractor shall:

- 1. Perform cleaning of coils on HVAC systems sites annually that HCS Maintenance Department requires.
- 2. As HCS Maintenance Department specifies a particular school site to provide coil cleaning at, all condensers and evaporators (including mini-split units) shall be cleaned and inspected by HCS prior to moving on to other sites.
- 3. When access (to custodial closets, etc.) allows, condenser and evaporator coils should be cleaned with 120 degree or warmer water to assist in sanitation of coils while cleaning. Regardless of the method, coils shall be cleaned before HCS provides payment. All units shall be taped off for protection of electrical components. PTAC/Window units must be removed; sleeves vacuumed and cleaned. No chemical solutions are allowed. However, the use of a diluted foaming non-acid, biodegradable green coil cleaner on site is acceptable unless the use of such cleaner were to cause complaints from students or staff. At that time the use of all chemicals would no longer be allowed.
- 4. HCS will select the number of school sites that they intend to require the contractor to provide HVAC coil cleaning based on the need for coil cleaning and funding each year.

SERVICE REPORT: Contractor shall provide within five (5) days of completion of services a written report of recorded inspection results/servicing activities completed and indicate any detected deficiencies. Report shall be submitted via email to HCS Regional Area Manager or designee designated on purchase order.

After service is performed at any site, the Contractor shall furnish a written report (checklist) detailing the services performed, indicate any detected deficiencies and shall advise the District whether additional services are required to assure operating dependability of the equipment under this contract. If additional services are required, the Contractor shall submit the price of those services to the District and describe the work to be performed detailing pricing for the work. The price for these additional services shall be submitted to the District in writing and shall be approved by the District prior to performing. The Contractor shall not undertake any repairs without the prior approval from the District.

In addition, the Contractor shall notify the District of the status of each unit or system upon completion of the service before departing from the location. If service requires more than one (1) visit, the Contractor shall notify the District of the repair status upon completion of each visit. A signature from the District Facility representative is required before departure.

The Contractor shall ensure that all employees who perform under this contract have been fully trained and are certified as qualified to service the equipment.

HCS RESPONSIBILITIES: HCS will provide an HCS Regional Area Manager or designee for administering the subsequent contract. The District shall provide access (keys, codes, etc.) to all equipment that requires services.

CONTRACTOR RESPONSIBILITIES: The Contractor shall directly employ and supervise technicians working under the resulting contract.

The Contractor shall employ service technicians throughout the life of the contract to perform the work required under this Scope of Services who are knowledgeable and proficient in this field.

The Contractor shall have personnel trained in the application of and the need for the Lock Out / Tag Out (LOTO) method according to OSHA standard 29 CFR 1910.147.

The Contractor shall have fully equipped service trucks and other support equipment (lifts, ladders, etc.), to safely complete the scope of work without injury to personnel and/or damage to District equipment/materials (such as ductwork, etc.). This shall include anything necessary to comply with regulatory environmental requirements.

The Contractor shall ensure that all employees have a valid State Driver's License and/or ID.

The Contractor shall provide a one-year warranty on all parts and labor provided under the resulting contract.

The Contractor shall be willing to obtain and maintain the following in order to respond to work orders through the District's School Dude software: internet access thorough a computer, table, or smart phone. The name, email address, and cell phone number of one employee of the Contractor shall be provided to the Facilities Department. This employee shall attend a 2-3 hour training session with Facilities personnel on School Dude software. The Contractor is responsible, once trained by HCS, for documenting and completion of HCS School Dude Work Orders or the work order system being utilized by the District at that time. The School Dude work orders are created for preventative maintenance of associated items along with replacement of HVAC filters and HVAC Coil Cleaning.

The Contractor shall provide a written report to the District Maintenance Department upon completion of services, detailing all work performed, parts replaced and service recommendations. This Report shall be attached to School Dude Work Order or work order system that HCS is using.

To facilitate HCS maintaining an accurate filter replacement record, contractor shall provide a semi-annual report (due in December and June) to the district of filter sizes, filter installation locations, equipment type and totals for each school so that the master report can be updated and maintained due to HVAC equipment replacements.

The Contractor shall provide the recommended size filter per manufacturer to assure proper operation when increasing the Merv rating of the HVAC filter installed to prevent a decrease in airflow throughout the HVAC system and prevent filters from becoming dislodged from the intended filter location. If an additional filter resides in an HVAC unit to provide filtration for fresh air for building occupants, and the space and has a return grill in the space for that unit, it isn't recommended or required to provide an of-equal MERV filter to filter the outside air. This filter should be a lesser MERV rating to prevent improper airflow and possible damage to equipment. If damage occurs as a result of improper sizing of filters, or MERV rating choices of the wrong type, it shall be the responsibility to correct the cause and repair the damages that are in direct association.

CONTRACTROR'S GENERAL CONDITIONS: Must have adequate service organization with local service representative for the geographical area for which the bid is applicable.

Contractor shall assure that all materials used are in full compliance with applicable standards, rules, regulations, and manufacturer's guidelines/recommendations.

Contractor shall contact HCS to coordinate and schedule service. Any subsequent schedule changes shall be approved by the HCS Regional Area Managers or designee.

Contractor will perform the filter replacement and coil cleaning service on the equipment at each facility as listed in Attachments A, B, and C. Any findings outside of the scope of work that requires maintenance or repair should be reported to the HCS Regional Area Manager during the onsite contract performance.

Perform all work in accordance with generally accepted industry practice for safe and efficient operations.

Shall furnish, install, and maintain all signage, warning devices, barricades, cones, etc., as required to adequately protect the public, DISTRICT staff and others during the performance of this CONTRACT.

Safeguard surrounding property, vehicles and the public.

Ensure all tools and materials shall remain in possession at all times.

Ensure all work areas shall be secured prior to the end of each workday.

Provide trucks and vehicles licensed for use on public streets. Vehicles shall have identification to include company's name and/or logo so that it is apparent to the nature of business of the occupant of the vehicle.

ADDITION/DELETION: The current equipment inventory operated is comprised of various makes, models, ages and sizes. As equipment is replaced or expansion occurs equipment may be substituted, deleted or added to the inventory. All additional services or filters will be added at the same cost as identified in the Attachment A - Bid Schedule Market Basket/Coil Cleaning. The District reserves the right to add, delete, revise and expand services in response to changing requirements. Such modifications will be executed using a written Change Order with negotiated adjustments to the contract.

PARTS AND MATERIAL: All parts and materials provided under this agreement shall be new, free from defects, guaranteed suitable for their particular designed purpose.

Contractor shall at their own expense shall obtain parts in the most expeditious manner available, which includes overnight air shipping and special fast track ordering.

CONTRACTOR'S WORK HOURS: Non-Business Hours. The Contractor will provide service during non-business hours unless prior approval has been obtained from the HCS Regional Area Manager or designee. Non-business hours would be 30 minutes after the dismissal time of the bell schedule. Dismissal time with the bell schedule can be viewed online at https://www.horrycountyschools.net/Page/644. During the summer break, contractor may perform the work during regular business day with the exception of schools that offer summer school to students.

Travel Time. Travel time shall not be billed to HCS.

CONTRACTORS PERSONNEL REQUIREMENTS: Contractor's employees shall wear conservative-style uniform shirts. Contractor shall also provide employees with identification to include employee's name, company name and/or logo which shall display at all times. Employees shall wear name tags in plain view at all times while performing the work of the contract.

Contractor's employees should wear appropriate clothing for their protection. Proper attire must be worn at all times. Tank tops, shorts and open toe shoes are not permitted on site, at any time.

Contractor's employees may not have Walkman-type or other radios which may impede hearing or sight, other than earplugs or safety glasses.

Contractor shall use only skilled, competent, trained, licensed or certified personnel.

Contractor shall use personnel protective equipment to ensure the safety of their employees.

Unauthorized Personnel – Unauthorized personnel are not permitted on District property, including friends, children, or any other relatives of personnel. Violation may be the cause for cancellation of the contract.

USE OF SUBCONTRACTORS: The Contractor shall perform the work with its own employees under its immediate supervision and shall not subcontract any portion of the work unless approved by the District Procurement Office.

QUALITY ASSURANCE: All work is subject to inspection the HCS Regional Area Manager or designee. Contractor may be required to correct any defective workmanship or to replace any defective materials with no further cost to HCS. Defective workmanship shall be corrected within 2-business days of notification of deficiency.

SECURITY AND SAFETY REQUIREMENTS:

Swipe Card Badge & Access Keys –It will be the successful contractor's responsibility to see that these badges and all are returned at the end of the contract period. If any badges are lost the vendor will also be responsible for the cost of replacement. The vendor shall also be responsible for all costs associated with loss of badges or building keys. Provided a building key is lost and the building exterior doors require rekeying, it will be the contractor's responsibility to reimburse HCS for all time and labor associated with providing this repair. The successful contractor will be responsible for any thefts due to break-in by any of the contractor's employees, past or present.

Responsibility – If any doors are left open and/or unlocked which results in the setting off of the alarm system, the successful contractor shall be responsible for any charges HCS may incur from the police department for responding to a false alarm. HCS will not be responsible in any way for damage to the vendor's employee's personal belongings brought into the building.

Security Issues – Doors should only be unlocked when cleaning is necessary and must not be left unattended and be actively supervised. Doors and windows should be locked immediately after completion of work.

School District and District Employee Property – The successful contractor shall be responsible in the event of theft or damage of School District property or personal property of District employees. Any articles found by the contractor shall be handed in to the designated office. The successful contractor and their employees are prohibited from the use of school facilities, coffee makers, microwaves, audio-visual equipment, computers, telephones, all other equipment, or district property, etc. The successful contractor shall prohibit all employees from disturbing papers on desks, opening desk drawers or cabinets, or any office equipment provided for official use. Any violation of these prohibited actions may cause cancellation of the contract. The successful contractor shall at all time guard against damage or loss to the property of the School District or of other vendors or contractors and shall be held responsible for replacing or repairing any such loss or damage. The school district may withhold payment or make such deductions as deemed necessary to insure reimbursement or replacement for loss or damage to property through negligence of the successful vendor or his agents. When requested, the successful contractor must cooperate with any ongoing investigation involving economic loss or damage to the building or personal property.

Safety – Successful contractor(s) shall be responsible for instructing employees in safety measures considered appropriate.

VENDOR LIASON: The vendor must provide a primary liaison to coordinate all matters pertaining to this contract. In the event that the vendor's primary liaison is not available for any reason, a secondary liaison must be provided as well. The vendor must provide the following: Name, telephone number, fax number, email address and business cell phone number. Normal working hours of their primary and secondary liaisons. The vendor must be able to accept request after normal working hours for emergency situations.

NON-EXCLUSIVE CONTRACT: HCS reserves the right to engage temporary services from any other available source in the event the Contractor is not able to provide the services called for in these specifications in a timely and/or satisfactory manner for any reason, including, but not limited to strikes or work stoppage from breakdown in equipment. HCS reserves the right to charge the Contractor with costs for temporary services.

WARRANTY: The contractor warrants to the District that all work performed as a result of this solicitation will be performed in a professional manner consistent with industry practices. Failure to perform HVAC Filter Changing or HVAC Coil cleaning that leads to constant or necessary requirements on behalf of HCS employees to perform quality control checks shall result in back charges to the contractor for time and expenses associated with these checks.

DELIVERY/PERFORMANCE LOCATION -- SPECIFIED (JAN 2006): After award, all deliveries shall be made and all services provided to the following address, unless otherwise specified: Refer to attachment for a list of all locations for the purpose of providing geographic information. **Attachment B** [03-3030-1]

INSTALLATION: Contractor shall install all items acquired pursuant to this contract as follows: The contractor shall coordinate and develop a schedule with the HCS Regional Area Manager or designee. Installation shall be made in accordance with the manufacturer's recommendations. [3-3050-1]

LICENSE/PERMITS AND RESPONSIBILITIES: The Contractor must be properly licensed in Horry County and all municipalities in Horry County, South Carolina to perform work.

CONTRACT VIOLATION: During the term of the contract, contractors who violate this contract will be considered in breach and subject to cancellation for cause. As used in this paragraph, the term "Agreement" means any transaction or agreement arising out of, relating to, or contemplated by the solicitation. (2) Service of Process. Contractor consents that any papers, notices, or process necessary or proper for the initiation or continuation of any disputes, claims, or controversies relating to the Agreement; for any court action in connection therewith; or for the entry of judgment on any award made, may be served on Contractor by certified mail (return receipt requested) addressed to Contractor at the address provided as the Notice Address on Page Two or by personal service or by any other manner that is permitted by law, in or outside South Carolina. Notice by certified mail is deemed duly given upon deposit in the United States mail. [07-7A025-1]

EQUAL OPPORTUNITY (JAN 2006): Contractor is referred to and shall comply with all applicable provisions, if any, of Title 41, Part 60 of the Code of Federal Regulations, including but not limited to Sections 60-1.4, 60-4.2, 60-4.3, 60-250.5(a), and 60-741.5(a), which are hereby incorporated by reference. [07-7A030-1]

FALSE CLAIMS (JAN 2006): According to the S.C. Code of Laws § 16-13-240, "a person who by false pretense or representation obtains the signature of a person to a written instrument or obtains from another person any chattel, money, valuable security, or other property, real or personal, with intent to cheat and defraud a person of that property is guilty" of a crime. [07-7A035-1]

FIXED PRICING REQUIRED (JAN 2006): Any pricing provided by contractor shall include all costs for performing the work associated with that price. Contractor's price shall be fixed for the duration of this contract, including option terms, except as otherwise provided in this solicitation. This clause does not prohibit contractor from offering lower pricing after award. [07-7A040-1]

NO INDEMNITY OR DEFENSE (JAN 2006): Any term or condition is void to the extent it requires HCS to indemnify, defend, or pay attorney's fees to anyone for any reason. [07-7A045-2]

NOTICE (JAN 2006): (A) After award, any notices shall be in writing and shall be deemed duly given (1) upon actual delivery, if delivery is by hand, (2) upon receipt by the transmitting party of automated confirmation or answer back from the recipient's device if delivery is by telex, telegram, facsimile, or electronic mail, or (3) upon deposit into the United States mail, if postage is prepaid, a return receipt is requested, and either registered or certified mail is used. (B) Notice to contractor shall be to the address identified on Cover Page. Notice to HCS shall be to the Procurement Specialist's address on the Cover Page. Either party may designate a different address for notice by giving notice in accordance with this paragraph. [07-7A050-1]

OPEN TRADE (JUN 2015): During the contract term, including any renewals or extensions, Contractor will not engage in the boycott of a person or an entity based in or doing business with a jurisdiction with whom South Carolina can enjoy open trade, as defined in SC Code Section 11-35-5300. [07-7A053-1]

PAYMENT & INTEREST (FEB 2015): HCS shall pay the Contractor, after the submission of proper invoices or vouchers, the prices stipulated in this contract for supplies delivered and accepted or services rendered and accepted, less any deductions provided in this contract. Unless otherwise specified herein, including the purchase order, payment shall not be made on partial deliveries accepted by HCS. (b) Unless otherwise provided herein, including the purchase order, payment will be made by check mailed to the payment address on "Page Two." (c) Notwithstanding any other provision, payment shall be made in accordance with S.C. Code Section 11-35-45, or Chapter 6 of Title 29 (real property improvements) when applicable, which provides the Contractor's exclusive means of recovering any type of interest from the Owner. Contractor waives imposition of an interest penalty unless the invoice submitted specifies that the late penalty is applicable. Except as set forth in this paragraph, HCS shall not be liable for the payment of interest on any debt or claim arising out of or related to this contract for any reason. (d) Amounts due to HCS shall bear interest at the rate of interest established by the South Carolina Comptroller General pursuant to Section 11-35-45 ("an amount not to exceed fifteen percent each year"), as amended, unless otherwise required by Section 29-6-30. (e) Any other basis for interest, including but not limited to general (pre- and post-judgment) or specific interest statutes, including S.C. Code Ann. § 34-31-20, are expressly waived by both parties. If a court, despite this agreement and waiver, requires that interest be paid on any debt by either party other than as provided by items (c) and (d) above, the parties further agree that the applicable interest rate for any given calendar year shall be the lowest prime rate as

listed in the first edition of the Wall Street Journal published for each year, applied as simple interest without compounding. (f) The District shall have all of its common law equitable and statutory rights of set-off. [07-7A055-3]

PAYMENT WITH PROPER INVOICE: Invoices submitted for payment for goods or services provided under this contract shall contain, as a minimum, the following information:

- Name of business concern
- Contract number or other authorization for delivery of service or property
- Complete description per individual line item
- Price and quantity of property or service actually delivered or executed.
- Shipping and payment terms.
- Name where applicable
- Title, telephone number and complete mailing address of responsible official to whom payment is to be sent; and
- Other substantiating documentation of information as required by the contract.

Invoices shall be provided to Horry County Schools at the address below. An itemized invoice shall be provided even if payment is made with a District purchase card.

During the term of the contract, if the District identifies items that have been overcharged, the contractor shall reimburse the District the difference in the overcharge(s) plus an additional ten percent of the overages. Repeated instances of overcharging the HCS's may result in the contract being terminated.

PUBLICITY (JAN 2006): Contractor shall not publish any comments or quotes HCS employees, or include HCS in either news releases or a published list of customers, without the prior written approval of the Procurement Specialist. [07-7A060-1]

PURCHASE ORDER (JAN 2006): CONTRACTOR SHALL NOT PERFORM ANY WORK PRIOR TO THE RECEIPT OF A PURCHASE ORDER FROM HORRY COUNTY SCHOOLS. The District shall order any supplies or services to be furnished under this contract by issuing a purchase order. Purchase orders may be used to elect any options available under this contract, e.g., quantity, item, delivery date, payment method, but are subject to all terms and conditions of this contract. Purchase orders may be electronic. No particular form is required. An order placed pursuant to the purchasing card provision qualifies as a purchase order. [07-7A065-1]

RECORDS RETENTION AND RIGHT TO AUDIT: Horry County Schools has the right to audit the books and records of the vendors they pertain to this purchase order, both independent of, and pursuant to, the District Procurement Code. Such books and records shall be maintained for six (6) years from the date of final payment under the purchase order.

The District may conduct, or have conducted, performance audits of the vendor. The District may conduct, or have conducted, audits of specific requirements of this bid as determined necessary by the District.

Pertaining to all audits, vendor shall make available to the District access to its computer files containing the history of purchase order performance and all other documents related to the audit. Additionally, any software used by the vendor shall be made available for auditing purposes at no cost to the District.

SURVIVAL OF OBLIGATIONS (JAN 2006): The Parties' rights and obligations which, by their nature, would continue beyond the termination, cancellation, rejection, or expiration of this contract shall survive such termination, cancellation, rejection, or expiration, including, but not limited to, the rights and obligations created by the following clauses: Indemnification - Third Party Claims, Intellectual Property Indemnification, and any provisions regarding warranty or audit. [07-7A075-1]

TAXES (JAN 2006): Any tax the contractor may be required to collect or pay upon the sale, use or delivery of the products shall be paid by HCS, and such sums shall be due and payable to the contractor upon acceptance. Any personal property taxes levied after delivery shall be paid by HCS. It shall be solely HCS' obligation, after payment to contractor, to challenge the applicability of any tax by negotiation with, or action against, the taxing authority. Contractor agrees to refund any tax collected, which is subsequently determined not to be proper and for which a refund has been paid to contractor by the taxing authority. In the event that the contractor fails to pay, or delays in paying, to any taxing authorities, sums paid by HCS to contractor, contractor shall be liable to HCS for any loss (such as the assessment of additional interest) caused by virtue of this failure or delay. Taxes based on Contractor's net income or assets shall be the sole responsibility of the contractor.[07-7A080-1]

TERMINATION DUE TO UNAVAILABILITY OF FUNDS (JAN 2006): Payment and performance obligations for succeeding fiscal periods shall be subject to the availability and appropriation of funds therefore. When funds are not appropriated or otherwise made available to support continuation of performance in a subsequent fiscal period, the contract shall be canceled. In the event of a cancellation pursuant to this paragraph, contractor will be reimbursed the resulting unamortized, reasonably incurred, nonrecurring costs. Contractor will not be reimbursed any costs amortized beyond the initial contract term. [07-7A085-1]

THIRD PARTY BENEFICIARY (JAN 2006): This Contract is made solely and specifically among and for the benefit of the parties hereto, and their respective successors and assigns, and no other person will have any rights, interest, or claims hereunder or be entitled to any benefits under or on account of this Contract as a third party beneficiary or otherwise. [07-7A090-1]

WAIVER (JAN 2006): HCS does not waive any prior or subsequent breach of the terms of the Contract by making payments on the Contract, by failing to terminate the Contract for lack of performance, or by failing to strictly or promptly insist upon any term of the Contract. Only the Procurement Specialist has actual authority to waive any of HCS' rights under this Contract. Any waiver must be in writing. [07-7A095-1]

VII. TERMS AND CONDITIONS - B. SPECIAL:

ACCEPTANCE OF OFFERS 10% BELOW PRICE: If the district is offered the exact same item on the exact same terms and conditions as those provided under this contract by a vendor other than the contractor (the "alternate vendor") for a price that is at least ten percent less than the contract price, the district may purchase those items from the alternate vendor if the contractor does not agree to meet the offered price. Any acquisition pursuant to this clause must be documented by the Procurement Specialist in sufficient detail to satisfy the requirements of an external audit.

BANKRUPTCY – DISTRICT INFORMATION (FEB 2015): (a) All District information (as defined in the clause herein entitled "Information Security - Definitions") shall belong exclusively to the District, and Contractor has no legal or equitable interest in, or claim to, such information. Contractor acknowledges and agrees that in the event Contractor enters into proceedings relating to bankruptcy, whether voluntary or involuntary, District information in its possession and/or under its control will not be considered property of its bankruptcy estate.

- (b) Contractor agrees to notify the District within forty-eight (48) hours of any determination that it makes to file for bankruptcy protection, and Contractor further agrees to turn over to the District, before such filing, all District information that is in Contractor's possession in a format that can be readily utilized by the District.
- (c) In order to protect the integrity and availability of District information, Contractor shall take reasonable measures to evaluate and monitor the financial circumstances of any subcontractor that will process, store, transmit or access District information. [07-7B007-1]

COOPERATIVE - AUTONOMY: Each governmental entity listed is considered an independent autonomous governmental entity, and Horry County Schools (lead entity) shall not be held responsible for the financial transactions, contractual disputes, or incurrence of liability for any other governmental entity. Horry County Schools is acting as lead entity in the procurement process. All references to "the District" in the terms, conditions, and provisions of the contract documents shall apply to each

separate governmental entity in the administration of the contract. The terms and conditions of this solicitation shall be binding between each governmental entity and each Contractor and can only be changed in writing and signed by both parties. Such amendments to the contract terms and conditions made by any governmental entity shall not be binding on other participating governments. The lead entity shall execute changes to the contract such as, but not limited to, price changes, product substitutions, service enhancements or other such changes that will be binding on all governmental entities in the cooperative. Contractors must deal directly with each governmental entity listed above concerning the placement of orders, issuance of purchase orders, payments with purchasing cards, contractual disputes, invoicing, payments or delinquent accounts, or other contract issues after the inception of the contract. Any cancellation or termination of products, services or contract between any governmental entity and any Contractor shall not be binding on the other participating governments.

CHANGES (JAN 2006): (1) Contract Modification. By a written order, at any time, and without notice to any surety, the Procurement Specialist may, subject to all appropriate adjustments, make changes within the general scope of this contract in any one or more of the following:

- (a) Drawings, designs, or specifications, if the supplies to be furnished are to be specially manufactured for HCS in accordance therewith;
- (b) Method of shipment or packing;
- (c) Place of delivery;
- (d) Description of services to be performed;
- (e) Time of performance (i.e., hours of the day, days of the week, etc.); or,
- (f) Place of performance of the services.
- (g) Product upgrades and new products that are offered by manufacturer.
- Subparagraphs (a) to (c) apply only if supplies are furnished under this contract. Subparagraphs (d) to (f) apply only if services are performed under this contract.
- (2) Adjustments of Price or Time for Performance. If any such change increases or decreases the contractor's cost of, or the time required for, performance of any part of the work under this contract, whether or not changed by the order, an adjustment shall be made in the contract price, the delivery schedule, or both, and the contract modified in writing accordingly. Any adjustment in contract price made pursuant to this clause shall be determined in accordance with the Price Adjustment Clause of this contract. Failure of the parties to agree to an adjustment shall not excuse the contractor from proceeding with the contract as changed, provided that the District promptly and duly make such provisional adjustments in payment or time for performance as may be reasonable. By proceeding with the work, the contractor shall not be deemed to have prejudiced any claim for additional compensation, or an extension of time for completion.
- (3) Time Period for Claim. Within 30 days after receipt of a written contract modification under Paragraph (1) of this clause, unless such period is extended by the Procurement Specialist in writing, the contractor shall file notice of intent to assert a claim for an adjustment. Later notification shall not bar the contractor's claim unless the District is prejudiced by the delay in notification.
- (4) Claim Barred After Final Payment. No claim by the contractor for an adjustment hereunder shall be allowed if notice is not given prior to final payment under this contract. [07-7B025-1Revised 2017 06]

CISG (JAN 2006): The parties expressly agree that the UN Convention on the International Sale of Goods shall not apply to this agreement. [07-7B030-1]

COMPLIANCE WITH LAWS (MODIFIED SEPT 2022): During the term of the contract, contractor shall comply with all applicable provisions of laws, codes, ordinances, rules, regulations, and tariffs.

Through acceptance of an order or contract, and during the term of any contract, the Contractor shall be deemed to represent that it has complied, or will comply, with all applicable provisions of Federal, State and local laws, codes, ordinances, rules, regulations and tariffs, and all District regulations and policies while on District property or while conducting District associated activities off of District property. District policies are available through this web site: https://www.horrycountyschools.net/Domain/193. The Contractor acknowledges that persons under the age of eighteen (18) are considered minors in the State of South Carolina and protected under State law. By acceptance of an order or contract, the Contractor is deemed to represent that it has complied or will comply with the Drug-Free Workplace Act, Section 44-107-

10, Chapter 107, of the South Carolina Code of Laws. Failure to comply with any applicable laws, ordinances, rules, regulations, and policies may result in unilateral and immediate revocation of this contract. [07-7B035-1]

CONFERENCE – PRE-PERFORMANCE (JAN 2006): Unless waived by the Procurement Specialist, a pre-performance conference between the contractor, district and Procurement Specialist shall be held at a location selected by the district within five (5) days after final award, and prior to commencement of work under the contract. The responsibilities of all parties involved will be discussed to assure a meeting of the minds of all concerned. The successful contractor or his duly authorized representative shall be required to attend at contractor's expense. [07-7B040-1]

CONTRACT LIMITATIONS (JAN 2006): No sales may be made pursuant to this contract for any item or service that is not expressly listed. No sales may be made pursuant to this contract after expiration of this contract. Violation of this provision may result in termination of this contract and may subject contractor to suspension or debarment. [07-7B045-1]

CONTRACTOR'S LIABILITY INSURANCE – GENERAL(FEB 2015) (MODIFIED):(a) Without limiting any of the obligations or liabilities of Contractor, Contractor shall procure from a company or companies lawfully authorized to do business in South Carolina and with a current A.M. Best rating of no less than A: VII, and maintain for the duration of the contract, insurance against claims for injuries to persons or damages to property which may arise from or in connection with the performance of the work and the results of that work by the contractor, his agents, representatives, employees or subcontractors.

- (b) Coverage shall be at least as broad as:
- (1) Commercial General Liability (CGL): Insurance Services Office (ISO) Form CG 00 01 12 07 covering CGL on an "occurrence" basis, including products-completed operations, personal and advertising injury, with limits no less than \$1,000,000 per occurrence. If a general aggregate limit applies, the general aggregate limit shall be twice the required occurrence limit. This contract shall be considered to be an "insured contract" as defined in the policy.
- (2) Auto Liability: ISO Form Number CA 00 01 covering any auto (Code 1), or if Contractor has no owned autos, hired, (Code 8) and non-owned autos (Code 9), with limits no less than \$1,000,000 per accident for bodily injury and property damage.
- (3) Worker's Compensation: As required by the State of South Carolina, with Statutory Limits, and Employer's Liability Insurance with limit of no less than \$1,000,000 per accident for bodily injury or disease.
- (c) Horry County Schools, and the officers, officials, employees and volunteers, must be covered as additional insureds on the CGL policy with respect to liability arising out of work or operations performed by or on behalf of the Contractor including materials, parts or equipment furnished in connection with such work or operations. General liability coverage can be provided in the form of an endorsement to the Contractor's insurance at least as broad as ISO Form CG 20 10 11 85 or if not available, through the addition of both CG 20 10 and CG 20 37 if a later edition is used.
- (d) For any claims related to this contract, the Contractor's insurance coverage shall be primary insurance as respects the District, and the officers, officials, employees and volunteers. Any insurance or self-insurance maintained by the District, or the officers, officials, employees and volunteers shall be excess of the Contractor's insurance and shall not contribute with it.
- (e) Prior to commencement of the work, the Contractor shall furnish the District if requested with original certificates and amendatory endorsements or copies of the applicable policy language effecting coverage required by this section. However, failure to obtain the required documents prior to the work beginning shall not waive the Contractor's obligation to provide them. The District reserves the right to require complete, certified copies of all required insurance policies, including endorsements required by this section, at any time.
- (f) Should any of the above-described policies be cancelled before the expiration date thereof, notice will be delivered in accordance with the policy provisions. In addition, the Contractor shall notify the District immediately upon receiving any information that any of the coverages required by this section are or will be changed, cancelled, or replaced.

- (g) Contractor hereby grants to the District a waiver of any right to subrogation which any insurer of said Contractor may acquire against the District by virtue of the payment of any loss under such insurance. Contractor agrees to obtain any endorsement that may be necessary to effect this waiver of subrogation, but this provision applies regardless of whether or not the District has received a waiver of subrogation endorsement from the insurer.
- (h) Any deductibles or self-insured retentions must be declared to and approved by the District. The District may require the Contractor to purchase coverage with a lower deductible or retention or provide proof of ability to pay losses and related investigations, claim administration, and defense expenses within the retention.
- (i) The District reserves the right to modify these requirements, including limits, based on the nature of the risk, prior experience, insurer, coverage, or other special circumstances. [07-7B056-2]

CONTRACTOR PERSONNEL (JAN 2006): The Contractor shall enforce strict discipline and good order among the Contractor's employees and other persons carrying out the Contract. The Contractor shall not permit employment of unfit persons or persons not skilled in tasks assigned to them. [07-7B060-1]

CONTRACTOR PERSONNEL - OBLIGATION: Contractors are responsible for the conduct of their employees, representatives and agents and for their subcontractors' and sub-subcontractors' employees, representative and agents. Suppliers are considered contractors, subcontractors or sub-subcontractors when the performance of their work (including deliveries) is conducted on District property. All such businesses/individuals shall comply with the following:

- 1. No drugs, alcohol, tobacco products, knives, firearms or other weapons on District property.
- 2. No fraternizing with, threats to, use of abusive or profane language or improper attire or actions while on District property or adjacent thereto.
- 3. Take all necessary precautions to ensure the safety of children and employees when performing contracted work or making/accepting deliveries on District property.
- 4. Secure SLED (State Law Enforcement Division) criminal background checks on every employee, representative and agent performing work, making deliveries or in any other way conducting business on District property. Ensure that no person having been convicted of violent crimes, crimes against children, illegal drug distribution, or other crimes of moral turpitude is assigned or performs work on District property. SLED background checks shall be maintained on file at the main office of the Contractor and made available to District personnel or the District's legal counsel immediately upon request.
- 5. Not employ or contract with, during the performance of the contract, any illegal alien workers or otherwise violate the provisions of the federal Immigration Reform and Control Act of 1986, as may be amended.
- 6. Not violate the provisions of the South Carolina Illegal Immigration Reform Act, as may be amended, beginning January 1, 2009, and abide by this Act <u>regardless of the number of employees employed</u>. Participation in E-Verify through the Dept. of Homeland Security is required by the District regardless of the number of employees you employ.
- 7. Provide picture ID badges for all persons performing work on District property and ensure they are worn at all times. The ID shall include the name of the individual, his/her picture and the name of their employer.

Contractors are to ensure that their subcontractors, sub-subcontractors, as well as suppliers who meet the "contractor, subcontractor or sub-subcontractor" definition above are advised of these requirements and comply with them. These are mandatory conditions for doing business (whether directly or indirectly) with Horry County Schools. The District, at its discretion, may perform random compliance checks. Any Contractor, subcontractor, sub-subcontractor, or supplier found not to be in compliance with these requirements shall result in termination of any existing contract or non-award of a contract.

CONTRACTORS OBLIGATION – GENERAL (JAN 2006): The contractor shall provide and pay for all materials, tools, equipment, labor and professional and non-professional services, and shall perform all other acts and supply all other things necessary, to fully and properly perform and complete the work. The contractor must act as the prime contractor and assume

full responsibility for any subcontractor's performance. The contractor will be considered the sole point of contact with regard to all situations, including payment of all charges and the meeting of all other requirements. [07-7B065-1]

DEFAULT (JAN 2006): (a)(1) HCS may, subject to paragraphs (c) and (d) of this clause, by written notice of default to the Contractor, terminate this contract in whole or in part if the Contractor fails to-(i) Deliver the supplies or to perform the services within the time specified in this contract or any extension; (ii) Make progress, so as to endanger performance of this contract (but see paragraph (a)(2) of this clause); or (iii) Perform any of the other material provisions of this contract (but see paragraph (a)(2) of this clause). (2) The State's right to terminate this contract under subdivisions (a)(1)(ii) and (1)(iii) of this clause, may be exercised if the Contractor does not cure such failure within 10 days (or more if authorized in writing by the Procurement Specialist) after receipt of the notice from the Procurement Specialist specifying the failure.

- (b) If HCS terminates this contract in whole or in part, it may acquire, under the terms and in the manner, the Procurement Specialist considers appropriate, supplies or services similar to those terminated, and the Contractor will be liable to the District for any excess costs for those supplies or services. However, the Contractor shall continue the work not terminated.
- (c) Except for defaults of subcontractors at any tier, the Contractor shall not be liable for any excess costs if the failure to perform the contract arises from causes beyond the control and without the fault or negligence of the Contractor. Examples of such causes include (1) acts of God or of the public enemy, (2) acts of the State in either its sovereign or contractual capacity, (3) fires, (4) floods, (5) epidemics, (6) quarantine restrictions, (7) strikes, (8) freight embargoes, and (9) unusually severe weather. In each instance, the failure to perform must be beyond the control and without the fault or negligence of the Contractor.
- (d) If the failure to perform is caused by the default of a subcontractor at any tier, and if the cause of the default is beyond the control of both the Contractor and subcontractor, and without the fault or negligence of either, the Contractor shall not be liable for any excess costs for failure to perform, unless the subcontracted supplies or services were obtainable from other sources in sufficient time for the Contractor to meet the required delivery schedule.
- (e) If this contract is terminated for default, HCS may require the Contractor to transfer title and deliver to the District, as directed by the Procurement Specialist, any (1) completed supplies, and (2) partially completed supplies and materials, parts, tools, dies, jigs, fixtures, plans, drawings, information, and contract rights (collectively referred to as "manufacturing materials" in this clause) that the Contractor has specifically produced or acquired for the terminated portion of this contract. Upon direction of the Procurement Specialist, the Contractor shall also protect and preserve property in its possession in which HCS has an interest.
- (f) HCS shall pay contract price for completed supplies delivered and accepted. The Contractor and Procurement Specialist shall agree on the amount of payment for manufacturing materials delivered and accepted and for the protection and preservation of the property; if the parties fail to agree, the Procurement Specialist shall set an amount subject to the Contractor's rights under the Disputes clause. Failure to agree will be a dispute under the Disputes clause. HCS may withhold from these amounts any sum the Procurement Specialist determines to be necessary to protect the District against loss because of outstanding liens or claims of former lien holders.
- (g) If, after termination, it is determined that the Contractor was not in default, or that the default was excusable, the rights and obligations of the parties shall, if the contract contains a clause providing for termination for convenience of HCS, be the same as if the termination had been issued for the convenience of HCS. If, in the foregoing circumstances, this contract does not contain a clause providing for termination for convenience of HCS, the contract shall be adjusted to compensate for such termination and the contract modified accordingly subject to the contractor's rights under the Disputes clause.
- (h) The rights and remedies of HCS in this clause are in addition to any other rights and remedies provided by law or under this contract. [07-7B075-1]
