**If your firm/company is awarded the bid, the following items must be submitted within three business days in order to issue a Purchase Order:**

- Current W9 (less than one year old)
- Worker's Compensation as required by State Law (\$1,000,000 coverage) **OR** Exemption Form
- General Liability (\$1,000,000 coverage)
- Automobile Liability (\$1,000,000 coverage)
- Certificate of Insurance (COI) **must** list Escambia County as Certificate Holder and additional insured for General and Auto Liability (**see example COI**)
