1.	How many feet are going to be between the new and existing building?	The proposed building will be installed on the site with the necessary building separation per the current Building Code. This will have to be confirmed and documented by the successful contractor's engineer/architect
2.	Would you consider other types of roll-up doors such as a steel sectional?	Bid per the current Scope of Work: 2. Building Specifications, c. Shall include one (1) 10' x 10' Chain Drive Janus Roll-up Door
3.	How will inspections be handled?	Scope of Work: <u>DETAILED DESCRIPTION OF WORK TO BE PERFORMED</u> 5. Chapter One and Chapter Seventeen Inspections and Material Testing Services will be performed by an inspection agency retained by the District.
4.	Are we responsible for protective fencing for this project?	Specifications are revised to remove all temporary fencing requirements from this Scope of Work.
5.	Any additional insulation requirements?	Bid per the current Scope of Work: 2. Building Specifications, d. Shall include 4" VRR Plus Insulation on Roof & Side walls
6.	Do we have access to water?	Available on-site for the contractor's use.
7.	Do we have access to electricity?	Available on-site for the contractor's use.
8.	What type of overhang do you want?	Match the existing adjacent storage building.
9.	Where do you want the doors located?	Front Rolling Coil Door and Side Personal Door.
