#### CHATTANOOGA FIRE DEPARTMENT UNIFORM SPECIFICATIONS

PURPOSE: The purpose of this bid is to find a uniform supplier who can supply the items listed in the specifications. The Chattanooga Fire department is willing to consider any and all brands that meet or exceed the specifications mention. The successful bidder must be able to supply any and all items listed in the specifications in a timely manner. All alterations must be done locally by a skilled seamstress who can come out and measure academy candidates upon request. We have tried to use color pictures in the specifications; however there may be some items in the specifications that are not pictured. If you need additional information concerning any item please contact the City of Chattanooga Purchasing Department.

#### **UNIFORM SPECIFICATIONS:**

- 1. Fabric must be of 65/35 ratios of polyester and cotton with wrinkle resistance. Available in 4 pocket or cargo style.
- 2. Color must be as follows:
  - a. Pants -Navy or Gray
  - b. Coveralls -Navy or Gray
- 3. Pants and shirts must be industrial in style. (See attached photo)
- 4. Sizes available shall be as follows:
  - a. Pants -up to, but not limited to, size 56
  - b. Coveralls -up to, but not limited to, size 64 regular
- 5. Length shall be hemmed to the nearest inch.
- 6. Coveralls needed by welders must meet or exceed NFPA 1975 standard on station/work uniform for firefighters.
- 7. Any problems with sizing must be corrected within 7 days of returning the uniform, if the problems are the fault of the Vendor.
- 8. Uniform prices will be frozen for the length of the contract not to exceed 12 months, with the City's option to renew an additional twelve months at the City's discretion.
- 9. New uniforms shall be fitted and sized at the beginning of the new contract with no cost to the City of Chattanooga.





## **DELIVERY:**

- 1. Uniforms are to be delivered within 30 days after order has been made.
- 2. Each employee's order shall be packaged per order, per employee with the employee's name and order plainly visible on the package.

# **COMPANY QUALIFICATIONS:**

Company must have established period of service no less than 18 months.

# **PAYMENT:**

Payment shall be made after all uniforms have been received correctly and in accordance with the City's payment procedures.

# CHATTANOOGA FIRE DEPARTMENT DRESS COAT UNIFORM SPECIFICATIONS

#### **MODEL NUMBER:**

Fechheimer Brothers Company (Flying Cross) Dress Coat #38803 (or equivalent color must match what we currently have)

#### **FABRIC:**

Textured woven 100% Dacron Polyester. Weight 11-11.5 oz./Linear yards. Yarn size: 2-ply, 150 Denier. Weave: 2 x 2 Serge. Minimum of 8% stretch in warp and 10% in filling. Color: Navy Blue

#### **BASIC DESIGN:**

Four (4) button, single-breasted straight front, semi-form fitting with notch lapels and epaulets.

## **BUTTONS:**

Four (4) 36 Ligne Gilt "P" buttons sewn on front 4" apart and one (1) 24 Ligne Gilt "P" button on each pocket flap.

#### **COLLAR:**

Shall not be over 1-7/8" wide in back when finished. To be stiffened with best quality Belgium elastic. Under collar of all wool collar cloth, closely padded.

#### **EDGES AND SEAMS:**

Edges to be single stitched 3/16". Plain seams, pressed open.

#### **POCKETS:**

Two (2) lower scalloped flaps, no pockets, two (2) breast pockets pleated patch pockets with scalloped flaps. Lower and breast flaps to button with gilt "P" buttons. One (1) inside reinforced breast pocket piped with same material 6" wide and 7" deep.

#### **POCKETING:**

Inside pockets to be Drill.

#### LINING:

Coat is to be fully lined with navy blue rayon or 70 Denier nylon.

#### **VENT:**

Shall be back center.

#### **BADGE TAB:**

Separate oval badge tab made of cloth about 1-1/2" wide and 2-1/4" long with two (2) metal eyelets, about 1-1/8" apart, sewn to the outside left breast of the coat, so that the lower point of the badge is 1" above the breast pocket button.

#### **BUTTONHOLES:**

All buttonholes, except shoulder strap buttonhole, shall be made to a full %" from the edges of the seam and pocket flaps. The ends of all buttonholes shall be bartacked. All buttonholes to be "cut after" machine made buttonholes. All thread used in making buttonholes shall be black silk, tailor's twist, colorfast and guaranteed against fading.

#### **SWEAT SHIELDS:**

A sleeve sweat shield of the same cloth as in the body of the coat, piped with rayon to be securely set under each arm over the lining.

#### **SHOULDER STRAP:**

To be sewn in sleeve seam directly on top of the shoulder. The strap shall come under the dollar and fasten with 24 Ligne metal buttons at the edge of collar. Cross stitched.

#### **OUTLETS:**

All body seams to have outlets of not less than 1". Turn up at sleeve cuffs to be no less than 21/2".

#### **CONSTRUCTION:**

Hymo, felt and canvas to be properly stayed together with edges taped and sewn into seams. Finest canvas, felt and hymo available and cut to fit the actual size of the coat. Heavy shoulder pads. All findings thoroughly cold water shrunk.

### LABELS:

There shall be permanently affixed size label and care instruction label. Garment must be made in the United States of America and bear a union label.

#### **BUTTONS:**









# Class A Captains uniforms are the same as Lieutenants with the following exceptions:

## CHATTANOOGA FIRE DEPARTMENT DRESS PANTS UNIFORM SPECIFICATIONS

#### **MODEL NUMBER:**

Fechheimer Brothers Company Dress Pants #38200 or equivalent (colors must match what we currently use)

#### **FABRIC:**

100% Textured Polyester Serge Weave. 11.75 oz/Linear Yard (60-61" width) Grab Tensile: 154 lbs. Warp -173 lbs. Fill. Tongue Tear: 141bs. Warp -12 lbs. Fill fabric shall incorporate a permanent washable and dry cleanable moisture transport/soil release finish. Color: Navy Blue

#### **DESIGN:**

Trouser shall be manufactured from a men's uniform trouser pattern. The trouser styling shall incorporate a plain front, two (2) quarter top front pockets, and two (2) hip pockets. Trouser to be straight leg style.

#### **POCKETING:**

The pocketing shall be 70% Polyester/30% Cotton, 2.9 oz. Per square yard (60" width) with a minimum 78 x 64 count. Pocketing must have a durable press finish and the color of the pocketing must be black.

### **POCKET DESIGN:**

The two (2) front pockets will be quarter top style with a minimum opening of 6" and a minimum depth of 5-3/4" measured from the bottom of the opening. Front pockets to have straight bartacks (use of triangle bartacks will be cause for rejection) at the top and bottom of pocket openings. Pockets shall be constructed using the stitch, turn, and topstitch method. Pocket facings to be made of the basic fabric and must measure a minimum of 3" in width at the top.

The two (2) hip pockets shall have a minimum opening of 5-1/2" and a minimum depth of 5-3/4" measured from the bottom of the pocket opening. Hip pockets shall be constructed using the double welt method on a REECE PW Machine. The welts shall be finished in such a manner that there is no topstitching (topstitched hi pocket welts shall be cause for rejection). The corners of the hip pocket openings shall have firm straight bartacks for reinforcement (triangle bartacks are unacceptable). Hip pocket facings to be made of basic fabric and have a minimum depth of %". The left hip pocket shall have a centered tab made of basic cloth inserted into the top welt with bartacks at the top and bottom of the tab to form an opening for a button. A button shall be located below the bottom welt corresponding in location with the tab.

#### WAISTBAND:

The waistband shall be constructed using the "closed method" and shall measure 2" wide when finished. The waistband curtain is to be made of the same fabric and color as the pocketing material and shall be

attached to the trouser with a Rocap Machine. The waistband must contain %" wide Ban-Rol to prevent roll over and have three (3) strand Snugtex to keep shirts tucked in. The waistband closure shall be accomplished with a crush-proof hook and eye. The hook and eye shall be reinforced with stays made of non-woven fabric that are anchored by the topstitching for the fly facing and curtain. This topstitching must be to the top of the waistband. The waistband must be topstitched 1/16" below the waistband seam for added strength.

#### FLY:

Trouser shall have a metal memory lock zipper. There shall be a French Fly tab closure on the inside of the right fly. The tab shall be double ply made of the basic cloth (tabs made of pocketing material or a "grown on" French Fly will be cause for rejection. The right fly shall be lined with the same fabric as the waistband curtain and pocketing. The fly lining shall be sewn to the left fly below the zipper in a neat and durable manner. A button shall be located on the left fly corresponding with the French Fly tab to provide a clean and comfortable closure. There shall be a firm straight bartack at the bottom of the fly going through the zipper tape.

#### **BELT LOOPS:**

There shall be a minimum of seven belt loops %" in width of double thickness. Each loop must have a non-woven interlining. Allloops (except for the back center loop) must be sewn into the bottom of the waistband (dropped" belt loops are cause for rejection) and the top of the belt loops shall be caught into the waistband curtain seam with a Rocap machine. The bottom of the center back loop shall be tacked to the trouser and the top of the loop tacked to the outside of the waistband.

#### SEAT:

Seat outlet to measure a minimum of 2-3/4" to allow for alterations. Seat must be sewn with a Tandem Needle Machine.

#### STITCHING, PRESSING & FINISHING:

Trouser must be stitched with matching thread and all stitching to show must be 10-11 stitches per inch. Trouser must be neatly pressed on Hothead Presses and properly shaped. Outseams and inseams must be cleaned and finished to eliminate loose threads.

#### LABELS:

Trouser must have a care label permanently affixed that also indicates the size. A paper ticket showing the size, fabric content, cut number, and WPL number must be on the outside of the waistband.

Garment must be made in the United States of America and bear a union label.

#### **STOCK SIZES:**

Trouser must be available from stock in the following sizes:

Regular rise:

28 54 (Even sizes only above 38)

Long rise:

32 42 (Even sizes only)

Short rise:

28 40 (Even sizes only)

#### CHATTANOOGA FIRE DEPARTMENT DRESS SHIRT UNIFORM LONG SLEEVE SPECIFICATIONS

#### MODEL NUMBER:

Elbeco Paragon Plus or equivalent

#### **FABRIC:**

Horace Small "3D" stretch poplin with micro comfort finish. 4-1/2 oz. Square yard. 65% Dacron Polyester/35% Combed with 9-11% filling stretch to enhance comfort and mobility. Protected by licensed Scotchgard meeting 3M test standard.

#### CREASING:

Pockets, pocket flaps, collar band and shoulder straps to be die creased to give uniform shape and size. The two military creases in front and three in back of each shirt must incorporate a permanent modified silicone crease produced by the "Lintrak System".

#### FRONT:

Left front to have a self-fabric center pleat 1-1/2" wide extending from collar band to bottom of shirt. It shall have 2 rows of stitching 7/8" apart. The center pleat to be lined with 100% Polyester. A selflined button stand 7/8" wide shall be placed on the right side and extend from collar band to bottom of shirt. There shall be six front and one collar button. Metal Button Feature.

## **COLLAR:**

To be die cut. The back of the stand is to measure 1-1/2". The points are to be 2-7/8" in length and top stitched  $1_{/4}$  from edge. The interlinings are to be 100% Polyester, 250 Denier. The inside collar band will be of self-goods, cut in filling direction to enhance stretch properties. Permanent collar stays of proper length are to be sewn inside collar so that no stitches are made through the bottom leaf. The stand shall fasten with one button.

#### YOKE:

Two ply yoke of self-goods in filling direction to enhance stretch. Yoke shall measure approximately 2-3/4" at bottom center of band and 2-1/2" at outside edge of yoke. 1/16" topstitch.

#### **SLEEVES:**

Each sleeve shall have 2 plackets, 1-1/4" wide both top and bottom, with one button placed on the placket approximately 2-1/2" above the top of the cuff. Sleeve setting and closing shall be done with an overedge and safety stitch. Cuffs to close with 2 buttons and buttonholes, be 2-7/8" wide and have 114" topstitching on the edge. They shall be lined with woven, unbleached 100% Cotton interlining.

#### **POCKETS:**

Two breast pockets finishing 5-3/8" wide and 5-3/4" long to have mitered corners. Both pockets shall have a 1-1/2" box pleat stitched top and bottom to prevent spreading. Left pocket to have sewn through pencil opening 1-3/8" wide. Velcro 3/8" wide and 1" long to be placed on each pocket to secure Velcro placed on each flap.

#### **FLAPS:**

To be die cut, creased and scalloped, finishing 5-1/2" in width, 2-3/4" in length at the center and 21/2" at each side. Flaps to be placed *V4*" above the top of each pocket and have one centered buttonhole with button. The left flap to have a pencil opening 1-3/8" in width. Velcro 3/8" wide and 1" long to be placed on edges of each flap to secure Velcro to placed on pockets. Flaps to be lined with crease "n" tack interlining.

#### **BADGETAB:**

Inside sling type of self-goods approximately I" wide to extend from joining seam to pocket of left front. To have two small, uncut buttonholes 1-1/4" apart with lower buttonhole approximately 1" above the flap.

## **SHOULDER STRAPS:**

To be sewn into sleevehead seam and measure, approximately 1-7/8" tapering to 1-1/2" with end pointed. Straps to b set approximately I" from the collar seam. They shall be box stitched to shoulders with a row of cross-stitching 2" from sleeve head and diagonally sewn from each end of the seam to the sleeve.

Shoulder straps are to be die cut, creased and lined with crease "n" tack.

#### **SHIRT LABELING:**

Two pointed breast pockets with topstitched pointed flaps. Topstitched shoulder straps. Back to have double yoke of shirting material ¼" double needle topstitched. Work wear industrial style shirt construction is unacceptable and shall be cause for rejection.

# **COLLAR & STAND:**

Collar points to measure 2-7/" long with ultrasonically fused-in Mylar stays. Collar to have woven interlining of #250 Dacron. Stays to be 2 1/2" long, 3/8" minimum width, and to be fused to under side of collar interlining. Stays applied directly to collar material itself unacceptable. Collar height at rear 1-1/2". Collar topstitched 1/4" off the edge. Collar stand to measure 1-5/16" at rear and band to be interlined with "Crease-N- Tack." Collar stand to close with single button and buttonhole. Collar material itself (top or underside) shall have no fusing to Mylar stays or collar interlining.

#### FRONT:

The right front shall have top center placket 1-1/2" wide with two double rows of stitches 7/8" apart. The shirt shall have 5 snaps concealed by the placket with 5 well sewn buttons attached to the top center placket; spaced 3 1/2" apart except the spacing between the neck button and first button on the front, which will be approximately 3". Top center placket to have woven interlining of #250 Dacron. Non-woven interlining unacceptable and shall be cause for rejection. The fronts shall be joined to the yoke so that both raw edges of the yoke are turned under, with the front sandwiched between, and then all three are stitched down with a 1/16" raised stitch. Safety stitch joining unacceptable.

### SHOULDER STRAPS:

Shoulder straps to be two-piece pointed, 1/8" topstitched and to be set on yoke with leading topstitch conforming with front joining seam. To measure 2" at sleeve tapering to 1-3/8" and set not more than 1/2" from collar set seam. Cross-stitched approximately 2" from sleeve seam. Shoulder strap interlined with #250 Dacron. ### POCKETS:

Collar, pocket flaps, cuffs and shoulder straps are made with conventional construction. Top ply, bottom ply and interlining are first stitched together, then turned right side out and finally topstitched.

### STYLE:

To be Flying Cross Model 9820. Dress style, top center placket front with hidden snap closure, full cut tapered fit, banded collar, long sleeves with square cuffs, and dress shirttail. Two pointed breast pockets with topstitched pointed flaps. Topstitched shoulder straps. Back to have double yoke of shirting material ¼" double needle topstitched. Work wear industrial style shirt construction is unacceptable and shall be cause for rejection.

### COLLAR & STAND:

Collar points to measure 3" long with ultrasonically fused-in Mylar stays. Collar to have woven interlining of #250 Dacron. Stays to be 2 3/4" long, 3/8" minimum width, and to be fused to under side of collar

interlining. Stays applied directly to collar material itself unacceptable. Collar height at rear 1-1/2". Collar topstitched 1/4" off the edge. Collar stand to measure 15/16" at rear and band to be interlined with "Crease-N- Tack." Collar stand to close with single button and buttonhole. Collar material itself (top or underside) shall have no fusing to Mylar stays or collar interlining.

#### FRONT:

The left front shall have top center placket 1-1/2" wide with two double rows of stitches 7/8" apart. The shirt shall have 6 snaps concealed by the placket with 6 well sewn buttons attached to the top center placket; spaced 3 ¾" apart except the spacing between the neck button and first button on the front, which will be approximately 3-1/2". Top center placket to have woven interlining of #250 Dacron. Non-woven interlining unacceptable and shall be cause for rejection. The fronts shall be joined to the yoke so that both raw edges of the yoke are turned under, with the front sandwiched between, and then all three are stitched down with a 1/16" raised stitch. Safety stitch joining unacceptable.

### SHOULDER STRAPS:

Shoulder straps to be two-piece pointed, 1/8" topstitched and to be set on yoke with leading topstitch conforming with front joining seam. To measure 2" at sleeve tapering to 1-3/8" and set not more than 1/2" from collar set seam. Cross-stitched approximately 2" from sleeve seam. Shoulder strap interlined with #250 Dacron. No buttonhole in shoulder straps. Buttons to be sewn on top of shoulder strap, through the shoulder so that the point of the strap is held to the shoulder by the button. Edge stitched shoulder strap construction unacceptable.

### POCKETS:

Two pointed breast pockets. Pocket to measure 5-1/4" wide, 6-1/8" deep at center point, 55/8" at sides. Breast pockets are set to shirtfront with  $\frac{1}{2}$ " double needle stitching. Each pocket to have hook Velcro, 3/4" long by  $\frac{1}{2}$ " wide, positioned on each edge of pocket to correspond with outer flap edges as specified. Velcro to be stitched all sides and to be sewn through pocket and shirt for added reinforcement.

#### FLAPS:

Two-piece pointed design to measure 5-1/2" across and 2-1/2" in depth at center point, 1-5/8" at sides. Secured to shirtfront approximately 3/8" above pocket. Left flap to have invisible pencil opening 1-1/2". (Stop & start stitching for pencil opening unacceptable and shall be cause for rejection.) Flaps to be 1/4" double needle topstitched. Flaps to have woven interlining of #250 Dacron. Creased and edge stitched pocket flap construction unacceptable. Under side of the flap to have looped Velcro 3/4" long by 1/2" wide stitched all sides, positioned on outer edges of both pocket flaps to secure with corresponding Velcro strips on shirt pocket. Each flap shall have a button centered on the sewn crease; no buttonhole in pocket flap.

### **SLEEVES:**

Sleeve vent shall be a minimum of 4-1/2" long with a continuous facing.

#### CUFFS:

Two piece ½-inch hemmed cuff with 1/8" topstitching. Cuffs to measure 3" in depth with squared corners. Cuffs to have one female snap corresponding to two male snaps set horizontally on the cuff so cuff may be adjusted for fit. Cuffs to have woven interlining of #250 Dacron.

#### **BUTTONS:**

First grade 19-ligne pearlescent.

#### SEWING:

Collar to be 1/4" topstitched. Shoulder straps and cuffs to be 1/8" topstitched. Yoke, top center placket, pocket flaps and pocket to be 1/4" double needle topstitched. Sleeve inserting and side close felling seams are to be safety stitched.

#### THREAD:

All sewing threads to be color fast Nomex to match.

### INTERLININGS:

Collar, cuffs, pocket flaps, shoulder straps and top center to be interlined with #250 Dacron. Collar band interlined with "Crease-N-Tack".

#### **MILITARY CREASES:**

There shall be five stitched-in sharp military creases on all shirts. One crease on each front to be centered vertically. Front creases shall be through pockets and flaps. Spacing for three military creases across shirt back to be proportionate to the size of the shirt.

#### **CONSTRUCTION:**

Collar, pocket flaps, cuffs and shoulder straps are made with conventional construction. Top ply, bottom ply and interlining are first stitched together, then turned right side out and finally topstitched.

The successful bidder will supply the jacket with the following modifications all to be included in the price of the jacket:

The upper left chest shall have an embroider firefighter badge sewn on. (The badge will be supplied by the Chattanooga Fire Department)

The upper left sleeve shall have the Chattanooga Fire Department patch sewn on. (The patch will be supplied by the Chattanooga Fire Department)

The upper right chest shall have a black name strip approximately 5 inches long and 1 inch wide. (The name strip shall be supplied by the successful bidder) This name tag shall match the color of the jacket and can contain either gold or silver embroider letters depending on rank (Chiefs, Captains shall have gold letters all other shall have silver letters). The name strip shall have the name and rank of the Firefighter. First initial and last name will be acceptable.

Both the name strip and badge must be removable without damage occurring to the jacket.



# REQUIREMENTS FOR INSURANCE COVERAGE

The Contractor shall not commence work under these Contract Documents until he has obtained all insurance required herein nor shall the Contractor allow any Subcontractor to commence work on his subcontract until similar insurance required of the Subcontractor has been obtained by the Subcontractor. Insurance shall be placed by the Contractor with one or more insurance carriers licensed to do business in the State of Tennessee. Each insurance policy shall be renewed ten (10) days before the expiration date of the policy.

Certificates of insurance shall be filed with the City prior to commencement of the work. These certificates shall contain a provision that coverage's afforded under the policies will not be changed or canceled unless at least fifteen (15) days' written notice has been given to the city. The Contract shall not be binding upon the city until the insurance coverage required herein has been obtained and certificates have been filed with the City.

Adequate insurance coverage shall be maintained by the Contractor at all times. Failure to maintain adequate coverage shall not relieve the Contractor of any responsibilities or obligations under these Contract Documents. In the event any insurance coverage is canceled or allowed to lapse, the Contractor will not be permitted to prosecute the work until adequate and satisfactory insurance has been obtained and certificates of insurance furnished to the City. Failure to keep insurance policies in effect will not be cause for any claims for extension of time under these Contract Documents.

All such policies shall be subject to approval by the City Attorney. Should the City Attorney at any time in his sole discretion determine that the insurance policies and certificate provided may not be sufficient to protect the interests of the City because of the insolvency of the insurance company or otherwise, the Contractor shall replace such policies with policies meeting his approval.

The Contractor shall procure and maintain at his own expense, during the Contract Time, insurance as hereinafter specified:

Workmen's Compensation Insurance that shall protect the Contractor against all claims under applicable state workmen's compensation laws shall be maintained. The Contractor shall also be protected against claims for injury, disease or death of employees which, for any reason, may not fall within the provisions of a workmen's compensation law. This policy shall also include an endorsement providing coverage in all states in which work is performed. The Contractor shall require all the Subcontractors to provide similar Workmen's Compensation Insurance for all the Subcontractors' employees on the work unless such employees are covered by the protection afforded by the Contractor. The liability limits shall not be less than that required by statute.

<u>General Public Liability and Property Damage Insurance</u> that shall be written in comprehensive form and shall protect the Contractor against all claims arising from injuries including death, to members of the public or damage to property of others arising out of any act or omission of the Contractor or his agents, employees, or Subcontractors. In addition, this policy shall specifically insure the contractual liability assumed by the successful bidder to defend and indemnify the City of Chattanooga against such claims or suits.

To the extent that the work may require blasting, explosive conditions or underground operation, the comprehensive general public liability and property damage coverage shall contain no exclusion relative to blasting, explosion, collapse of buildings, or damage to underground property.

The comprehensive general public liability and property damage coverage shall also protect the Contractor against all claims resulting from damage to:

- 1. Private driveways, walks, shrubbery and plantings;
- 2. Public utility facilities; and
- 3. U.S. Government monuments.

The liability limits shall not be less than:

Bodily Injury \$ 500,000 each person

\$1,000,000 each occurrence

Property Damage \$ 250,000 each occurrence

\$ 500,000 aggregate

The general public liability and property damage insurance shall carry an endorsement in form satisfactory to the City to the effect that the Contractor shall save harmless the City from any claims and damage whatsoever, including patent infringement. General public liability and property damage insurance shall be kept in force at all times during the course of the work until such time as the work covered by these Contract Documents has been completed and accepted by the City.

Comprehensive Motor Vehicle Liability and Property Damage Insurance that shall be written in comprehensive form and shall protect the Contractor against all claims for injuries to members of the public and damage to property of others arising from the use of motor vehicles, and shall cover operation on or off the site of all motor vehicles licensed for highway use, whether they are owned, non-owned, or hired.

The liability limits shall not be less than:

Bodily Injury \$ 250,000 each person

\$ 500,000 each occurrence

Property Damage \$ 100,000 each occurrence

#### **Affirmative Action Plan**

- 5. This Plan or any attachments thereto shall further provide a list of all employees annotated by job function, race, and sex who are expected to be utilized on this project. This plan or attachment thereto shall further describe the methods by which the Contractor or Subcontractor will utilize to make good faith efforts at providing employment opportunities for minorities and women.
  - During the term of this contract, the Contractor upon request of the City, will make available for inspection by the City of Chattanooga copies of payroll records, personnel documents and similar records or documents that may be used to verify the Contractor's compliance with these Equal Opportunity provisions.
- 6. The Contractor will include the portion of the sentence immediately preceding paragraph 1 and the provisions of paragraphs 1 through 6 in every subcontract so that such provisions will be requested of each subcontractor. The Contractor agrees to notify the City of Chattanooga of any subcontractor who refuses or fails to comply with these equal opportunity provisions. Any
