  submitted in pencil and bids not submitted on the Bid Proposal Form will not be considered.
  All corrections shall be initialed and dated by the bidder representative. Bids that are
  submitted without being signed will automatically be rejected.
- Bid envelopes must be sealed and must indicate clearly the appropriate bid number, bid item, and bid opening date, as indicated on the cover sheet of the bid packet. Bids by Facsimiles and emails will not be accepted. The County is not responsible for delays occasioned by the U.S.
   Postal Service, the internal mail delivery system of the County, or any other means of delivery employed by the bidder. Similarly, the County is not responsible for, and will not open, any bid responses which are received later than the date and time indicated above. Late bid responses will be retained in the bid file, unopened.
- The Commission provides equal opportunities for all businesses and does not discriminate
  against any vendor regardless of race, sex, creed, age, disability, national origin or religion in
  consideration for an award. Bidders must abide by the provision of the American with
  Disabilities Act of 1990 and assure that in connection with the performance of work under this
  agreement that they are an equal opportunity employer and do not discriminate on the basis
  of race, sex, creed, age, disability, national origin or religion.
- All bidders must comply with applicable sections of the Alabama Competitive Bid Law, Code of Alabama, 1975.
- All bid amounts shall be submitted on the attached Bid Proposal Form. Amount quoted shall be delivered prices, exclusive of all federal or state excise, sales, and manufacturer's taxes.
   The Commission will assume no transportation or handling charges other than specified in the bid.
