SPECIFIC REQUIREMENTS

- 1. The vendor shall provide Model year 2020-2023 with manufacturers' standard equipment.
- 2. All items of standard equipment which are normally provided with each vehicle by the manufacturer hall be furnished unless such items are specifically omitted by the request for bid specifications.
- 3. The vehicle needs to be an SUV or Sedan
- 4. All options and/or accessories must be manufacturers' original equipment. No aftermarket options and/ or accessories shall be acceptable.
- 5. All options must be factory installed.
- 6. Must have no more than 65,000 miles
- 7. Must come with a warranty
- 8. All warranty service must be performed within a 70 mile radius from the Franklin County Prosecuting Attorney's Office AT 15 S Church St. RM 204 Union, MO. 63084
- 9. Vehicle shall come with owner's manual.
- 10. Vehicle shall come with proper form to apply for Missouri title and license including the Manufacturer's Statement of Origin and invoice.
- 11. Vehicle shall be delivered and/or picked up within one week from award date of this bid.
- 12. Delivery and/or pick up specifications of the vehicle will be one of the following:
 - a) Vehicle delivered to Franklin County Prosecuting Attorney's Office @ 15 S Church St. RM 204 Union, MO. 63084
 - b) Vehicle picked up at awarded vendor's location no more than 70 miles from the Franklin County Prosecuting Attorney's Office @ 15 S Church St. RM 204 Union, MO. 63084
- 13. If the awarded vendor cannot deliver and/or accommodate pick up for the Franklin County Prosecuting Attorney's Office within one week of the award date, The Franklin County Prosecuting Attorney's Office reserves the right to find the same or similar vehicle from another source.
