This addendum is hereby incorporated into the Bid Documents for the project referenced above. The following items are clarifications, corrections, additions, deletions and/or revisions to and shall take precedence over the original documents. Additions are indicated by <u>underlining</u>, deletions are indicated by <u>strikethrough</u>.

1. Page 21, item 1a.

<u>Ethanol-Free</u> Unleaded Gasoline, 89 octane rating. Must meet the specifications of the State of Florida, Department of Agriculture and Consumer Services, with minimum octane rating of: R + M/2 = 89. Non-ethanol Detergent type. E-10 is not acceptable.

- 2. Attached is a revised bid schedule editing the description of <u>ethanol free</u> 89 octane gasoline and updated placeholders for each type of fuel. Bidders must use revised bid schedule to have a responsive bid.
- 3. Answers to Bidders' written questions:
 - Q1: When is the award date?

A1: Daytona Beach City Commission makes the award. Don't have a definite date. It's based on the department review and how soon yet get it on a Commission agenda.

Q2: When is the first board meeting after the opening?

A2: April 4th would be the first opportunity to go before Commission, but no guarantee is made it will make that meeting.

Q3: Will decision be made before or at the board meeting?

A3: At a Commission meeting, then will take up to three weeks to fully execute a contract.

Q4: Can you make payment on invoices quicker than 30 days?

A4: Payment is made in accordance with Florida Statutes 218.70 "Prompt Payment Act".

4. All other terms and conditions remain the same.
