The scope of work outlined below will be completed by an accredited educational university. The work may be divided into two categories so that the Chattanooga Police Department may select the candidate(s) with the most experiential expertise in this particular field. Candidates may, but are not required to, provide a quote for both aspects of the work (Research and/or On-site partner), although the Chattanooga Police Department reserves the right to choose the candidate(s) they feel will best meet the objectives within the parameters of the grant.

Primary Work Assignments:

The selected vendor(s) will collaborate with the Chattanooga Police Department in analyzing relevant data, and guide the response to gun crimes. The data points, measurements, and resulting analysis will be provided in industry-standard increments which are useful in guiding a data-driven response to violence. Specific tasks include, but are not limited to, the following:

- Assist in data cleaning and preparation
- Run descriptive, time series, survival, regression, and logit analyses as they relate to the analytical strategy outlined in the CGIC Grant proposal
- Assist in tracking and updating key performance measures as outlined in the proposal. Data will be provided from CPD to research partners.
- Develop how-to guides for analytical techniques employed during the project that CPD analysts need
- Assist in providing updated reports to CPD
- Assist in writing reports grant reports for BJA
- Assist in writing final report for BJA
- Run spatial and temporal analyses as it relates to the analytical strategy outlined in the proposal

General Instructions

Section references are to the Internal Revenue Code unless otherwise noted.

Purpose of Form
