Project Description: The project consists of the reconstruction of a portion of the taxiway system and apron; and the rehabilitation of a portion of the taxiway system and apron.

Options: The base bid is the reconstruction of three connector taxiways and a portion of the apron; the rehabilitation by seal coat of a portion of the taxiway system; and rehabilitation by mill and inlay a portion of the apron. The additive alternative is a mill and inlay of a portion of the taxiway as a substitute for the seal coat.

The work requires the following licenses from New Mexico Construction Industries Division: Runway and taxiway Construction: GF-1 – Fixed Works, Airports or GF-98 – Fixed Works, Construct, alter, or repair fixed works facilities. Airfield Electrical: EE-98. Residential and commercial electrical wiring 5000 volts, nominal or less and Electrical distribution and transmission systems over 5000 volts, nominal. These licenses will be required at the time bids are opened by any contractor bidding on this work.

The procurement code, Sections 13-1-28 through 13-1-199, NMSA 1978 (as amended), imposes civil and criminal penalties for its violation. In addition, the New Mexico Criminal Statutes impose felony penalties for illegal bribes, gratuities and kickbacks.
