Description **GENERAL INFORMATION**

The City of Daytona Beach, Florida, will receive Offers online for **Pest Control Services Term Contract 2021 - Q 21129** until **2:00 p.m. on 11/29/2020**, Offers received after said time will not be accepted.

SCOPE:

The work generally consists of Pest Control Services for City facilities including insect and rodent control. Control is to be considered in terms of both short-term and long-term objectives. Short-term objectives would typically be to eliminate or reduce current unacceptable pest populations. Long-term objective would focus on the prevention of unacceptable pest populations and reduce the amount of pesticide applied and the frequency of applications. This contract shall cover all offices/buildings as listed on the Pricing Sheet.
