Thank you all for your interest in Spartanburg District 7's Pressure Washing Services Fixed Bid. Below are questions that I have received regarding the bid.

<u>Question 1</u> - If we wish to mark our Equipment as 'confidential' on page 15, how should we include this decoration?

<u>Answer</u>: A line has been added to the bid sheet giving the option to keep information confidential.

<u>Question 2</u> - On page 15, on the bidding schedule, there are four columns, Description, Unit of measure (which has blank entries), the maximum price per hour, and the Offeror's bid price, which I do understand we are to fill out. I'm asking about the column for Unit of Measure - is that the number of hours, or something else? If you could please clarify how to properly fill out that schedule.

Answer: The "Unit of Measure" column has been removed.

Question 3 - On page 13, number 3: "Contractors must rinse all flatwork so that no debris remains after cleaning" What is flatwork?
Answer: Flatwork are all surfaces that someone may walk on. We want to make sure it is safe for all entering or exiting a facility.

Question 4 - If we are among the awardees, do you recommend we reach out to Districts 1 and 2 soon thereafter, or should we wait for them to notify us of opportunities?

<u>Answer</u> – No, once the Statement of Award is posted, I will be sending Districts 1 and 2 everyone's information. All 3 districts will reach out to you on a as needed basis.

Question 5 - Will there be multiple contractors/vendors performing the job?

<u>Answer</u> – depending on the size of the job and the urgency of the job, there may be more than 1 vendor on site.

Question 6 - What is the previous contractor price (awarding price)?

<u>Answer</u> – This is the first time I have posted a bid for pressure washing services.

Question 7 – Is the hourly rate based on the number of laborers.

Answer – The fixed price rate should be a fully burdened labor rate PER PERSON.

Question 8 – What are the business licensing requirements?

HOME-BASED, RESIDENTIAL BUSINESS

If your business operates out of a residential or other non-retail property within the City, you are required to obtain a Home Occupation Permit prior to applying for a Business License.

Qualifying businesses in this category are not required to maintain a state-issued retail license. However, these businesses are urged to check with the South Carolina Secretary of State, Corporations Division at 803-734-2158 to inquire about the use of business names, trademarks, phrases, slogans, etc.

BUSINESSES WITH A STOREFRONT

Businesses located within the City of Spartanburg, or businesses that operate within the city limits, are required to purchase an annual business license. However, prior to obtaining a license, businesses operating out of a storefront or other non-residential space must contact our Planning Department to ensure that all applicable zoning, building, signage, fire, and safety codes are met, and must have received a final inspection by the City's Building Inspections Department. Upon completion of all inspections, a certificate of occupancy will be issued, the final step before licensing.
