  - Per construction drawing, Site B-5, sheet #11 of 13, pavement will be milled and overlayed, and "24" zebra crosswalk" will be reinstalled between the two proposed handicapped ramps on 11<sup>th</sup> St. N. There is no median on 11<sup>th</sup> St. N.
- Will Arlington County provide the VDOT LUP?
  - Yes, LUP was obtained already for B-5 and C-3 sites by the County.
- Please confirm that all tree protections are to be wood frame with plywood.
  - Confirmed, the contractor is to protect trees per DPR Design Standard 311300.14NS.
- Can you provide a website or documentation showing actual existing utilities?

- When actual conditions are different from the geotechnical report/information provided, will the contractor be entitled for additional compensation?
  - See General Conditions B.2, B.3, E.1
- Due to current supply chain issues, will the owner consider issuing a second NTP for delays due to material availability?
  - The owner will not be issuing a second NTP for delays at this time. See General Conditions F.3, G.4, G.7.
- Will the owner reimburse for existing utilities damaged if not shown on the plans?
  - See General Conditions B.2, B.3, E.1
- May we have a geotechnical report?
  - There is no geotechnical report produced for any of the sites
- Will you provide a staging area?
  - No, the scope of work for the individual sites is small enough not to warrant an individual staging area.
