SPECIFIC CONDITIONS

Bids must be received by **January 2, 2020 at 2:00 p.m**. Mountain Time. Any bids received after 2:00 p.m. will be kept on file unopened and will be opened and considered only in the event that all other bids are unresponsive.

SPECIFICATIONS

Curry County is requesting bids to lease four (4) new Motor Graders for the Curry County Road Department. Motor Graders must have no more than 100 hours. To be a responsive bid, the Motor Graders must meet or exceed the specifications listed in this document. Each bidder must attach the specifications for each motor grader and a breakdown sheet showing that all the specification has been met or exceeded along with the quotation sheets as required by the bid.

BASIC SPECIFICATIONS

Machine must be designed and built by the manufacturer.

Machine must be joystick operation.

Base Machine Weight must not be less than 40,380 lbs. Weight must include standard machine configuration, lubricants, coolants, full fuel tank and operator of 200 lbs.

Machine height to top of the cab must not exceed 132 in.

Machine length from the front outside edge tire to end of tow hitch must not be less than 351 in.

Machine Wheel Base (distance from front axle to mid tandem) must not be less than 241 in.

The rear frame must have two box section channels with an integrated bumper as standard.

Machine must have Front Wheel Assist standard with AWD, this model

disengages the transmission and provides hydraulic power to the front wheels only. When AWD is engaged, flywheel horsepower is automatically increased up to an additional 37 hp compared to the rear drive model.

Machine must have:

- Saddle Pin hydraulic activated
- Locks for cab doors
- Four (4) engine side shields
- A top tank radiator access door
- An engine coolant surge tank
- A hydraulic reservoir cap
- A fuel tank cap
- A tool box
- A rear hitch
- Pushblock/Counter Weights

ENGINE SPECIFICATIONS

Engine must:

- Be designed and built by the manufacturer
- Be a turbo-charged, direct injection, four stroke, 6-cylinder diesel engine.
- Be certified EPA Tier 4 Final and European Union Stage IV
- Be electronically controlled for more efficient fuel injection and fuel burn
- Achieve a rated power requirement with engine displacement not less than 9.3L (568 in³) for better performance and fuel economy.
- Increase its low idle speed to 1,000 rpm when the battery voltage is below 24.5 volts for more than 5 minutes to ensure adequate system voltage and battery reliability.

Altitude deration will not occur at altitudes less than 10,000 ft. The deration rate above 10,000 ft must be 1.5% per 1000 ft.

Peak engine power must not be achieved at an engine speed greater than 1800 rpm.

Rated engine power must not be achieved at an engine speed greater than 2000 rpm.

Engine must have a minimum torque rise of 47% from 2000 rpm to peak torque following SAE J1349 (net power with max fan).

Engine enclosure and daily service points must be accessible from ground level and grouped on the same side of the machine.

Engine fan must automatically adjust fan speed via carriable hydraulic fan pump to meet engine cooling requirements thus reducing demand on the engine, putting more horsepower to the ground, reducing noise, improving fuel economy and reducing heat.

Engine fan must be reversible in order to blow out radiator.

Engine must allow for at least 500 hours of operation between oil changes.

Engine must be isolation/resilient mounted to minimize sound and vibration.

Engine compartment doors must be lockable without the use of external locks.

Engine must automatically lower engine torque and alert the operator if critical conditions are detected.

Engine must have an air-to-air after cooler for superior engine performance.

Engine oil cooler must be a water to oil shell and tube cooler system.

Machine must have a 12000 hour coolant interval from factory.

The cooling package air intake must have 2.8 mm perforated inlet screen.

The charged air cooler (ATAAC) must have 6 fins per inch.

Economy mode must be available directly from factory to increase net efficiency.

Economy mode must be able to be enabled and disabled by the operator through the onboard Message Display.

Economy mode must be lockable via onboard programmable password protection.

DEF tank reservoir must have a heater to thaw DEF fluid.

DEF lines should be heated to prevent freezing during extremely cold ambient conditions.

An engine coolant heater must be available to assist in cold weather starting.

Ether starting aid must be available and must automatically meter ether

injection to prevent engine damage.

POWERTRAIN/TRANSMISSION

Transmission must be:

- Designed and built by the machine manufacturer
- A direct drive, power shift, countershaft type
- Be equipped with built-in self-diagnostic capability
- No less than 8 forward speeds and 6 reverse speeds (for added safety)
- Have 5 working gears between 0-10.6 mph, for dirt applications.
- Isolated/resilient mounted to reduce sound and vibration.

A controlled throttle shifting system must be standard to smooth directional gear changes without use of the inching pedal.

Electronic Throttle Control (cruise control) must be standard and must be controlled by a push button, located on a 3-axis joystick as standard on the right joystick control for resuming and decreasing throttle set.

Electronic Throttle Control modes, set and accelerate functions must be located on the right control column for easy access.

A load compensating system for the transmission must be standard to ensure consistent shift quality in all applications.

An automatic Differential Lock/Unlock feature must be standard and must not have speed, shuttle shifting or tandem spinning restrictions for engaging/disengaging. System must be load-sensing for optimal performance.

Automatic mode must not be overridden via manual intervention for optimal performance and to prevent unintended differential engagement.

Differential Lock/Unlock must be electro-hydraulically controlled, as standard feature.

Differential Lock/Unlock must be a multi-disc design.

Final drive must be a planetary design.

The rear axle must be a bolt-on modular design offering easy access to differential components, improving serviceability and contamination control.

Machine must be equipped with an electronic inching pedal for improved modulation and machine control.

Machine must be equipped with electronic over-speed protection to prevent the engine and transmission from over speeding, as a standard feature.

Machine must have no drive shafts that cross over the articulation hitch.

An autoshift transmission option must be available on all forward and reverse gears.

STEERING & IMPLEMENT CONTROLS

Joystick is required to operate the machine.

Joystick Steering capabilities must be ISO 5010:1992.

Machine must employ a friction pack style steering mechanism, utilizing the follow steer concept.

The left 3-axis joystick must control wheel lean with individual left and right wheel lean buttons as standard.

Primary steering must be achieved via a left-hand, multifunction, 3-axis joystick as standard, using an intuitive steering control system that automatically adjusts steering sensitivity as machine ground speed increases.

Articulation to the right or left must be achieved by a multifunction, 3-axis left joystick with the twist of such to the right or left by the left-hand, multifunction, 3-axis joystick.

An articulation return-to-center button on the left-hand, multifunction, 3-axis joystick must return the machine to a straight frame position from any articulation angle with the touch of a single button.

The right 3-axis joystick must primarily control the Drawbar, Circle and Moldboard.

Machine, Drawbar, Circle and Moldboard must be control and must be achieved via a right-hand multifunction, 3-axis, joystick, including moldboard slide and tip, drawbar center shift through a 4-way hat switch and circle turn by a left or right twist intuitively.

Blade lift cylinders must be individually controlled by the multifunction, 3-axis joysticks; lift and drop of cylinders must be achieved by the forward and back motion of the respective joystick. Forward (left joystick) lowers left lift cylinder, back (left joystick) raises the left lift cylinder, forward (right joystick) lowers the right lift cylinder and the back (right joystick) raises the right lift cylinder.

Joystick controls must be mounted to electronically adjustable pedestals, which are hard mounted to the cab floor, independent of the operator seat.

Secondary steering must have a primary and secondary power supply in the event the primary source is lost.

Transmission direction control must be a 3-position rocker switch for selecting forward, neutral, and reverse incorporated into a single, 3-axis, multi-function, left-handed joystick control.

Transmission gear selection must be controlled by dual push buttons for up shifting and downshifting and must be incorporated into a single, 3-axis, multifunction, left-hand joystick control.

Manual Differential Lock/Unlock must be operator controlled, via a push-button, located on a single, 3-axis, multi-function, right-hand joystick control.

The machine must have two (2) redundant articulation sensors.

Two (2) redundant sensors must be standard in the steering cylinders (one in each).

Three (3) redundant sensors must be provided in the steering joystick for additional safety.

Up to five (5) additional auxiliary hydraulic functions that could include: Ripper, Front Lift group.

BRAKES

Machine must have primary and secondary service brakes.

The entire braking system must meet all requirements of ISO 3450: 1996.

Two (2) separate left and right hydraulic brake accumulators must be standard for safety.

Parking brake must be multi-disc, oil-cooled, spring-applied, hydraulically released, sealed, adjustment-free, and must be serviceable without removing the transmission.

Service brakes must be multi-disc, oil-cooled and completely sealed; they will also provide access to check and determine brake wear without removing or disassembling the brake assembly.

Service brake disc surfaces must be grooved and carry oil between discs and plates with brakes fully applied.

Services brakes must be hydraulically actuated, utilizing dual independent brake circuits.

Brakes must be continuously pressurized, filtered and oil cooled.

Machine must have individual brake pods for each rear wheel, located at each rear wheel inside the tandem box, independent of tandem chains.

Compensation components must be required at all four tandem brake pods in addition to the brake wear indicator.

Brake line protection, including tandem walkways and hydraulic brake line guarding, must be required to prevent line damage.

Service brakes must provide a minimum of 620 in² of friction material surface area at each of the four (4) tandem wheels to eliminate braking loads on the power train.

HYDRAULIC SYSTEM

A standard triple-redundant hydraulic relief system must protect machine hydraulic components.

Hydraulic implement pump must produce between 0 and 55.7 gal/min of oil flow at 1,800 RPM.

Hydraulic system must be a closed center, load sensing type with a variable displacement, axial piston-type pump.

Hydraulic system must be fully sealed, using Duo-cone and O-ring face seals to prevent leaks, contamination, and spillage.

The hydraulic tank must have a baffling system to reduce potential pump cavitation.

The maximum hydraulic system pressure must be no more than 3,500 psi.

Implement valves must be electro-hydraulic, designed and built by the machine manufacturer.

Implement pump must not be mounted under the cab floor, minimizing sound and vibration.

Implement valves must be proportional priority pressure compensating for consistent response when multi-functioning any combination of implement controls and independent of engine speed.

Implement pump must be solely dedicated to implement controls and not shared with any other components.

Lock valves must be integrated into the main implement valve to prevent cylinder drift.

The hydraulic stand-by pressure must be no more than 885 psi at 1,800 RPM.

There must be a provision to install up to fifteen (15) modulating hydraulic valves, controlled by two (2) multifunction, 3-axis joystick controls and auxiliary controls inside the cab.

Hydraulic valves must not be mounted under the cab floor, minimizing sound and vibration.

Left and right blade lift cylinders must have independent float capability, actuated by two (2) multifunction, 3-axis joystick controls inside the cab, as a standard feature.

A sight gauge must be provided for checking hydraulic reservoir fluid.

Hydraulic oil change service interval must be no less than 6000 hours with oil sampling.

Hydraulic system must have a separate oil tank solely dedicated to the implement pump.

FRONT AXLE AND TANDEMS

Front axle oscillation must be no less than 32 degrees total per side, 16 degrees up and 16 degrees down.

Front axle must be an arched design for maximum ground clearance.

Wheel spindle must be a "live" spindle design and rotate inside a sealed (with Duo-Cone seals) compartment with lightweight oil for lubrication of the bearings.

Front spindle must be heat induction hardened.

Front wheel spindle bearings must be a double-tapered design with the larger diameter bearing mounted closest to the centerline of the front tire.

Front wheel spindle maintenance intervals must be no less than 2000 hrs.

Front wheel steering angle must be no less than 50.0 degrees left or right.

Maximum front wheel lean must be no less than 18 degrees left or right.

Machine turning radius must not exceed 25 ft. 7 in. using front steering, full articulation and unlocked differential.

Distance between center of tandem wheels must be no greater than 60.0 in. for optimum clearance and mobility.

Tandem drive chain pitch must not be less than 2.0 in (50.8mm).

Tandems must be capable of oscillating 15 degrees front tandem up and 25 degrees front tandem down, with full machine articulation and having no interference between tandem wheel and machine structure.

Electronic and Mechanical steering stops located at each wheel and steering cylinder relief valves must be present to prevent steering system damage during normal operation.

Steering tie rods ends must be heat induction hardened.

Machine must provide two (2) steering cylinders for maximum steering force.

With a ripper, the machine must have a minimum ramp angle of 15.9 degrees.

TIRES AND RIMS

A 10 in (25.4cm) by 24 in (60.96) size 3-piece tire rim must be standard to provide mounting for 14.00-24 tires and 14.00R24 conventional radial tires.

OPERATORS STATION

A 42,075 BTU/h heater must have an integral pressurizer and three-speed fan along with A/C.

Cab must have an angled floor design allowing direct visibility to the moldboard.

Seat must be a cloth-covered suspension seat with 3 in. retractable seat belts, with adjustments for fore-aft position, seat height, seat back angle, thigh support, and lumbar support.

An enclosed cab with ROPS (Rollover Protective Structure) according to ISO 3471: 1986-1997 must be provided.

Cab doors must have a hold-open clasp with a ground-level release in addition to a release in the cab.

Cab must have fixed front window of laminated glass with intermittent wiper.

FOPS (Falling Object Protective Structure) must be provided according to ISO 3449.

Machine must have no less than 17 adjustable vents, positioned to direct air

to front windows and operator.

Radio ready arrangement will include a 24V to 12V converter, two speakers, antenna and wiring.

An instrument cluster must be provided that includes a speedometer, tachometer, coolant temperature, fuel and articulation angle gauge.

Operator cab fresh air-filter must be accessible for clean out and replacement from outside of the cab at ground level.

A real-time information system must monitor all system data and alert the operator of any faults through a digital text display. This performance and diagnostic information system must be programmable for multiple languages.

Left and right side cab doors must be provided.

Wipers must be provided on front, side and rear windows.

Digital machine hour meter must be provided.

An electronic message system must provide real-time machine performance and diagnostic data.

The forward visibility must be continuous and unobstructed glass from roofline to floor providing visibility of the blade, heel and toe, back of the cutting edge, and front tires.

Access to cab must be three (3) anti-skid steps.

Cab must have cup holder, personal cooler holder/storage compartment for operator's manual, with a molded floor mat.

Window washer fluid bottle refill spout must be located external of the cab.

DEF gauge must be visible to the operator at all times.

An auxiliary control pod, with implement float control capability, must be available.

Auxiliary controls must be available for control of attachment implements and/or work tools and must be programmable via computer software.

Auxiliary controls must be a finger-tip control type and located beside the right-hand joystick control.

An auxiliary, 2-axis joystick must be available for control of a snow wing.

An Integrated Cross Slope System must be available from the factory in order to ensure proper calibration and installation for improved accuracy and performance.

A rear vision camera must be provided with capability to view at all times without interfering with the gauge and diagnostic display.

A rear sun shade.

A rear defroster fan.

An air suspension seat.

A heated or both heated/ventilated seat.

CIRCLE & MOLDBOARD

Drawbar, circle, and moldboard must be controlled with a maximum of two (2) multifunction, 3-axis joysticks, as standard.

Drawbar wear strips must be replaceable drop-in inserts made from nylon composite material, replaceable and adjustable from the top of the drawbar plate via removable cover plates.

The drawbar must feature welded protective wear plates to prevent lift group contact with the primary drawbar structure.

The moldboard must be at least 14ft long, 24in high and no less than 7/8in thick.

Moldboard must have a bank slope angle capability of at least 90 degrees to both sides.

Moldboard must have no less than 16.3 in arc radius (blade curvature) for optimum productivity.

Moldboard must have a hydraulic tip control through a range of 40 degrees fore and 5 degrees aft.

Moldboard wear strips must be adjusted with lock screws, providing shim-less adjustment capability both vertical & horizontal.

The moldboard must be pre-stressed during manufacturing for superior strength and durability.

Moldboard side rails must be constructed of a heat-treated, high carbon steel and have replaceable bronze allow wears inserts on top and bottom.

Circle must be a single piece, rolled-ring forging with raised wear surfaces on the top and bottom.

Circle must be rotated by a hydraulically driven motor (pinion gear) with a minimum circle pinion torque capability of 44253 ft-lb.

Circle teeth contact surfaces must be induction-hardened on the front 240 degrees of the circle.

Blade lift and center shift cylinders must have replaceable bronze-alloy wear inserts in the ball sockets with removable shims to insure the ability to remove free play throughout the useful wear insert life.

The lift cylinder casting must be welded to the front frame for added strength and structural integrity.

The standard mounting hardware for cutting edges and end bits must be 3/4 in.

All seven (7) Link Bar positions have replaceable bushings.

Linkbar pin must be separate from pin pulling mechanism for easier service and lower O&O costs.

The draft frame pivot connection must have a single ball stud with grease zerk. Ball stud must be bolt-on, shimable and adjustable to allow for quick and easy field serviceable design.

Three (3) sideshift anchor positions must be provided for extended reach capacity as standard.

Pinion gear must be separate from the Pinion Shaft to allow for a quick and easy serviceable design.

Circle outside diameter must be no less than 60.2 in.

There will be no more than six (6) replaceable wear inserts between the circle and drawbar providing at least 163 in² of wear surface area.

Blade lift accumulators must be provided, protecting cutting edge and other components from damage from shock loads as an option.

ELECTRICAL

Machine must have a 145 amp-hour, 1125 CCA heavy-duty battery.

Machine must have a minimum 115-amp alternator at 24 volts provided which is brushless for increased life and durability.

Six (6) 3 x 3 in. LED mounted cab lights must be provided.

Starting system must be a 24V direct electric type.

LED white reversing lamps and LED stop lamps must be provided.

Electrical system must have a master disconnect switch with a removable key (in addition to the ignition switch), accessible from the ground level.

All core machine systems must be electronically connected, optimizing performance and preventing machine damage.

All wiring must be arranged and located so as to facilitate regular visual inspections, not to be in contact with hot surfaces and not routed with other service lines (e.g. fuel, oil, etc.).

All harnesses/cabling are secured with clipping clamps providing a gap between the conduit/harness and the mounting surface preventing material build-up.

Power must remain available upon key off to purge DEF system lines and protect components.

Lighting arrangement of:

- Two (2) (3 X 3 in) LED mounted on the right-hand side of the car roof bar to illuminate a snow wing
- Two (2) (3 X 3 in) LED heel work lamps mounted underneath the cab
- Two (2) (3 X 3 in) LED mid-frame toe lamps must be available to illuminate the moldboard and surrounding area
- Two (2) (3 X 3 in) LED ripper work lamps
- High and low bar LED headlights with front turn signals
- An amber LED high-speed strobe beacon
- 24V to 12V converter with 25-amp capacity

SERVICEABILITY

Machine must have a lockable swing-out cooling fan housing featuring a latch-style mechanism (must not be of a bolted design), allowing easy access to cores. Ability to open/close must be ground level accessible, eliminating need to climb on the machine.

The dip stick for checking transmission fluid must be at ground level.

Hydraulic tank site gauge must be readable from the ground.

Hydraulic tank filter must be a cartridge style filter providing a separate filter element, housing, and drain valve for quick and clean servicing.

Ability for ground level fueling must be provided.

Sampling ports must be accessible from the tandem level and provide access to the engine, hydraulic, coolant and fuel ports.

A two-way communication tool must give service technicians easy access to stored diagnostic data and allow configuration of machine parameters.

Machine must provide three (3) points of contact on all areas of the machine, for mounting and dismounting.

The articulation joint must have a mechanical locking device to prevent frame articulation while servicing or transporting the machine.

The left and right side tandem case assemblies must be covered with punched steel plate to provide an adequate platform for standing and walking.

Engine oil filter must be a 500-hour, vertical spin-on.

Engine primary and final fuel filters must have a 500-hour service replacement interval.

Engine must have a primary fuel filter with a fuel water separator and electronic sensor, quick release dual stage filter and primer pump.

The centralized lube bank must be at the articulation joint to give access to difficult zerks.

Transmission filter restriction indicator must be displayed in the cab.

Lock out tag out capabilities must be provided as standard to increase the safety levels during down time. This ensures that an energy isolating device and the machine which are being work on cannot be operated.

The DEF tank fill must be located on the same side of the fuel tank fill, and be easily accessible from the ground level.

A guard to protect the machine's transmission from debris.
