The Jackson County Board of Commissioners will be accepting sealed bids for the following property until April 26, 2018 at 2:00 PM. At that time, the sealed bids will be opened and read in the County Manager's Conference Room of the Jackson County Administrative Building at 67 Athens Street, Jefferson, Georgia 30549.

The Jackson County Board of Commissioners declared the following property surplus for the purpose of making the property available for sale to the public:

Certain real property located off Hwy 124 identified as Tax Parcel 105 001D.

Legal Description of Property: All that tract of or parcel of land lying and being in the 248 G.M.D., Jackson County, Georgia, containing 49,881.5 square feet, more or less, as shown on plat and survey of Patton-Boyer, Inc., dated November 18, 2004, recorded in the Office of the Clerk of Superior Court of Jackson County, Georgia, in Plat Book 63, Page 201. For a more detailed description of said tract, reference is hereby made to said plat as recorded, subject to all existing easements and rights of way for public and utilities now in use.

All bids should be submitted using a form provided by the Purchasing Department and should be completed fully and signed.

Bids will be opened, evaluated and submitted to the Jackson County Board of Commissioners for award.
