Questions and Answers

- Do you have approved manufacturers for both the standing seam panels and the underlayment or are we allowed to use our preferred manufacturer?
 No manufacturers have been pre-approved. You may use any appropriate manufacturer
- Can you confirm the panel profile width and rib height you would like?
 Panels come in 12", 16" and 18" with rib heights at 1-1/2" to 2". The preference will be relative to cost.
- Are you wanting a bid for Galvalume mill gray panels or a bid for painted kynar panels which you can select the color for?
 Galvalume
- The advertisement for bids states the bid date is November 17th, 2023, but the first page of the bid document states the bid date is November 22, 2023. Please clarify.
 Bids are due on November 22, 2023.

On page 11 of the specification the scope states that the roof panels are to be 24 ga metal roof system and paragraph 10.c states a 20 year WTW. Only aluminum panels will meet the warranty requested due to the location of the bldg being so close to either salt or brackish water. Please advise.

Panels should be 24G Aluminum Standing Seam.

1.) Page 11 note 2.b requests a 1 year installer warranty but note 10 on page 11 states a 2 year
6. installers warranty. 2.) Page 11 note 2.a requests a 10 year manufacturers warranty but page 13 note 10.c states a 20 year. Please advise.
