

# **INTRODUCTION:**

This is a Request for Proposal for emergency power generators, associated equipment and installation. Instructions for preparation and submission of a Proposal are contained in this packet. Proposals must be typed or printed in ink.

There will be a **MANDATORY** Pre-Proposal Conference held at Rockdale County Administration Building, Room 106, 958 Milstead Street, Conyers, GA 30012, at 10:00 a.m., local time, <u>Wednesday, August 26,</u> <u>2015</u>. Site visits to the four (4) locations will follow the meeting. Any questions and/or misunderstandings that may arise from this RFP must be submitted in writing and forwarded to the Procurement Officer at the above address or by email. It shall be the Proposers responsibility to seek clarification as early as possible prior to the due date and time. *Any contractor who intends to submit a Proposal is required to attend this meeting*.

## **QUESTIONS AND CLARIFICATIONS:**

You should submit your questions and/or requests for clarifications about this RFP no later than <u>2:00 p.m.</u>, <u>local time, Friday, August 28, 2015</u>. Written responses from the County to the questions it receives will be in an addendum and posted to the County's website at <u>www.rockdalecounty.org</u>, Bids, RFPs and Announcements/Current Bids.

Any discussions or documents will be considered non-binding unless incorporated and issued in an addendum.

# QUANTITIES

The quantities listed in the Proposers Response Schedule are provided as an estimate for proposal purposes. The County will not be obligated to quantities beyond actual needs.

# LOCAL VENDOR PREFERENCE POLICY

The Rockdale County Board of Commissioners adopted a Local Vendor Preference Policy on March 26, 2013. The policy will apply to all qualified Invitations to Bids and Request for Proposals after May 1, 2013. The Local Vendor Preference Policy allows Rockdale County vendors to get an extra 5 points on the evaluation criteria scoring for Request for Proposal. The Policy will give the local bidder the opportunity to match the price of a non-local vendor's bid price if they are low and within 5% of the low bidder's price on Invitation to Bids. # ENERGY EFFICIENT, RECYCLING, AND WASTE REDUCTION PURCHASING POLICY

Policy #R-2015-08 includes the following language:

The Rockdale County Board of Commissioners only purchases energy star rated equipment and appliances that are economically responsible and reduce resource consumption and waste within federal, state, and local laws. The County will only purchase recycled copy, computer, and fax paper with at least 30 percent recycled content.

#### **QUALIFICATIONS OF OFFERORS:**

Proposers must have a current business license from their home based jurisdiction and provide a copy of that license with the submittal of their proposal response.

Proposals from any offeror that is in default on the payment of any taxes, license fees, or other monies due to Rockdale County will not be accepted.

Any contractor submitting a Proposal must complete the Contractor's Qualification Statement and Questionnaire if provided in this package.

In evaluating Proposals, the County may seek additional information from any contractor concerning such contractor's proposal or its qualifications to construct the Project.

#### **PROPRIETARY INFORMATION**

Careful consideration should be given before submitting confidential information to Rockdale County. The Georgia Open Records Act permits public scrutiny of most materials collected as part of this process. Please clearly mark any information that is considered a trade secret, as defined by the Georgia Trade Secrets Act of 1990, O.C.G.A. §10-1-760 et seq., as trade secrets are exempt from disclosure under the Open Records Act. Rockdale County does not guarantee the confidentiality of any information not clearly marked as a trade secret.

#### FINANCIAL STABILITY

The Offeror will provide financial information that would allow proposal evaluators to ascertain the financial stability of the firm.

- If a public company, the Offeror will provide their most recent audited financial report.
- If a private company, the Offeror will provide a copy of their most recent internal financial statement, and/or a letter from their financial institution, on the financial institution's letterhead, stating the Offeror is in good standing with that financial institution.

#### **PERMITS:**

The awarded contractor will be responsible for acquiring any permits that are required for this project/purchase. Rockdale County will waive fees on all permits issued by Rockdale County.

# AWARD OF CONTRACT

The Rockdale County Procurement Office and Evaluation Committee makes a recommendation for award. The Board of Commissioners will make the actual award of the contract and has the authority to award the contract to a company different than the company recommended by the Procurement Office and/or Evaluation Committee.

# **EVALUATION PROCESS:**

The Rockdale County Procurement Office and Evaluation Committee make a recommendation for award. The Board of Commissioners will make the actual award of the contract and has the authority to award the contract to a company different than the company recommended by the Procurement Office and/or Evaluation Committee.

This is a past performance/quality/price trade-off source selection in which competing proposer's past and present performance history and product quality will be evaluated on a basis approximately equal to price. Award will be made to the responsible offeror whose proposal represents the best value after evaluation in accordance with the factors listed below. Rockdale County Board of Commissioners may reject any or all proposals and to waive any technicalities or informalities if such action is in the county's interest.

Rockdale County may evaluate proposals and award a contract without discussions with offerors. Therefore, the offeror's initial proposal should contain the offeror's best terms from a price and technical standpoint. The County reserves the right to conduct discussions if the County later determines them to be necessary.

Proposers will be evaluated based on the following criteria and may be called in for an interview. The County intends to award the contract to the responsible and responsive contractor whose proposal is determined in writing to be the most advantageous to the County taking into consideration all of the evaluation criteria.

Rockdale County will determine whether the final scope of the project to be negotiated will be entirely as described in this Request for Proposal, a portion of the scope, or a revised scope.

This RFP contains multiple projects. Rockdale County reserves the right to award all projects to one vendor or to multiple vendors based off the proposals for each project.

#### BONDS:

Rockdale County shall request the following for bids/proposals in excess of Fifty Thousand Dollars (\$50,000.00).

#### **BID BOND**

Each bid shall include a bid bond in the amount of five percent (5%) of the total bid amount as guarantee that the bidder shall <u>not withdraw</u> the bid for 90 days after the scheduled bid opening. If awarded the contract, Bidders shall enter a written agreement with Rockdale County in accordance with the bid.

#### PERFORMANCE BOND

Upon execution and delivery of the contract, the bidder shall furnish Rockdale County a performance bond for the full amount of the contract. Maintenance provisions of the bond shall remain in effect for a period of twelve (12) months after acceptance of the work by the County. The surety shall be a reputable bonding company authorized to transact business in the State of Georgia.

#### PAYMENT BOND

Upon execution and delivery of the contract, the bidder shall furnish Rockdale County a payment bond for the full amount of the contract. Maintenance provisions of the bond shall remain in effect for a period of twelve (12) months after acceptance of the work by the County. The surety shall be a reputable bonding company authorized to transact business in the State of Georgia.

All sureties of bonds for Rockdale County must be licensed to do business in the State of Georgia and must be listed on the Department of Treasury Federal Register.

#### **ILLEGAL IMMIGRATION REFORM AND ENFORCEMENT ACT OF 2011**

Vendors submitting a Qualification package in response to this RFP must complete the Contractor Affidavit under O.C.G.A. §13-10-91(b)(1) which is provided with the RFP package to verify compliance with the Illegal Immigration Reform and Enforcement Act of 2011.

A. The form must be signed by an authorized officer of the contractor or their authorized agent.

B. The form must be notarized.

C. The contractor will be required to have all subcontractors and sub-subcontractors who are engaged to complete physical performance of services under the final contract executed between the County and the contractor complete the appropriate subcontractor and sub-subcontractor affidavits and return them to the County a minimum of five (5) days prior to any work being accomplished by said subcontractor or sub-subcontractor. Format for this affidavit can be provided to the contractor if necessary.

# **EVALUATION CRITERIA:**

Proposals will be evaluated based on the following criteria and Respondents may be called in for an interview.

Respondents will have their submissions evaluated and scored. Submissions will be evaluated to assess the respondent's ability to provide anticipated services for Rockdale County. Rockdale County shall be the sole judge of the quality and the applicability of all statements of qualifications. Approach, scope, overall quality, local facilities, terms, and other pertinent considerations will be taken into account in determining acceptability.

Evaluation Committee shall evaluate and rank the statements of qualifications based on the following criteria:

- A. Professional Qualifications (15%) Company Experience/Similar Projects
- B. Proposed Work Plan (35%) Proposal must include a separate complete detailed work plan for each project.
- C. Proposal Compliance form (25%) Pages 21-25
- D. Fee Proposal (25%) Proposal must include a separate clearly understandable schedule of charges for each project.

## **INTERVIEWS**

Interviews may be scheduled if required. Interviews will be informal, and will provide respondents with an opportunity to answer any questions the evaluation team may have on a submission.

All insurance shall be provided by an insurer(s) acceptable to the County, and shall provide for thirty (30) days prior notice of cancellation to the County. Upon contract award, Contractor shall deliver to the County a certificate or policy of insurance evidencing Contractor's compliance with this paragraph. Contractor shall abide by all terms and conditions of the insurance and shall do nothing to impair or invalidate the coverage.

Rockdale, GA shall be named as Additional Insured under any General Liability, Business Auto and Umbrella Policies using ISO Additional Insured Endorsement forms CG 2010 or its equivalent. Coverage shall apply as Primary and non-contributory with Waiver of Subrogation in favor of Rockdale County, Georgia.

The insurance carrier must have a minimum rating of A or higher as determined by the rating firm A.M. Best.

Certificates to contain policy number, policy limits and policy expiration date of all policies issued in accordance with this contract.

# STANDARD INSTRUCTIONS:

- 1. The instructions contained herein shall be construed as a part of any bid invitation and/or specifications issued by Rockdale County and must be followed by each bidder.
- 2. The written specifications contained in this bid shall not be changed or superseded except by written addendum from Rockdale County. Failure to comply with the written specifications for this bid may result in disqualification by Rockdale County.
- 3. All goods and materials shall be F.O.B. Destination Conyers, Georgia and no freight or postage charges will be paid by Rockdale County unless such charges are included in the bid price.
- 4. The following **RFP No.** <u>15-27</u> must be written clearly on the outside of each proposal envelope in order to avoid prior opening in error.
- 5. All bids must be received and in-hand at bid due date and time. Each bidder assumes the responsibility for having his/her bid received at the designated time and place of bid due date. Bids received after the stated time and date may be subject to rejection without consideration, regardless of postmark. Rockdale County accepts no responsibility for mail delivery.
- 6. Unless otherwise stated, all bids submitted shall be valid and may not be withdrawn for a period of 120 days from the due date.
- 7. Each bid form submitted must include the name of the business, mailing address, the name, title and signature of the person submitting the bid. When submitting a bid to Rockdale County the first page of your bid package should be the bid form listing the price, delivery date, etc., unless the bid form is requested to be in a separate envelope.
- 8. Rockdale County reserves the right to accept a bid that is not the lowest price if, in the County's judgment, such bid is in the best interest of the County and the public. The County reserves the right to reject any and all bids.
- 9. Telephone, Telegraphic or Facsimile bids will not be accepted.
- 10. No sales tax will be charged on any orders except for contracts that include construction materials being purchased through a third party.

- 1. A new emergency power generator for a complete replacement of the existing emergency power generator and all needed associated items, equipment and labor for the Rockdale County 911 Dispatch Center located at 2120 Farmer Road Conyers, Georgia 30012.
- 2. A new emergency power generator for a complete replacement of the existing emergency power generator and all needed associated items, equipment and labor for the Rockdale County MIS Data Center located at 922 Court Street Conyers GA 30012.
- 3. A new emergency power generator system including all related items, equipment and labor for the Rockdale County Fleet Services located at 2570 Old Covington Highway Conyers, Georgia 30012.
- 4. Remove, Relocate and Reinstall the current generator located at Rockdale County 911 Dispatch Center 2120 Farmer Road to the Rockdale County Fire Station #7 located at 1496 Rockbridge Road Conyers GA, 30012. This will include all needed associated items, equipment and labor for the reinstallation of the generator.

#### SCOPE OF WORK

#### (1) Rockdale 911 Center

The 911 center currently has an existing generator. This RFP is requesting proposals to replace the existing generator unit with a new diesel generator. It is also requesting to inspect all components that are associated with the generator systems and determine any and all items and equipment that need replacement to bring the entire generator system up to **meet all Local, State and National codes and standards for a 911 communication facility**. The generator for the 911 Center shall be a new diesel powered generator with a capacity large enough to supply power to operate the entire facility and support all electrical loads, plus a 10 percent reserve capacity for future expansion, and be able to run for an indefinite period of time without the possibility of an overloading failure.

The proposal shall include any and all needed items and labor so at completion of the project the generator system is fully operational meeting all codes and standards.

#### (2) Rockdale MIS Data Center – Rockdale County Courthouse

The Rockdale MIS Data Center currently has a generator. This RFP is requesting proposals to provide and install a new natural gas powered emergency power backup generator and all associated items, equipment and labor for a complete turnkey installation. This shall include but not limited to the generator, hookup to fuel, electrical wiring, panels, switch gear, and notification equipment, necessary upgrades and additions to the existing building wiring system for the emergency circuits, reinforced concrete pad and required installation items.

The generator for Rockdale MIS Data Center shall be a new natural gas powered generator with a capacity large enough to supply power to operate the data servers, HVAC unit and UPS units. The generator shall have a 10 percent reserve capacity over and above the needed load capacity for future electrical power needs, and be able to run for an indefinite period of time without the possibility of an overloading failure.

The proposal shall include any and all needed items and labor so at completion of the project the generator system is fully operational meeting all codes and standards.

#### (3) Rockdale Fleet Services

The Rockdale Fleet Services building has no emergency backup power at this time. This RFP is requesting proposals to provide and install a new diesel powered emergency power backup generator and all associated items, equipment and labor for a complete turnkey installation. This shall include but not limited to the generator with fuel tank, electrical wiring, panels, switch gear, and notification equipment, necessary upgrades and additions to the existing building wiring system for the emergency circuits, reinforced concrete pad and required installation items.

The generator for Rockdale Fleet Services shall be a new diesel powered generator with a capacity large enough to supply power to operate the Car repair facility, Fleet service offices, one (1) air compressor, garage doors, certain light fixtures and 120 volt outlets in the Truck repair shop. It shall also be able to power the fuel pump island, fuel pumps and all components related, entry gates and canopy lights. The generator shall have a 10 percent reserve capacity over and above the needed load capacity for future electrical power needs, and be able to run for an indefinite period of time without the possibility of an overloading failure.

#### (4) Rockdale County Fire Station #7
