### TERMS AND CONDITIONS OF SALE

- A. Each Motor Grader will be sold in its "as-is" condition and without any warranties.
- B. The terms of sale are in US Dollars and payment must be in cash, check or other form of payment acceptable to Curry County at the date of sale.
- C. The sale shall be subject to compliance with Section 3-54-2, NMSA 2018.
- D. The County retains the right to reject any and all bids that do not conform to all of the requirements of Section 3-54-2, NMSA 2018, and the terms and conditions of sale set forth in this Invitation to Bid.
- E. Successful Bidder(s) shall be responsible for transporting the referenced Motor Graders from their present location and shall be responsible for any and all costs and expenses associated therewith. Successful Bidder(s) must remove Motor Graders within ten (10) business days from the date of the fully executed contract.

### **GENERAL CONDITIONS**

- 1. Bid Forms: All pages included in this Invitation to Bid that are marked "BID FORM" must be completed and returned as part of the bid document. All bids must be completed and securely sealed prior to submitting to the purchasing office. No unsealed, faxed or e-mailed bids are acceptable.
- 2. Bids Binding Ninety (90) days: Unless otherwise specified all formal bids submitted shall be binding for ninety (90) calendar days following bid opening date, unless the Bidder(s), upon request of the County Manager, agrees to an extension.
- 3. Payment Terms: Unless other circumstances are approved in writing by the County, the successful Bidder(s) shall make payment to Curry County within ten (10) days after the date of notice of award by the County. Upon payment, Bidder shall, within 24 hours, remove each of the Motor Graders from the County's property. Bidder shall be solely responsible for any and all costs or expenses of any kind relating to the removal of the Motor Graders. County reserves the right to access a reasonable fee against the Bidder for any additional days that any of the four (4) Motor Graders remains on and has not been removed by the Bidder from County property. All final awards will be approved by the County Commission.
- 4. Equivalency: The County hereby reserves the right to approve as equivalent, or to reject as not being equivalent, any item the Bidder proposes to furnish which contains variations from specification requirements but may comply substantially therewith. Such decisions are strictly at the discretion of the County.
- 5. If there is any clarification, problem, ambiguity or question regarding this bid, you must contact the Purchasing Agent or designee prior to the bid opening. Clarifications and addenda will be considered prior to the bid opening. Answers provided regarding the bid specifications or bid package MUST be answered by the Purchasing Agent or designee. Questions answered by any other person or County official shall be considered completely non-applicable to the legal provisions of this bid, except as specifically authorized by the Purchasing Agent.
- 6. Restrictive Specifications: It is the responsibility of the prospective Bidder to review the entire Invitation to Bid (ITB) packet and to notify the purchasing department if the specifications are formulated in a manner which would unnecessarily restrict competition. Any such protest or question regarding the specifications or bidding procedures must be received in the purchasing department not less than seventy-two (72) hours prior to the time set for bid opening.
- 7. An in-state resident or resident veteran preference will be given to all resident New Mexico businesses that have been issued certification by the State of New Mexico.

To qualify for the preference, the Bidder must list a valid resident business certificate number and shall submit a copy of the certificate with the bid. If you have a question regarding a Resident Business (or Resident Veteran Business) Certification, or wish to be given a number, you may contact the New Mexico State Department of Taxation and Revenue at 505-827-0951. This number is valuable to have as it allows the county to consider your bid at five to ten percent less than the amount submitted, and could mean a difference in award. Please note that this number is NOT your State CRS Number (i.e. 01-503047-004). In addition, any preference numbers issued by the NM State Purchasing Office were valid only through December 31, 2011 and must be re-issued through the Taxation and Revenue Department.

- 9. Non-collusion: Bidder(s), by submitting a signed bid, certify that the accompanying bid or proposal is not the result of, or affected by, any unlawful act of collusion with any other person or company engaged in the same line of business or commerce, or any other fraudulent act punishable under New Mexico or United States law.
- 10. Non-discrimination Statement: Curry County in accordance with the provisions of Title VI of the Civil Rights Act of 1964 (78 Stat. 252, 42 U.S.C. §§ 2000d to 2000d-4) and the Regulations, hereby notifies all Bidder(s) that it will affirmatively ensure that any contract entered into pursuant to this advertisement, disadvantaged business enterprises will be afforded full and fair opportunity to submit bids in response to this invitation and will not be discriminated against on the grounds of race, color, or national origin in consideration for an award. - 11. Insurance: Upon payment, Bidder shall be solely responsible for obtaining any and all insurance on the above described Motor Graders. Curry County shall not be liable, obligated to or responsible for any costs, expenses, damages or claims of any manner, with regards to any of the four (4) described Motor Graders, its conditions, or any damages thereto, after receipt of the payment.
- 12. The State of New Mexico's Procurement Code, Sections 13-1-28 through 13-1-199, NMSA 2018, imposes civil and criminal penalties for its violations. In addition, the New Mexico Criminal Statutes impose felony penalties for illegal bribes, gratuities and kickbacks.
- 13. Curry County reserves the right to reject any bid from a Bidder who previously failed to perform properly, or complete on time, contracts of similar nature, or to reject the bid of a Bidder who is not in a position to perform such a contract satisfactorily. Such is at the discretion of the County.

- 15. If a Bidder to whom a bid is awarded refuses to accept the award or, fails to deliver in accordance with the contract terms and conditions, the County may, in its discretion, suspend the Bidder/Contractor for a period of time from entering into any contracts with Curry County.
- 16. This solicitation is governed by the laws of the State of New Mexico. By signing and submitting a bid, the parties agree that any litigation concerning this bid, request for proposal, limited solicitation, or subsequent contract or purchase order, must be brought in the Ninth Judicial District in and for Curry County, State of New Mexico, and each party shall pay its own costs and attorney fees.
- 17. It is the responsibility of the Bidder to ensure that any addenda issued related to this Invitation to Bid have been received prior to submitting a bid. The County guarantees that any addenda issued will be distributed and available to every party on the Distribution List for this solicitation. The County will not accept responsibility for addenda not being obtained, and will not guarantee that addenda will be forwarded or available if the original packet was not obtained as directed.
- 18. The successful Bidder shall not subcontract any portion of the Price Agreement without the prior written approval of the Procuring Agency. No such subcontracting shall relieve the Bidder from its obligations and liabilities under this Price Agreement, nor shall any subcontracting obligate payment from the Agency.

### BID FORM 2 CAMPAIGN CONTRIBUTION DISCLOSURE FORM

Pursuant to the Procurement Code, Sections 13-1-28, et seq., NMSA 2018 and NMSA 2018, 13-1-191.1, NMSA 2018, any prospective contractor seeking to enter into a contract with any state agency or local public body for professional services, a design and build project delivery system, or the design and installation of measures the primary purpose of which is to conserve natural resources must file this form with that state agency or local public body.
