The City of Shelbyville is requesting proposals for a **USED DAY CAB (ROAD TRACTOR)** that will be used by the Shelbyville Sanitation Department to pull transfer trailer to landfill.

Proposals will be accepted until 2:00 p.m., September 26, 2019 at the Purchasing Department, City Hall, 201 N. Spring Street, Shelbyville, TN 37160. Proposals should be submitted in sealed envelopes marked "**USED DAY CAB (ROAD TRACTOR)**". Any proposals received after the scheduled closing time for receipt of proposals will be returned to the bidder unopened.

Proposals will be opened at public meeting of the council appointed bid committee on Thursday, September 26, 2019 at 2:00 p.m. in the City Hall Conference Room, 201 N. Spring Street. Award of the proposal will be made at the next scheduled City Council meeting at the Shelbyville City Hall Annex. (October 10, 2019)
