This includes approximately **4,600 SY of New Concrete Sidewalk and Handicap Ramps** with all related accessories as shown on the plans and called for in the Contract Documents and Technical Specifications. Bids shall be based on Unit Price Items.

A non-mandatory pre-bid meeting will be held at City of Brunswick Public Works Admin. Office at 525 Lakewood Ave., Brunswick, GA 31520 at 10:00 a.m., Tuesday, July 21, 2020. Prospective bidders are strongly encouraged to attend the pre-bid meeting.

The project shall be Substantially Complete within 180 calendar days from the date of notice to proceed of the contract.

The project will be paid for from federal CDBG Funds. Prevailing wages established under the Davis-Bacon Act will apply to this contract. The contract documents contain requirements addressing prevailing labor wage rates, labor standards, nondiscrimination in hiring practices, goals for minority and female participation, MBE and WBE participation, participation by Section 3 residents and businesses, and related matters.
