The Project consists of furnishing all materials, equipment and labor necessary to install approximately 8,651 LF of 6" water line, 6 fire hydrant assemblies, 126 service connections and all necessary appurtenances.

- This project is funded through State Revolving Fund (SRF). Please pay close attention to the General/Supplemental Conditions and Davis-Bacon sections.
- Certification Regarding Site Visit Prior to Bid.
- Bid Opening is on June 6th 2018 at 2 pm.
- 180 construction days after NTP.

MISCELANEOUS ITEMS

- In order to bid on the project, bid documents must be obtained from the office of AECOM and also attend this mandatory pre-bid conference.
- These pre-bid minutes and any other addendum items will be incorporated into Addendum 1.
- Traffic control is required by SCDOT and is the contractor's responsibility.
- The City will operate the valves.
- Notify the City a minimum of 1-week notice if test shuts need to be performed.
- Notify Engineer if there are any conflicts in the field.

QUESTIONS

1. Can we obtain copies of the Bid Documents in .pdf format? Response: Yes, Engineer will send the Bid Documents (.pdf) to all Plan Holders List via email.

- 2. Can the deadline for questions be extended to next Tuesday, May 22, 2018? **Response:** Yes. An addendum will be sent out to notify all participants.
- 3. Is there any available laydown area near the project site? Response: There is a small area behind the pump station site off of East Bay Street. The exact location will coordinated during the preconstruction meeting.
- 4. There is no detail for vertical separation of the new water line and the existing sewer. *Response: Engineer will provide a detail.*
- 5. Have you considered HDD? Response: Yes. The City does not want the new water line to be deep. Contractor to bid the project per the plans, specs, and addendum.
- 6. Can we install the service lines by horizontal direction drill? Response: The contractor has the option to do this if there enough space. On the City's previous water line project, the contractor used the existing trench to dry bore the new service line.
- 7. Some areas do not have any valves for isolation. Have you considered adding valves? Response: Any additional valves will be field verified during construction and will be paid for per each as stated in the Bid Form.
- 8. Is the contactor expected to retain a certified arborist? *Response: Yes.*
- 9. Is the contractor expected to locate every 1000 LF in advance? *Response: No. However the contract needs to verify all existing utilities in the field.*
- 10. Is the contractor required to swab the entire water line? Response: No. Only those in small length sections should be swabbed. See Note #26 under General Notes on Sheet G1.
- 11. How much compaction testing is needed? Response: *One* (1) per 500 feet should suffice for compaction testing.
- 12. Contractor will be responsible for SWPPP inspections.
- 13. The City will coordinate with the contractor where working in and around tree roots.
