Overview

The City of Canton intends to contract for engineering design services primarily for a proposed streetscape project between Cherry Ave. and Rowland Ave.

Project Description

Project Name: East Tuscarawas St. Improvements GP 1422

- The proposed project will consist of removing and replacing from the curb to the right of way on each side of the street. The existing pavement will remain. The new streetscape will consist of new curbs, sidewalks, brick elements and decorative street lights in accordance with the City's established streetscape standards. Pavement markings may be added/revised to provide for bicycles.

Professional Services Needed

The scope of services may include, but are not limited to:

- Survey
- Plan & profile development
- Cross sections
- Construction details
- General & technical notes/specifications
- Easement development
- Coordination with utilities and other reviewing agencies as needed
- Required ODOT Environmental Documents
- Engineering estimates
- Ohio EPA PTI submittals
- Project Site Plan and/or Storm Water Pollution Prevention Plan development
- Ohio EPA Notice of Intent (NOI)/Stormwater General Construction Permit Submittals
- Other service as necessary

Statement of Qualifications

Qualifications will be ranked based on the following information:

Firm's Background (10 Points)

- Information regarding the firm's history
- Types of services offered by the firm
- Information regarding the firm's available equipment and facilities

Similar Project Experience (25 Points)

- The firm's experience with similar projects, including at least three (3) examples of completed projects of a similar nature and scope

Past Project Performance (10 Points)

- Previous work performed for the City of Canton,
- Past project performance with regard to quality of work, experience with regulatory procedures and policies
- References

Project Team (25 Points)

- Education and experience of owners and key technical personnel who will be assigned this project. Project teams shall identify the proposed project manager, individuals anticipated to perform the work, and other in-house capabilities appropriate for this kind of work. Identification of possible outside sub-consultants shall be included.
- The technical expertise of the firm's current staff
- Current projects underway and availability of staff

Submittal Presentation (5 Points)

- Overall appearance and quality of the submittal.

Deadline and Submission Procedures

The submission must not exceed 20 single-sided (8.5" x 11"), numbered pages that are double-spaced with a 12-point font, including attachments. The cover page will not count towards the total number of pages, but all others will. The submission must also be in PDF format or alternate formats that are easily readable using Microsoft Word. The qualification submission must provide adequate information needed to rank the capability of a firm on each of the preceding categories. The City may short list firms based on any combination of categories noted above. The City reserves the right to require an oral technical presentation to aid in the ranking process.

Deadline and Submission Procedures

Firms interested in being considered for this design work must provide a statement of qualifications by **4:00 P.M. on Thursday, September 21, 2023.** Statements received after this deadline will not be considered.

Electronic copies of your statement of qualifications must be submitted via the City's sourcing tool, Vendor Registry. Vendor Registry is free for your use with City sourcing events (<https://www.cantonohio.gov/448/Purchasing-Procurement>).

Evaluation and Next Steps

Responding firms will be evaluated and ranked pursuant to Ohio Revised Code Sections 153.65-153.73 based on the above criteria. Upon the completion of this evaluation process, the City of Canton will enter into contract negotiations with the firm receiving the highest ranking. At this time the City will commence fee and contract negotiations with the selected firm most qualified to perform the services as needed. The final scope of engineering services will also be established during these negotiations.

The City of Canton reserves the right to reject any and all proposals and to accept the proposal deemed most beneficial to the City of Canton.
