If no Subcontractors are being used, the outside of the envelope must state, "No Subcontractors are being used on this project".

The Owner reserves the right to reject any or all quotes, to waive any informality or irregularity in the quote received and to accept or reject any and all items of any quote. No contractor may modify, withdraw, or cancel a quote within thirty (30) calendar days after the actual date of the opening thereof.
