#### STANDARD SHIRT

This specification is for finished ANSI/ISEA Class 2 high visibility t-shirt. The class 2 t-shirt shall be in compliance with the most current Edition of the MUTCD Part 6E.02 - High-Visibility Safety Apparel and all of the requirements of the Federal Highway Administration 23 CFR, Part 634 – Worker Visibility. The class 2 t-shirt must be manufactured using ANSI/ISEA certified background and retroreflective component materials and meet all of ANSI/ISEA design requirements. T-shirt will be ANSI/ISEA 107-2010 certified, 4.1 oz/yd² flourescent lime and black polyester birdseye knit with lime/black body, lime sleeves, and black collar. Fabric shall be treated with an inherent wicking finish. Shall meet third party certificate of compliance for the background material as required by ANSI/ISEA 107-2010. Reflective stripes shall consist of 2" wide 3M Scotchlite reflective material (5510 segmented home wash trim certified to 75 washes). Small - 6x. CHATTANOOGA PUBLIC WORKS logo printed in 8.5" diameter on back.

#### **POLO SHIRT**

This specification is for finished ANSI/ISEA Class 2 high visibility polo shirt. The class 2 polo shirt shall be in compliance with the most current Edition of the MUTCD Part 6E.02 - High-Visibility Safety Apparel and all of the requirements of the Federal Highway Administration 23 CFR, Part 634 – Worker Visibility. The class 2 polo shirt must be manufactured using ANSI/ISEA certified background and retroreflective component materials and meet all of ANSI/ISEA design requirements. Polo shirt will be ANSI/ISEA 107-2010 certified, 4.1 oz/yd² flourescent lime and black polyester birdseye knit with lime/black body, lime sleeves, and lime/black collar. Fabric shall be treated with an inherent wicking finish. Shall meet third party certificate of compliance for the background material as required by ANSI/ISEA 107-2010. Reflective stripes shall consist of 2" wide 3M Scotchlite reflective material (5510 segmented home wash trim certified to 75 washes). Small - 6x. CHATTANOOGA PUBLIC WORKS logo printed in 8.5" diameter on back.

#### JACKET SYSTEM

The Hi Vis Jacket System will be made up of four pieces: a zippered thermal sweatshirt (hoodie), a zippered sweatshirt with a removable hood, a water resistant bomber style jacket and a waterproof rain parka. The sweatshirts and the water resistant winter bomber style jacket can all zip into the waterproof rain parka.

#### ANSI107 Class 3 jacket/zippered insulated thermal sweatshirt with hood.

Jacket/sweatshirt shall be of appropriate dimensions and have the appropriate features to allow it to both zip and snap into the external shells. Background materials will be made of ANSI107 certified Lime 100% spun polyester microfiber knitted, non-pilling fleece, 300gsm (8.5 oz). Black 100% spun polyester of the same weight and construction shall be sewn into the front chest area below the reflective stripe as well as along the forearm area. The background fabric shall be sewn to a 100% cotton waffle knit liner, 270 gsm (8 oz). The waffle knit liner shall be either gray or black to hide dirt. The collar will have a zip thru zipper which will allow this garment to zip into the other external shells. It will have 2 inch wide 3M 8910 Scotchlite Reflective material sewn onto the fabric and into each of the shoulders and side seams as well as two strips on each sleeve between the elbow and the wrist and the elbow and the shoulder; each are sewn into the arm seams. The tape will be placed on the garment in an approved ANSI 107 pattern. It will have two waist pockets which begin at the zipper and are 9 inches high at the zipper, 8 inches across the ribbing at the bottom of the jacket, a 4 inch side where the hand opening begins, hand opening is 9 inches on a diagonal and 4 inches

across the top back to the zipper. The diagonal will have finished 5/8 inch hemmed edges.A permanently attached hood will be of the same material and color as the jacket/sweatshirt. The identical cotton liner fabric shall extend to the hood to provide insulation. The hood will have an adjustable drawstring with a toggle system to control the tightening.
