# **Questions and Answers**

1. Is there pre-bid meeting for this solicitation?

There is not a pre-bid meeting.

The invitation to bid lists the bid deadline as being at 2:00 P.M. on June 9 and the legal ad lists the deadline as 06/09/2020 at 11:00 PM Eastern. Which is correct?

The deadline is June 09, 2020 at 2:00 P.M.

We want to be sure that Indian River County would like to use a Flat Finish for the exterior coating. Eagle Painting strongly recommends a Satin Finish, to increase longevity of this paint job. We are sure every manufacturer will agree with our recommendation, and we would just like to know your opinion before we bid this project.

We would prefer a satin finish.

4. On pages 13-14, it lists the procedure to pressure clean, patch, seal cracks, and paint. We want to be sure that you do want a sealer to be applied to all of the walls prior to painting, not just to the

cracks, is that correct? We recommend applying a coat of sealer prior to painting for proper adhesion purposes. Again, it is listed on page 13-14 to seal the cracks, we just want to make sure that all walls are sealed prior to painting for proper adhesion.

Yes, we want a sealer on the entire building before applying paint.

- 5. When the bids are opened, will the prices be read out loud as well?
  The total bid price will be read.
- If subcontractors are to be used on this project, must their names be listed in this bid (and have proof of liability insurance with the same limits as the contractor and have a workman's comp policy)?
