

BID DESCRIPTION

Request for Proposals for the Creation of Logo/County Seal for Anderson County Government. Vendors are to submit one (1) original and five (5) copies. Proposals must be submitted in a sealed envelope with the RFP # clearly labeled.

Bidders should note that the Time Clock in the Purchasing runs 5 minutes fast. Proposals must be received by the deadline as recorded by the date stamp on this Time Clock.

Request for Proposals #2204 – Creation of Logo/County Seal Anderson County Government

Scope of Work

Anderson County Government (herein after “The County”) is seeking proposals to for a vendor to work with a County Committee to establish a standard logo/brand design for the County. The RFP also requests pricing for a new County Seal, which may or may not be part of the awarded contract.

In order to fulfill the project goal, the awarded vendor and the Committee shall first convene to establish parameters for the new logo before proceeding with development phase. During this meeting, the vendor shall provide guidance to the Committee on the facets of designing a logo. The Committee shall provide the vendor feedback on what considerations are important in developing the logo and what message the logo should convey about the County.

At a second meeting, the vendor will provide initial logo samples to the Committee. Each sample shall have an accompanying explanation of the design elements to include how the design elements represent the County. The vendor shall explain the pros/cons for reproduction resolution/costs of each design option. Based on feedback from the Committee at this meeting the vendor shall finalize logo options from which the Committee can independently make a final selection.

Once the County makes a final decision on the logo, the vendor shall provide the artwork in a format for digital printed reproduction by County Departments on forms produced in-house and forms produced by outside companies. The vendor shall also provide an instructions document to include such things as size/placement recommendations for the logo depending on the size of the print/digital medium (envelope, legal paper, website etc). Ownership of logo shall become property of the County.

If the County decides to include a re-design of the County Seal in the scope of work then that project will be incorporated into these same processes.

Proposal Requirements

Proposals must be submitted in the format listed in this section. Proposals shall be prepared simply and economically and provide a straightforward, concise description of the Proposer’s capabilities to satisfy the requirements of this RFP The evaluation points assigned to each section are indicated in parentheses.

Tab 1 – Proposed Solution (30 points)

Responses to the RFP shall detail a proposed solution that illustrates understanding of project requirements.

The proposed solution shall describe what information the vendor will provide to the Committee for decision-making purposes. The response shall describe how the vendor will receive and incorporate feedback from the Committee to produce logo artwork samples and final options. The response shall provide a recommended timeline for the events and the number of logo samples and final options the Committee shall receive. The proposed solution shall identify the format type of the final logo and the information that will be included in the instructions recommendation document.

The vendor may also propose alternate approaches that accomplishes the project goal.

Responses must include the proposed vendor team to include names, titles and work history/resumes.

Tab 2 – Vendor History/Experience (20 points)

Proposals must provide the following:

- Number of years vendor has been in operation
- Number of current customers
- Certifications/licensures applicable to the proposed work

Tab 4 – Vendor References (20 points)

Proposals must include at least two (2) references for which similar work have been conducted within the past four (4) years. The County reserves the right to contact the references. Proposals that do not provide references that endorse and demonstrate the vendor’s qualifications will not be considered for further evaluation. The determination of whether a reference support the vendor’s qualifications is in the sole discretion of the County.

The vendor shall also include a catalog of work sample illustrations from successful logo projects. The logo samples identify shall the entity/company and explain the design elements.

Tab 5 – Pricing (30 points)

Vendor shall provide one price for the design of the logo and another cost for the re-design of the County seal. The pricing of the seal re-design shall be based on the same requirements described in the Scope of Work for the logo design.

Vendor Presentations (20 points)

Non-Collusion Affidavit

- This Non-Collusion Affidavit is material to any contract awarded pursuant to this bid.
- This Non-Collusion Affidavit must be executed by the member, officer, or employee of the bidder who makes the final decision on prices and the amount quoted in the bid.
- Bid rigging and other efforts to restrain competition and the making of false sworn statements in connection with the submission of bids are unlawful and may be subject to criminal prosecution. Definitions for Determining Minority, Women And Small-Owned Firms

The guidelines for determining minority, women and small-owned firms are defined as follows:

"MINORITY" means a person who is a citizen or lawful permanent resident of the United States and who is:

- o Black (a person having origins in any of the black racial groups of Africa);
- o Hispanic (a person of Mexican, Puerto Rican, Cuban, Central or South American, or other Spanish culture or origin, regardless of race);

This Agreement is made on this the DD of MM YYYY, between Anderson County, Tennessee, a governmental entity and political subdivision of the State of Tennessee (hereinafter, "County") and XXXXXX (hereinafter, "Contractor") and for good and valuable consideration, the sufficiency of which is hereby acknowledged, the parties agree as follows:

Contractor Services. Contractor agrees to provide XXXXX for the County Per XXXXXXX.

Standard of Performance. Contractor agrees to perform the services in a manner consistent with the standard in the industry and to the satisfaction of the County.

Purchase Order. A Purchase Order must in place before services are rendered.

Contractor Compensation. Contractor shall be paid by County for the Contractor's services within thirty (30) days of invoicing and completion of the contracted services. The compensation to Contractor shall be calculated by: XXXXXX. Contractor **shall not** receive additional compensation for expenses including travel, hotel, food, etc.

Term. The term of this agreement shall begin on MM/DD/YYYY and shall end on MM/DD/YYYY **with renewal option of XXXXXXXX.**

Release. Contractor hereby agrees to release, indemnify, and hold County harmless from and against any and all claims, lawsuits, or the like associated with County's performance of this agreement, or as it relates to the past, present, or future financial condition of the County or the performance of Contractor's services under this Agreement.

Default. In the event of default by the Contractor hereto, the County may bring suit against the Contractor to enforce the terms of this Agreement. In such event, the prevailing party shall be entitled to recover any remedies available at law and/or equity including reasonable attorney's fees and costs associated with the default.

No Oral Modification. No modification, amendment, supplement to or waiver of this Agreement or any of its provisions shall be binding upon the parties hereto unless made in writing and duly signed by all the parties.

Waiver. A failure of any party to exercise any right provided for herein, shall not be deemed to be a waiver of any right hereunder.

Entire Agreement. This Agreement sets forth the entire understanding of the parties as to the subject matter and may not be modified except in a writing executed by all parties.

Severability. In the event any one or more of the provisions of this Agreement is invalid or otherwise unenforceable, the enforceability of the remaining provisions shall be unimpaired.

Cancellation. In the event any party materially breeches, defaults or fails to perform hereunder, this Agreement may be cancelled by the other party with cause on thirty (30) days written notice to the other, if the event constituting the breach, default, or failure is not cured during that time.

Termination: Anderson County reserves the right to terminate this contract in whole or in part with thirty (30) days written notification to the contractor. In the event of termination, the County shall not be liable for any costs other than the cost of services performed and materials delivered and accepted prior to termination date.

Exhibits. Any Exhibits attached hereto or incorporated herein are made a part of this Agreement for all purposes. The expression "this Agreement" means the body of this Agreement and the Exhibits.

Multiple Counterparts: Effectiveness. This Agreement may be executed in multiple counterparts, each of which shall be deemed an original for all purposes and all of which shall be deemed, collectively, one Agreement. This Agreement shall become effective when executed and delivered by all the parties.

Jurisdiction. Each party hereby irrevocably consents to the jurisdiction of all state courts sitting in Tennessee or all federal courts sitting in Knoxville, Tennessee and agrees that venue for any legal action brought in connection with this Agreement shall lie exclusively in such courts.

Binding Effect. This Agreement shall be binding upon and inure to the benefit of the parties and upon their respective successors, heirs, or assigns.

Choice of Law. This Agreement shall be governed and construed in accordance with the laws of the State of Tennessee. The Contractor certifies that in performing this contract they will comply with all applicable provisions of the federal, state, and local laws, regulations, rules, and orders.

Appropriated Funds. The County's obligation to pay under this Contract is contingent upon funds appropriated in the current fiscal year's budget as approved by the County Board of Commissioners. Any contract requiring appropriated funds beyond the current fiscal year may be cancelled without notice in the event that funding to support the contract are unavailable in the subsequent fiscal year.

Payment Terms. The County's payment terms are net 30. All invoices shall be addressed to Anderson County Director of Finance, Room 210, 100 North Main Street, Clinton, TN 37716, and must include Contractor's name, address and phone number, and clearly list quantities, item description and units of measure.

Warranty. The Contractor warrants to the County that all goods and services furnished hereunder shall be free of defects in materials, workmanship, and from defect in design. In addition, Contractor warrants the goods and services are suitable for and will perform in accordance with the purposes for which they were intended.

Insurance Requirement: Vendors awarded bids or contracts are required to maintain, at their expense adequate insurance coverage to protect them from claims arising under the Worker's Compensation Act, any and all claims for bodily injury and property damage to the Vendor and to Anderson County Government while completing delivery and services. A certificate of insurance may be required before work begins and be maintained until work is completed. Certificate Holder Shall Be: Anderson County Government, Clinton, Tennessee. Anderson County Government shall be named as an additional insured on all policies except worker's compensation and auto. Insurance carrier ratings shall have a Best's rating of A-VII or better, or its equivalent. It shall also be an unlawful employment practice for the Contractor (1) to fail or refuse to hire or to discharge any individual or otherwise to discriminate against any individual with respect to their compensation, or the terms, conditions, or privileges of their employment,
